HELENA - Around 100 volunteers gathered at the Montana State Veterans Cemetery Saturday Dec. 15 for Wreaths Across America Day and to honor those that served.

Veterans, families and community members placed 756 wreaths across the hallowed grounds after a service at the Fort William Henry Harrison Chapel.

Saturday's event coincides with events at Arlington National Cemetery and 1,400 additional locations across the United States.

Before laying the first wreath, retired Col. Jen Dalrymple with the United States Air Force thanked everyone present for their support.

"Thank you for helping us lay these wreaths. To remember, honor and teach," said Dalrymple.

Organizers say this year's turnout was fantastic and are glad to see so many people pay homage to our veterans.

"You know this is an opportunity for all of us to show our respect for our service members, our veterans, the families. It's a privilege," said Wreaths Across America Location Coordinator Linda Juvik.

Juvik said the event wouldn't be possible without the generous donors, volunteers and support they've received from the community.



# COMMANDER KLOSE

Happy New Year! There are two things that I'm going to address. First, as usual is membership.

This year National Commander Brett Reistad has introduced an incentive program that rewards both the Posts and the Departments. For every renewal from our expired lists (2014-2015-2016), the Post will receive \$5. If the Department gets to 100 percent by May 8th, it will receive \$2,500. If by the delegate strength date, the Department membership gets to 105 percent, it will receive \$5,000. So you can see that there is an gains in our membership.



As I write this, there are 16 Posts in 8 Districts that have made their membership goal for the year. Membership numbers are important to keep pressure on our Legislature and members in Congress to provide the support needed for our veterans.

Here in Montana we have 124 Posts in 120 communities. These Posts are divided into 11 Districts and 4 Zones that make up Department of Montana. The Posts, Districts and Department operate under their own independent bylaws and charters.

Post Operations, is a good description of what a Post is. The Posts are responsible for electing their own Post officers and recruiting their members.

There are times when a Post, regardless of their membership size or size of their community, fall on hard times, either in membership or getting members to step up to be Post officers. One or two can lead by being commander and adjutant, however it is better if more members help. This can be done by having committees, even if it's a committee of one.

Montana has about 20 Posts that are not being responsible to their members as well as their communities, because they either have one or in most cases have no Post officers. That leaves no one local to run that Post. No one that the local veterans can turn to. The running of these Posts then falls on our Department Adjutant's office. The veterans in these communities deserve better and our Department Adjutant doesn't need the extra responsibility. From time to time one or more of these mentioned Posts either merge with another Post or have their charter pulled. This is something that I personally do not support. Why? Because to me we are telling the veterans in these communities that we are abandoning them and that they are no longer important to us. No matter the size of the Post or community the Post is located in, it's the first place that veterans can go to for help and to close a Post makes it harder for the veterans to get the personalized first-line support that they may need.

Every Post has someone whether they are officers or not, that others consider a leader. It is during challenging times when these individuals need to step up and get the Post back on track. Sometimes there is a personality problem between members but personal egos should be left at the door to do what is right for the Post and the community's Veterans.

In the next few months it will be time to hold Post elections. Now is the time to start looking for those people to lead your Posts. After your elections, don't forget to send the officers names and contact info to the Department.

# Post 42 Townsend~ Celebrates Life of Ralph Morand, WWII Army Air Corps

Townsend Post 42 rendered honors at the Celebration of Life for longtime Townsend businessman and Veteran Ralph Morand on Dec. 22, 2018. Ralph took his final flight on November 30, 2018 just two weeks shy of his 99th birthday. Ralph loved aviation from early childhood and at 21, with the war growing in Europe, he was accepted in the first group of 20 for a civilian pilot training program. The program offered the training for free, if he agreed to volunteer for aviation in the US military if and when needed. It seemed a fair trade for a flying enthusiast. Ralph worked hard and got his private license. Then in November 1942, the government called in their note and Ralph entered the Army Air Corps eventually becoming a P-38 pilot in the 429th Fighter Squadron

stationed in Warmwell, England. There he flew 65 combat missions over France and flew cover over the invasion fleet in the D-Day invasion of Normandy. He spent his final months of duty stationed in France and Belgium once France was liberated.

Following his military service Ralph had many adventures and business ventures that finally landed him in Townsend where he employed many locals in his Chicken farm. Ralph will be remembered by his faithful employees and by all those Townsend folks who moved chickens for him as teens. He will be greatly missed by all those lucky enough to have known him and by his extensive family.

Originally the first page of all the news media outlets stated in essence 'The Department of Veterans Affairs (VA) tells Congressional staffers that they would not repay student Veterans whose GI Bill benefits it underpaid?' The backlash was intense as Senators, Service Organizations and Veterans met with VA Representatives about the above issue. In light of the firestorm, Secretary of the VA Robert Wilkie has since assured the public that each Veteran would be paid their authorized housing benefits for the academic year. Keep in mind, VA rates are computed off the Forever GI Bill, not the Post 9-11 GI Bill. Veterans need to realize that new implemented programs look great on paper, as the program is unveiled, logistical inexactness soon becomes apparent and it takes time to work out the issues. Be patient and continue to monitor your status. Veterans using VA educational benefits for the first time need to save money as it could take a few months for the first VA check to hit your account. Students need to know that any changes to full-time status or transfers to other universities without prior communication could accrue a debt and prolonged waiting for any

monthly financial check to be deposited. Bottom line is to communicate with a VA Education Liaison at your educational institute and prepare to be patient waiting for results.

# Oratorical program: Back to the basics

American Legion Department Oratorical chairmen gathered in Indianapolis Sept. 28-30 for the 20th annual National Combined Americanism Conference. The focus of their program session was "Back to Our Oratorical Basics." The chairmen took a test that challenged their knowledge of the Oratorical program such as the history of the contest, contestant participation, contest rules and procedures, and more.

The questions for the test were gathered from The American Legion's High School Oratorical Scholarship Program, "A Constitutional Speech Contest," Chairman's Guide brochure. Many of the answers to the questions brought forth great discussion and served as a good reminder about the rules of the

"We create new leaders. That's what this contest does," said Tina Burney, discussion moderator and Department of Georgia Oratorical chairwoman. "Citizenship, duty and responsibility is the underlying thing that we're trying to get them to understand."

#### The following are a few highlights from the test answers and discussion:

**Assigned topic card.** During the contest, the assigned topic card (there are four) is to be drawn prior to the last contestant's prepared oration. Conference Chairman David King of the Department of Kentucky advised that about six to seven minutes after the last speaker starts, hand the assigned topic to the first speaker. They have five minutes to prepare.

Contest outcome dispute. Following the contest, if a teacher or parent of one of the contestants disputes the outcome of the contest and demands to see the judges' scorecards, indicate that the scorecards are the property of The American Legion and policy dictates that they are not to be released to the public. The decision of the judges is final.

Contest disruption. If there is a disruption to the contest when a contestant is speaking, like a fire alarm prompting an evacuation, allow the contestant to start over upon return to the competition.

Missed competition. If a contestant cannot compete in the contest at either the post, district or department level for a specified reason, but can compete the following day, conduct the contest as scheduled. And if a contestant competed they cannot do so again. "We had a student who lived on the Georgia-Tennessee line and wanted to compete and did not win (in Georgia) and wanted to go into Tennessee and we said 'No, you've already competed,"" Burney said.

**Number of prepared speeches**. In preparing for the Oratorical Contest, the contestants need to prepare five speeches – one prepared oration and four assigned topic speeches. "It's real important that we tell them that they have to prepare five speeches. It doesn't matter if they have a canned beginning and then fill in the end on the assigned topic. They have to have five," Burney said.

Early graduates. Contestants who have graduated early from high school are eligible to compete as long as they are not enrolled in college, university, trade school or other institution of higher learning.

Placement of judges. Judges should not sit together during a contest. Responses given to this is so they don't collude, look at each other's notes and so the contestants have to look at different people in the audience. And contestants should not be told who the judges are and where they will be seated.

Copies of speeches. Contestants may have a copy of their prepared oration in the first holding room.

"Some people question whether or not we should change some of the structure. We have been doing it this way for 83 years. And we have been doing it well," Burney said. "While National Speech and Debate do it one way, while other organizations do it another way, we do our contest in a way that is now a legacy. It is a legacy of something that we are keeping alive."

# Additional tips shared:

Allowing contestants to have cell phones or smartwatches is not advised. An example given of why is that what if a parent or speech coach sends a text to the contestant on the assigned

# **Changes to Boy Scouts of America**

There are some changes in the Boy Scouts of America organization. First, the name changes to Scouts

BSA in 2019. Second, girls are now welcome in all areas of Scouts BSA. In the past girls could join Venture, Sea Scouts, and Explorer Scouting but were not allowed in the Boy Scout Troops and Cub Scout Packs. As of February 2019 girls will have access to all that scouting can offer. Girls will form their own troops and packs and have the same curriculum as the boys. The Girls will be known as Scouts, not Girl Scouts which is a different organization not associated with Scouts BSA! Third, the LDS Church cut its ties with Scouts BSA as of December 31, 2018. If the Troops and Packs want to continue with Scouts BSA, they will need a new Charter Organization. This need, plus the addition of girl troops and packs, will present a great opportunity for The American Legion to have a bigger impact with scouting.

Also, Eagle Scout Recognition certificates are now available for download by Department and District personnel. The availability of this certificate makes it easier for you to obtain and present the certificate. Simply go to www.legion.org/scouting/certificates and log in or create a Legion.org account to access the forms for the BSA certificate. Once you have entered the requested information, you will be allowed to fill in and download the BSA Certificate of Recognition. Simply print to a colored printer with margins set to narrow.

topic that is pulled, giving them advance notice and preparation.

- While a sound system is not allowed for contestants to use, do let the kids do a voice check so they know how loud to project.
- Timekeeping for the contest is conducted with numbered time cards that are held up on the minute mark. Let them know there isn't a halfminute warning mark as many expect that.
- Encourage contestants to end their speech with "thank you" or some type of closure so the timers know they're finished, rather than just wander off or stand there while the time is running.

# Disaster Emergency Response

#### Is Your Pet Ready for an Emergency?

One thing disasters teach many too late is to prepare to evacuate their pets when they must leave their homes during a disaster or emergency. During the massive California wildfires this fall, in addition to the daily horrific death toll, news stories



of miraculous survival frequently focused on burned or injured pets – including pets that miraculously showed up in burned out neighborhoods weeks after the fire went through.

If you have pets, it is a given that you love them. So, it follows that it makes sense to prepare them for emergencies. As the FEMA Pet Preparedness brochure says, "Get Ready Now." Please don't wait.

- 1. Create a Pet Emergency Supply Kit: food, water medicines, first aid kit for animals, collar with ID tags, harness, leash, crate or other pet carrier and sanitation needs are vital. Dogs use the great outdoors for their bathroom; however, birds, cats, lizards and others do not. Prepare for their sanitation needs. Be sure to have a picture of you and your pet together in case you're separated, so you have proof your pet is your companion not someone else's. Finally, be sure to put some familiar items in your kit bedding and toys help reduce your pet's stress during an evacuation.
- 2. Create a Plan: What will you do in an emergency? How will you go? Create a plan to get away by more than one route. Don't wait for an "official" evacuation notice – often, with the unpredictable nature of disasters, it can arrive too late to get out safely. Leave as soon as possible. Many died in the California wildfires due to traffic jams out of their neighborhoods not allowing them to escape. How will you get your pets together and transport them? This is especially important in the case of large animals such as horses. If you go to a public shelter, your pets will not be allowed in. Consider pre-arranging with family or friends to take you and your pets in during an emergency. Other options include hotels that take pets or a boarding facility for your pets. Find out before the emergency if any of these are viable options for you.

Also, develop a buddy system – plan with neighbors to evacuate yours or their pets if one of you is not home when the emergency occurs. Explain your evacuation plans and designate specific locations, one closer to home and one farther away where you can meet in an emergency.

Additionally, talk to your veterinarian about items to include in your emergency first aid kit. If you pet is microchipped, keep your emergency contact information up to date to improve the chances of being reunited if you get separated.

3. Stay informed: some of the emergency preparation you do for the unexpected, such as assembling an emergency supply kit for yourself and your family and pets is the same regardless of the type of emergency. It's vital to stay informed about what might happen and the types of emergencies likely to affect your area as well as emergency plans established by your local and state government. Go to Ready. gov to learn more.

VETERANS, ARMISTICE RECOGNIZED AT MSU-BILLINGS~COMMUNITY LEADERS GATHER TO CELEBRATE CAMPUS VETERANS CENTER

Chancellor Dan Edelman's vision for Veterans at MSU-Billings University began to take root Sunday, Nov. 11, 2018; Veterans Day.

More than the celebration of the annual holiday, this Veterans Day also marked the opening of a new Military and Veteran Success Center on the MSU-B campus and the special recognition of the University as a Purple Heart University.

The campus has long hosted a Veterans Day bell ringing ceremony heralding the end of the "war to end all wars," at the 11th hour of the 11th day of the 11th month. They have provided support through Veterans Upward Bound, a program to help veterans transition to student life, and other academic and financial aid tools. The Military and Veteran Success Center, which will also be the new home for Veterans Administration Service Officers, will extend those programs and veterans' services to all veterans.

Chancellor Edelman, himself a disabled veteran, has already instituted initial changes to include veterans only and disabled veteran parking areas in front of the Education Building which houses the new Center. The Chancellor said he will also recognize every veteran who graduates and each of those graduates will have a special red, white and blue cord with their cap and gown at commencement.

The celebration began at 10 a.m. in the theater before an audience of several hundred veterans, their families and others who came to recognize veterans. In addition to MSU-Billings ROTC cadets, who presented the colors, the Laurel American Legion Post 123 and the Eugene Sara Detachment of the Marine Corps League presented the service flags at the beginning of this special celebration. Sue Davidson, Chaplain for Laurel's American Legion Post and a member of the Yellowstone National Cemetery board, gave both the opening and closing prayer.

At 11 a.m. on the dot, WWII veteran and former Marine Bill Van Wieren, rang the bell. VFW Post 6774 and the Marine Corps League fired the volley. Taps and echo were performed by MSU Billings student Tyler Honcoop and Retired Air Force Colonel Jack Klein.



# National Executive Committeewoman Update Post-National Convention

I had intended to get this article done before but time got away from me, so I am writing for this issue of the Legionnaire. While at National Convention, since I am the new NEC for the Department of Montana, I attended the Post-Convention NEC meeting. The new National President introduced a gentleman, Steve Peck, that spoke on the plight of the female veteran. The reason she had him speak is because she would like The American Legion Auxiliary to take up this cause. The gentleman gave several statistics, but I only wrote down a few of them.

## The statistics about women veterans are:

If a woman joins the military, when she gets out of the military; she is 6 times more likely to die by suicide than if she never went into the military. She is 12 times more likely to be homeless than if she never went into the military and when she does become homeless, she quite often has her children with her.

Woman veterans do not want to go to the VA for a lot of different reasons. Sometimes they say, "I have not been in combat, therefore I am not a veteran," or "they did not understand my female problems in the military so the VA will not understand them now." Or this one, the worst, "I was sexual harassed in the military and they want me to go to the VA where there are more males to harass me. No way." Any one of these reasons is not good but we as the Auxiliary have been handed this to help the female veterans.

The first step is to always be on the lookout for a female veteran. Talk with her and see if you as a Unit can help her. The next step is to try to get her to join in an activity that you may be doing – take her as far as she is willing to go even to the step of joining the Auxiliary. Sometimes getting them to talk about themselves takes time and that means having patience to see if they may need more help from the ALA. You never know what might happen as they gain more trust from your conversations.

Steve Peck did say he has a website that the organization he is with operates. It has had over 3500 visits with 500 going beyond the homepage. Only 30 of those visits have ended with the female veteran engaging a staff person from his organization. This means we as the ALA must be open to accepting the fact that the veteran may go slowly forward as we earn her trust. Steve states that he hopes that his website will be listed on the ALA Foundation website; however, National stated they are not sure when that will be.

I will be attending the NEC meeting the end of February and I am hoping this topic will again be discussed so I will have more information to share with you.

# The Membership Challenge

Gaining new members and retaining current members are a major challenge for American Legion Posts in small communities. Fergus Post 16 now uses the following procedures and as a result, we have gained substantial growth and retention in our membership.

First, we developed an informational letter that describes The American Legion as the largest and most respected organization of veterans in America. The letter names not only our Post but the Sons of the American Legion Squadron and The American Legion Auxiliary. We list activities and services of the organization as this provides members and potential members with a sense of what we are doing in our local Post and community. A list can include Memorial Day services, flag disposal on Flag Day, Veterans Day events, honor guard and firing party for funerals and other functions, DAV van support, the Highway Fatality Marker program, Boys/Girls State, Legion baseball and/or other projects in which your Post is involved. This letter is also an opportunity to let potential members know about your Post home or club and the services it offers to its members. For example, at Post 16 we have installed a computer that members can use to go online, with assistance if desired, to access VA information and benefits.

Second, potential members can be located in a number of ways through basic legwork and general conversation. Resources to reference include future members have simply not been asked. policies of the Legion and those of other veterans' organizations. Carry a copy of the eligibility rules when working on membership and contact your Department with questions that arise.

Compile membership packets to give to potential members. We suggest including the following items:

- 1. The Post's informational letter/pamphlet
- 2. The American Legion membership application
- 3. The Legion Care Accidental Death Benefit form
- 4. A list of money-saving discounts and programs for members of The American Legion
- 5. A calendar of upcoming events for your Post

As a final note, always keep a membership packet on hand. You may be surprised by who is qualified and interested in becoming a member.

# REMEMBERING OUR LEGACY: Montana's Experience in World War One

# The Famous "Powder River " Regiment pp 75-85.

In September 1917, a large draft of Montana men was sent to Camp Lewis near Tacoma, Wash., before the camp was completed. The first contingent of five percent of the draftees arrived at American Lake, Wash., September 8, 1917. The second and much larger group arrived at Camp Lewis on September 21. Larger consignments followed and they were all soon training, many still in their civilian clothes since there were not enough uniforms to go around. The companies and battalions were soon filled and after nine months of intensive training up to and including regiments and brigades, the division left the camp on its way to Europe and glory.

The 362nd Infantry Regiment, made of mostly Montana men and known as "Powder River Gang," left Camp Lewis on June 23, 1918, on the 7,000-mile trip to the trenches to fight with the American Expeditionary Force in France. The regiment stopped at Camp Merritt, N.Y. where medical examinations were taken, and new equipment issued, then on to Camp Mills, N.Y. The regiment sailed on the USS Princess of Russia for the great adventure on July 6, 1918 and arrived in Liverpool, England, July 17. It went to the Knotty Ash Rest Camp and then to another British rest camp near Southhampton from which point the Montana troops were taken to La Havre, France in transports on July 20, 1918.

The 362nd was entrained at La Havre in crowded 40 and 8 boxcars. The Regiment had its first casualties on its first of several train trips in France when another train plowed into the back of its train,

#### Yes, Your Heat CAN Be Turned Off In The Winter!

Many people think the utility company cannot shut a person off in the winter. However, under certain circumstances that can happen. There are special rules in the winter time though. From November 1 to April 1 a regulated utility may not shut off gas, underground propane, or electric service without prior approval from the Public Service Commission (PSC - the state agency that regulates some utility companies such as NorthWestern Energy, Energy West and Montana-Dakota Utilities). The PSC does not approve winter shutoffs if the customer is unable to pay (as demonstrated by being a recipient of a public assistance program) or if a member of the customer's household is either at least 62 years old or handicapped. Remember, it is the customer's responsibility to inform the utility if one or more of these circumstances exist in the household. Additionally, electric cooperatives and propane vendors are not regulated by the PSC; each one has their own rules so be sure to check with your energy provider on what those are.

killing 22 men and injuring 63. Thus the men of the regiment saw their first blood, wounds and death that would become commonplace in the weeks to come.

For further training in war tactics, the regiment was stationed around Montigny Le Roi, in Haute Marne. Here the men were given intensive training in the use of weapons, marksmanship, gas protection, etc., which would mean a matter of life and death and success in battles to come. On September 10, 1918, the regiment entrained again in the usual uncomfortable boxcars to Houdlaincourt and on September 11, the 3,000 man regiment was sent into the St Mihiel offensive. The regiment was in reserve with the 91st Division, but did come under enemy artillery fire on September 19. The men heard and saw the horrors of war and were indoctrinated for the big battle to come.

The American success at St. Mihiel was complete; but a few casualties occurred while 150 square miles of territory was

captured together with 80,000 prisoners. The entire American losses were 300 dead and 1,200 wounded.

After the St. Mihiel offensive the 362nd Regiment was immediately taken to the Argonne sector in French trucks and were within a short distance of the front lines most of the way. They endured their baptism of fire from German artillery during this period. They took over from the French in the front lines and early on the morning of September 26, 1918, went "over the top" after a tremendous American Artillery bombardment and remained in the battle lines until October 12. They were now fully committed to the grand adventure of wounded and dead. America had entered the greatest offensive of the War.


After an hour and a half of slow advance through the woods and facing the strong German objective to take on the wide American front which was defended by the finest troops the Germans had, the Americans were engaged by German machine-gun fire. The Montana National Guard Army regiment swept through the tough woods and steep ravines disposing of German machine-gun nests and snipers as they went but casualties started to mount. Despite caring for the casualties a large number of prisoners were also rounded up.

On leaving the Chehemin Woods, the German artillery began to splay the area and many Americans and their German prisoners soon became casualties. The regiment continued to advance and casualties mounted but the German infantry in numbers were not present. The Americans only encountered artillery, machine gunners and snipers.

Pushing its way relentlessly, the Montana regiment forged slowly ahead fighting all day crumbling one enemy defense after another, brushing aside machine-gun nests, uncovering snipers, for all of which it paid a considerable toll in dead and wounded. Late afternoon found the regiment facing Epionville across a small valley, over which sang machine-gun fire from nests in the woods ahead. These were attacked and soon the Germans withdrew. Then night arrived.

During the night the Germans came back into Epionville in strength and morning found the same task of forcing them out again. In the action, American artillery fell short among the fighting Americans which hurt morale and caused confusion. Led by its gallant Colonel John Henry "Gatling Gun" Parker, the regiment braved both enemy and American fire and gained the reverse slope before Epionville. Gradually the Germans were pushed out of the town, but they paid heavily at Epionville.

That night the Germans harassed the Americans with heavy artillery fire including gas shells and high explosives. It was also the night the Germans brought their crack reserves, the Prussian Guards, to try to stem the American advance. At seven o'clock the morning of September 28, the 362nd attacked More Powder River pg 14

Although, I am sure there are members who tire of getting solicitations through the mail, this program is the second largest source of revenue for the American Legion of Montana, without these funds it would be next to impossible to do what we do around the state. This program is also a great tool to keep our members addresses current; we probably receive more address changes through the label program than we do through Post Adjutants or individuals. We also receive numerous notices of members who are deceased. Without this program we would have additional mailing costs to those who are deceased or who have moved. When you receive your address labels please send the top portion with your address and member number back to Department, whether you donate or not. If you do not send this portion back and you don't donate, you'll receive a second mailing, so please send it back so we don't have to pay for additional mailings. Additionally, if you do not want to receive certain kinds of mail, notify Department Headquarters (toll free 866-793-1257) and we can stop the mail you don't want.

American Legion Boys State packets will be mailed this month to the Post Chairman that the Department has on file. If your Post does not receive an American Legion Boys State packet it was sent to the high school in your community. The fee for this year remains the same at \$300.00 and the registrations and fees are due by 15 May. Please advise any interested boys to obtain a copy of their parent's or grandparent's discharge so they will have time to compete for the Samsung Scholarship. They must have a copy of the discharge document to submit an application.

and gained the reverse slope on a ridge about two miles from the little town of Gesnes. It was here on September 29, 1918, the 362nd Regiment was to suffer its heaviest losses.

#### THE BLOODY ATTACK ON GESNES

The advance on Gesnes started at 7 o'clock the morning of September 29 and the regiment pushed through the Bois de Cierges Woods. There was heavy artillery fire from the north and the south and two kilometers ahead lay the town of Gesnes. The woods and terrain were greatly favorable to the enemy. Almost every foot of ground was under enemy observation. To advance meant annihilation.

The regiment received the order that the advance must be continued all costs. Supported by artillery and machine-gun fire, the troops of the 362nd Infantry launched a wild charge across the open grounds through the seething inferno. With shouts of "Powder River", they raced forward in thinning numbers like wild men. In an incredibly short time the distance to the town was covered.

Gesnes was taken and the advance pushed to the crest of Hill 285, one kilometer northwest of the town. This was the Army objective and it was reached at 5:30 p.m., September 30, 1918. The 362nd Regiment was the first American unit to gain any American objective in the bloody Argonne offensive. After preparing against possible counterattacks, soon after nightfall the regiment received orders to withdraw to the same line it held before the attack.

No one can describe the feelings of the men when they received the order and realized what it meant: The ground which they had taken at such a terrible cost was to be given up and the blood of their comrades had been shed in vain. Each man felt bitterly that he had participated in a veritable "Charge of the Light Brigade": heroic, but futile.

The withdrawal was accomplished, although some of the outposts did not rejoin the Regiment until the next morning.

As the men fell back in the darkness they gathered up most of the wounded. The night was black and cold and rain that was half sleet fell at fitful intervals. The moaning cries of the wounded seemed to come from everywhere out of the darkness. Here and there a man was found wandering among the dead and wounded like a lost child, rendered so by the terrible shock and horror of the carnage. How unutterably sad and heartrending, how awful is the aftermath of war-swept battlefield- especially if fought in vain! As compared to the number who began the charge, only a handful of men had emerged from the slaughter. Hundreds of dead and wounded were strewn over the battleground with many officers among the fallen. Colonel Parker himself was wounded early in the action and evacuated to the hospital. Lieutenant Colonel J.B. Woolnough succeeded to the command and afterward was promoted to Colonel of the Regiment. The burial party found bodies of over 100 of our men in 200 hundred yards.

Today there stands a humble concrete base in the village of Gesnes bearing a bronze plaque memorial to the 362nd Regiment, which the grateful French citizens erected back in the 1920's. This memorial went through the German occupation in World War II and still stands in the small French village where citizens still observe the bloody battle of Gesnes on

September 29, 1918 in which many Montana men lost their lives.

The Montana 362nd Regiment's casualties were enormous during the wild charge at Gesnes. Companies of nearly 200 men were cut down to a handful. Captains commanded battalions and Lieutenants commanded companies, so great had been the slaughter. One company had 18 men left out of its 179. A few companies had as high as 75 men remaining. Official records show that the 362nd Regiment lost 1,147 men and 57 officers in the attack of Gesnes that afternoon. They also showed the Regiment ranked ahead of any of the regiments in the 91st Division in terms of ground gained and prisoners taken.

# **How to Submit Articles or Photos?** Deadline: April 1, 2019

Preferences:

<u>Text</u> – No formatting such as, multiple space and multiple tabs to line up text

- Set one tab (publisher will format to line up paragraphs and columns) PLEASE do not use multiple spaces as All formatting has to be removed before placing into paper.
- Modern formatting is single-space between sentences (after the period)
- Provide Post City as well as Post/Unit number
- Post, Unit & Department are capitalized
- It is better if articles/stories are written in third person unless you're talking about quotes from actual people, of course. There really should never be any "we did this" or "I/we think that" written in the body of a good news story – imagine someone else is telling your story at all times, as though the journalist is telling the reader about someone or something else.
- Acronyms. Always keep new members informed and familiar with programs. For example: Veterans Affairs Voluntary Service (VAVS). The first time an acronym is used in an article use full title followed with acronym in parenthesis, then following first use, the acronym.
- Please keep articles to approximately 600 words per article.
- If you are using information in your article from another source be sure to use quotation marks and give credit to the author and/or publication you are taking the information from otherwise this is plagiarizing which has serious legal repercussions.
- DO NOT submit articles in PDF format.
- If you want credit for an article or photo(s), please make sure you let us know.

Photos – send as e-mail attachments – PLEASE!!

#### JPG format, as an attachment

- Default setting on a digital camera is usually set very high. Set to 1200 x 1725 pixels which is ideal for printing 4x6 with desired output resolution of 300 dpi.
- Cell phone photos are many times too poor quality so take your time taking the photo. If the photo is blurry, too far away, tops of heads cut off, shows just the backs of heads we cannot make it look better for you. Send photos in medium resolution.
- Captions should be noted in the e-mail:

Photo# caption which includes Post/ Unit #, Name, City along with the names of those in the photo and what Post/Unit they are members of.

- Don't spend time setting up photos and captions in a Word document PLEASE
- Each time a photo is copied/pasted to edit it loses integrity. Send as an e-mail attachment.

Do Not embed (insert) photos in an e-mail (use attach) See above (if embedded in an e-mail the photo has to be copied/pasted into Word, then
