NATIONAL EXECUTIVE COMMITTEEMAN (N.E.C.)

Greetings everyone. This will be my last report as your National Executive Committeeman, as I am looking forward to a little more fishing and family time while remaining active in Post 102. It has been a privilege to serve Montana's Legionnaires. During the last year, I have completed the following activities.

On Feb.5th I went to Great Falls to attend the 4 Chaplains Service. This was the first time for me at this church. The program was very good, the best one in Great Falls that I have attended. On March 6th I went with District 8 commander Andy Rice to the Power post where we celebrated the American Legion Birthday. Then on the 16th we celebrated at my home post 102. The TAL bid was at the Vet's Hall. On March 25th I participated in military honors for one of our WWII veterans. I have also sent names of Legionnaires to attend the Washington conference., working on rounding up people to attend. I was also able to attend a variety of District meetings.

I attended Spring meetings in Indianapolis, the biggest issue that was discussed was the removal of charters from two Departments and the continuing investigations of 3 other Departments. In the 100 plus years of the American Legion there had only been 4 such occurrences until the last 2 years where there have been significant issues with Departments and how business is conducted. Both Colorado and Washington have had their Charters pulled within the last few months because of out-of-control leadership by the Department Commander or the DEC. Both Departments were investigated and found guilty of a hostile work environment created by an un-checked leadership group. Department personnel resigned positions and lawsuits were filed. It is imperative that we ensure that this does not happen in Montana and that we treat each other with respect and dignity, that we work together to accomplish the goals and tasks of what our American Legion is based on: The Four Pillars.

There were 25 resolutions approved by the American Legion National Executive Committee at the 2023 Spring Meetings in May and are available on the <u>Digital Archive</u>. They cover Veterans health care, national security, children, and youth, and more. See the full list <u>here</u>. Probably the most interesting one was Resolution 1: The Purchase of Multiple Years of Membership. It is a 5-year pilot program where a Legionnaire may purchase three consecutive 12-month member terms at the

current dues rate. At the end of the pilot program, it will be decided if the American Legion wants to continue with multiple year membership. I urge you to review the resolutions.

ALTERNATE NATIONAL COMMITTEEMAN (N.E.C.)

Since my report to the Department Fall Conference at Fort Harrison in Helena in October, I have been fairly busy with American Legion activities. In November (10-12), I went to Alberta, Canada as part of the Montana delegation to participate in The Remembrance Day Ceremonies in the Crowsnest Pass area. There were ten members of the Department of Montana that attended (Gary White, David Driver, Jeff Nelson, Jennifer Dalrymple, Linda Cousineau, Jim and Val Grosset, Ray Stolp, and Jan Dobb and myself). The primary ceremonies at the Crowsnest Pass Consolidated High School were well attended with between 450-500 people in the audience. I was the primary speaker from Montana. We then participated in the wreath laying ceremony at the Coleman Legion Cenotaph and again later in the day at Bellevue Legion where over forty wreaths were laid. Later back at Coleman, I was contacted by a reporter from the Crowsnest Pass Herald who, asked if I could get him a copy of my speech, as he wanted to try and get it in the paper along with some pictures of the American participation. I emailed it to him when I got home and they printed the entire thing along with several photos. He also sent me some copies of the paper.

On January 4, I attended the Four Chaplains Service here in Great Falls. It was fairly well attended. I've attended for several years and the attendance varies greatly from one year to another. One change this year was the local high school Air Force Junior ROTC did the color guard portions, whereas in past years it was always the Marine Corp League. It was nice to see some youth involved in the service.

I was unable to attend the Department Oratory on 11 March due to the weather. I did attend six of the eleven District Meetings, and hoped to make more, but missed four while getting ready to attend and travel to and from the National Executive Committee Meeting in Indianapolis. I did attend District 6 (Helena), District 3 (Conrad), District 9 (Denton), District 8 (Power), District 7 (Manhattan) and District 11 (Billings). Attendance overall was quite good especially D-6 and even my District 9 had 8 of 9 posts represented. Some weren't so good especially D-11, in Billings, where only 6 out of 11 posts had anyone there. Billings Post 119, was not represented although they have over 150 members. Also at the time D-11 had five posts that had reached or exceeded 100% yet 3 of the five were not represented! Another first for me was at D-3 where CN20 Calgary attended via zoom with several people on the screen on their end. And Browning Post 127 did have representation which I had never personally seen before. And a big hand and appreciation to all the host posts that did a great job making us welcome and providing a nice lunch/banquet, with support of the Auxiliary or in one case it was provided by the Marine Corps League.

In May (8-12) myself and NEC Hal Rice attended the National Executive Committee Meeting in Indianapolis. While there, in addition to the actual NEC meeting, we represented Montana at the Western Caucus, the LIT dinner, visited the National candidate's hospitality rooms and the National Commanders Banquet. I also had time to look up Kim Shriver who is the Youth Shooting Sports Chairman and sit down in her office and get a lot of my questions answered and get her phone numbers/email addresses to make it easier to contact her.

The American Legion Officer's guide and Manual of Ceremonies contain much information about the history contest. Also, in that section of the *Guide* are "Capsule History of the American legion" and "Helpful Hints for District/County Historians." Please notify your Posts in your District of this readily available material. This information will also be sent out through electronic means via the Montana American Legion website www.mtlegion.org or by mail, as necessary. All entries will be judged and the first-place winners in either category (narrative or yearbook) will be certified, and I will forward them to National Historian for entry in the announced contest for that category. Keep in mind the requirements that must be met for the National Contest. And I refer you to the most current edition of the Officers Guide for the official rules of the 2022-2023 Legion year, or at the legion website www.legion.org.

The 2022-2023 year brought many challenges and quite a few success stories for the Department of Montana. Department finally got moved back into our regular home in the HAFRAC on Fort Harrison after an extensive remodel. We added a small conference room that comes in handy during Fall Conference. The Fall District meetings were a success with the Host Posts doing a magnificent job of meeting everyone's needs and expectations. Department visited Dutton, Big Timber, Cut Bank, Hinsdale, Glendive, Butte, Missoula, Fromberg and Rocky Boy. The Spring Meetings took us to Helena, Conrad, Denton, Power, Manhattan, Billings Lakeside, Corvallis, Baker, Poplar and Chinook. The visit to Lakeside was exciting as Post 426 is the newest Post in Montana, chartered at the onset of 2023. Post 426 has hit the ground running with membership and resolutions and I believe they will impact every Veteran in Montana with some of the ideas they are putting forth by means of resolutions that highlight the VA and treatment alternatives to PTSD and its connection to Veteran suicide. Very exciting.

National Commander Vincent J. Troiola visited Montana in September and it was a highly successful event. The Commander and his Aide arrived in Helena attended a POW/MIA Remembrance Event in Helena the first day; giving a poignant speech about the day and its true meaning. Upon completion of the reading of the names of Montana's remaining POW/MIA brethren; the visit continued with a stop at the State Capital and a visit with Governor Gianforte's Policy Director Glenn Oppel to discuss Montana Veteran specific issues. After a quick trip through the Montana Historical Society and the Nutter/Shore Trophy Room, it was off to the Veterans Hospital at Fort Harrison for a tour of the facility and a quick lunch with Veterans in the VA canteen.

That evening the National Commander was in Three Forks, Montana, where Post 93 and Commander Don Carlson hosted a tailgating event prior to Friday nights Class B football game against Whitehall. With around 35 Legion Caps in attendance the National Commander acted as the Honorary Captain for the game conducting captain introductions and the coin toss. The officiating crew for the game were all Veteran's and Legionnaires. Both the Whitehall and Three Forks fans, school administrators and players thought it was a big deal to have a distinguished guest in attendance; and made the event very memorable. The National Commander had a good laugh when one of the captains asked him as he departed the field if he was a General; I of course responded with a simple "No son, he had bigger dreams than that, he is an Admiral".

Saturday morning found us in Dutton, Montana at the Fall District 8 meeting. The District held a great meeting and the Commander enjoyed meeting the Legionnaires from that area. We had dinner in Craig at Izzac's and the next morning the Commander departed for Kansas. Since the convention, the Commander has been on the road and still had an additional 53 days of travels before he returns to Maine for a well-deserved break. I would like to thank everyone who made the Commanders visit a success. He truly enjoyed the stop.

American Legion Boys State made the move to Fort Harrison with a new Director and a new home. With around 63 Delegates the new curriculum, counselors and staff set out to reinstitute the importance of American Legion sponsorship of the program. Needless to say, the program went off with minimal issue and the Adjutant General of the Montana National Guard at Fort Harrison was so pleased with both the program, what it stands for and the exemplary kids attending it was setting the stage to make Fort Harrison the permanent home of American Legion Boys State.

Probably the biggest issue Department faced this year was with the Donald G. Nutter – Chester Shore Memorial Trophy Hall. The American Legion was asked to take the lead on behalf of all Veteran Organizations during a expansion and remodel of the building. The Montana Historical Society (MHS) is also located in the Montana Veterans and Pioneers Memorial building. There are three floors and a basement in the Memorial Building. The first two floors are occupied by the Montana Historical Society. The top floor is dedicated entirely to Veteran's offices, meeting rooms and the Donald G. Nutter – Chester Shore Memorial Trophy Hall. This floor was

The Historical Society Director informed the Veteran Service Organizations that removal and storage of all military artifacts within the Trophy Hall would need to be at allocated and paid for by the Veteran Service Organizations themselves. The America Legion was tasked with the removal of all artifacts no later than 1 May, 2023 and store them for a three-year period while renovation is completed. These artifacts trace back through American history, beginning with the Spanish American War. The artifacts will require storage in a climate- controlled setting at a cost of around \$10,000 per year.

The sudden decision to require the Veteran Service Organizations to store these artifacts was made in November of 2022 despite the renovation project being started in 2003 and funding for the project being approved during the 2019 legislative session. Unfortunately, a 3-year, \$30,000 project to store a part of Montana's military has not been considered or appropriated in any of the Veteran Service Organizations. The American Legion also had concerns regarding the re-appropriation of the Trophy Hall into a MHS conference room. We found this unacceptable.

Per Montana Code Annotated (22-3-302), (encl 3); "The Veterans' and pioneers' memorial building shall constitute a perpetual memorial to the war Veterans and the pioneers of Montana, and said building shall be devoted to the use of the united Spanish war Veterans of Montana the Veterans of the Foreign Wars of Montana, the American Legion of Montana, the Disabled Veterans of Montana, the World War I veterans of Montana, the Montana historical society, the society of Montana pioneers, and the sons and daughters of Montana pioneers and for the housing of books, records, documents, and other property of such veterans and organizations; and there shall be provided in such building appropriate office quarters for the state headquarters and officers and employees of such Veterans and organizations and for the librarian and other employees of the Montana historical society."

Governor Gianforte was contacted, and Department worked behind the scenes trying to figure out what to do with the artifacts with no funding or assurance we were getting back in there once the remodel was completed. The Governor's Office and our Finance Officer/Legislative Sergeant at Arms, John Joyce, put me in contact with Representative David Bedey from Hamilton. Representative Bedey was able to secure funding for the storage and moving costs, adding it to the MHS budget. Representative Bedey also ensured that the 3rd floor of the MHS will remain as it was intended upon renovation. A Veterans Hall. I cannot stress the gratitude that Montana Veteran's owe Representative Bedey.

Lastly, Department was visited by the Western Region Vice Commander Douglas Uhrig from 8-11 June. Vice Commander Uhrig is from Wyoming and requested that we visit some of the more isolated and smaller Posts in Montana. We visited the Eastern part of the state, with stops at Post 32 in Terry, Post 28 in Glendive, the Eastern Montana Veterans home in Glendive, and Post 12 in Sidney where we were joined by Post 114 Fairview and a final stop in Miles City for a meet and greet with Post 5. The trip was well received, and the Vice Commander had a wonderful time meeting Montana Veterans. I would like to thank Commander Lowell Long, NEC Hal Rice, Past PDC Richard Klose (who's birthday we celebrated during the trip), Zone Commander Ken Simon, District Commander Irene Dickerson, the Posts we visited and Legionnaire Clancee Collins for their contributions to making the visit a rousing success.

PARLIAMENTARIAN

Our organization is in need of continuous training on how to conduct meetings, elections and write resolutions.

I start my report with a purpose that we need to focus on.

Needs Assessment:

Who should be the trainer?

When should we train?

To what level should we train these?

How do we conduct this training?

Notice I did not ask why. We all have all been in meetings, observed elections and talked to our peers with great ideas for our organization. Meetings should be organization with an agenda for a purpose. Respect and decorum must be maintained while engaging all our members. Some of you may disagree with my assumption that all leaders at district and above should be able conduct a meeting with almost no prompting. Presiding officers need to demonstrate confidence and knowledge in basic Robert's rules.

I attended three district meetings in the spring with the intention to only discuss American Legion Boys State. During all three meetings opportunities presented that allowed me to mentor the various presiding officers.

These meetings lead to the potential illumination of a couple of lanes to focus on.

First, is mentorship. This is in no way a new concept for our organization or state. Who are we mentoring and for how long? New district commanders should reach out to previous leaders for guidance and know you are not alone. The lack of operational support for district meeting is another reason for one zone meeting per year to have "experienced" zone commanders show new district commanders how to conduct a meeting. Too many times we have shoved a novice district commanders into the role of a presiding officer with no training. How many of you were trained that way in your initial military training. (see me if you attended Coast Guard initial training - monetary reward)

We need to be mentors. We should not need to write out one but if a structure plan would help, lets build one.

Second was training. No one knows everything but we have some serious talent in our department. These meetings in the spring remaindered me action is needed not just problem admiring. I asked permission to conduct a zoom training on parliamentarian procedures. It was scheduled two weeks prior to convention to provide an opportunity for all leaders to attend to support our commander at convention. We had eight attend. Three members from the DEC. I am not sure if it was of any value.

I am always happy to sharing any knowledge I have. I do challenge every member of the DEC to assess the training needs, develop a plan and gather the resources needed to make our organization better.

I will close with a few recommendations.

- 1) District Commanders require you posts commanders send you agendas for August through October this year. Review it and provide feedback. No agendas is a critical failure of a presiding officer.
- 2) Direct (yes be a leader and direct) 6 to 8 TAL Basic Training subjects for post commanders to cover at the end of 6-8 meetings.
- 3) Have each post draft a resolution to be submitted at your Spring District meeting. There are 100s of ideas on how to improve our organization while focusing on our four pillars.

Let 2024 be a year to of action and let's lead.

FINANCE OFFICER

John Joyce

We have completed another good year with our finances; with all the events happening this year, I feel we have done pretty well with the finances of the Department of Montana American Legion. Overall assets are up around 15.00%. Our account was transferred from DA Davidson to

Stockman Wealth late last year and we have seen steady improvement of our assets as we moved from investing in a small cap/start-up higher risk portfolio to large cap low risk portfolio. Overall, based upon current performance, we should continue to see solid growth even in times of a less than an ideal market. It is recommended that we have Stockman Wealth provide an investment overview to the Finance Committee every year at Fall Conference and that the Finance Committee review the overall health of the investment portfolio every 5 years to include requesting investment briefings from potential new investment firms to ensure that we are staying competitive. This process should have been considered years ago.

We have also completed the move of all the Department accounts to Stockman Bank and Stockman Wealth Management; we can now start to focus on planning for the long term of our reserves. By shifting all accounts to one banking and investment organization, we have also seen a major decrease in banking fees resulting in additional capital. We have a few new members coming on to the Finance Committee and I am looking forward to meeting with them.

I would like to recommend that the Finance Committee relook at some of the budget items. There are a lot of programs the American Legion has done thru the years. Figuring out the budget should be easy and really only having cost of living adjustments plus there are always a few things that "happen" that need to be addressed. For example, The Legion has been doing Boys State for a very long time and should be automatic from year to year. I don't know all the details, but I have heard a lot of consternation about the lack of budget for Boys State. I am going to recommend we put a fixed budget amount for Boys State and will need to work within the Budget. As with many things we need to work smarter not harder.

Each month, when the Adjutant and I go over all the accounts and budgets, the 120-day rule for cashing checks has been helping keep our budget a lot more accurate. Legionnaires have been cashing checks sooner but there are still a few who wait until the 119th day to cash the check. We are working on keeping this process going and looking at adding in the rule of no check will be issues under \$10.00.

In the future, we are going to work on Travel Lines in the budget. In many areas, we are spending program money on travel instead of the program and that is causing a lot of problems with the people who do our accounting review. The accountant is having a hard time explaining to the IRS, how we are spending our money properly. There is a chance we may have to shut down the office to transactions for a couple of weeks so we can address the travel issues, get the rules in place, and the information out to the legionnaires.

As the Finance Officer, I make reconciliations each month with the Adjutant and have found zero discrepancies with the budget. I have also included a copy of the Report of the American Legion from Quick Books for you to look over. Let me know if you have any questions.

I have really enjoyed my time working with Adjutant Duane Cunningham and Office Manager Erin Carpenter as well as all my fellow legionnaires.

JUDGE ADVOCATE

I recently commissioned a painting of my Uncle Jack's B-17 bomber airplane over Abbeville, France on the day, June 22, 1944, that the B-17 was shot down. LEGIONNAIRE ARTICLE

In January I submitted an article to the Montana Legionnaire magazine about charity scams that target veterans. As many of you know, veterans are a preferred target of scammers because we have worked hard all our lives and have assets and savings to show for that hard work. In the article I encouraged The American Legion members to educate themselves and their veteran friends about how these scams work so that we can all protect ourselves from being scammed.

MEMBER ADVOCACY FOR STATE LEGISLATION

During the last session of the Montana legislature, some members advocated for specific bills while identifying themselves as members of The American Legion. Some members were concerned about the confusion that might arise as to whether the Department or The American Legion supported or opposed certain bills that came before the Legislature. In addition, it appeared that some members may have used Department e-mail lists to send e-mail messages to members to advocate for pending legislation. Also, many of us received an e-mail from an outside organization that was advocating for a particular bill, and it was clear that someone provided that organization with a Department e-mail list.

I recommended to Department staff and officers that it might be appropriate to discuss policies and protocols that could be implemented in the future to avoid confusion as to whether the Department or National is supporting or opposing state legislation, and as to whether individual members are speaking on their own behalf, or on behalf of the Department. For example, it may be advisable for members to specify in their written or oral statements about pending legislation that their opinions are not those of the Department or of The American Legion as a whole. In addition, I have recommended that the Department clarify that Post and Department e-mail lists are not to be used by individual members or outside groups for advocating for or against pending legislation, or for any other political purpose, unless sanctioned and approved by the Department. It is very important that Legion members do not provide non-members or outside groups with Department e-mail or address lists without Department approval.

SCAM E-MAILS

I have received dozens of scam e-mails on my Department e-mail address, and I am advised that many of you also receive scam e-mails. Many of the scam e-mails that I receive are disguised to appear to come from past and present Department Commanders. I have alerted Duane and Erin about these scam e-mails and have suggested that we remove Department officers' e-mail addresses from the Department's web page. Duane has suggested that we only list a generic e-mail address and a phone number on the Department's web page, and I agree that this would be an appropriate action to take.

ODDS AND ENDS

In early December and again in February I reviewed a proposed resolution about nominations for Department officers that would be intended to avoid situations where officer candidates delay on announcing their candidacy.

I early January I helped a Post resolve some issues with a bank that would not open a bank account for the Post.

For the second time in a year, on 26 December, the small town of Fishtail was hit with serious flooding due to ice jams. (Ice jams occur when temperatures drastically change.)

Winter Storm Elliott brought record-low temperatures to Montana on 27 December as the once-in-a-generation storm barreled through, causing flights to be canceled and creating dangerous driving conditions, Bozeman broke a <u>daily record low</u> that morning, with temperatures plummeting to -43 degrees, while Helena tied its daily record, at -35 degrees. The temperature in Lincoln also set a <u>daily low</u> at -49 degrees.

The coldest recorded wind chill (how cold it feels outside when considering wind speed) was in the town of Malta where it <u>dropped</u> to -72 degrees on that day.

Things then remained somewhat calm until April 10, 2023, when a combination of rainfall and high temperatures caused snowmelt that led to major flooding along the Milk River and its tributaries in northeast Montana.

Western and south-central Montana also saw between 1-4 inches of rainfall, as well as rapid snowmelt with warm weather in the first two weeks of April.

Meagher, Valley, Hill, Liberty, Blaine, Daniels, and Park Counties, the Fort Belknap Indian Community, the Fort Peck Indian Reservation, and the towns of Glasgow and Nashua enacted emergency or disaster declarations in response to the conditions, with several of them reporting extensive damage to infrastructure.

On 1 May, the residents of Hysham were informed they are not to consume their water after a filter failed on the water processing plant. As of 9 June, they are still waiting on parts and drinking bottled water. They had previously been on a boil order for the water before the filter failure.

On 16 May, Governor Greg Gianforte issued an executive order declaring a statewide disaster in response to flooding in northeast, western, and south-central Montana.

"Runoff from recent rainfall and snowmelt has compromised critical infrastructure and roads in Montana," Gianforte said in a news release. "This order will help impacted communities rebuild and get back on their feet."

On 17 May a weather front coming down from Canada brought thick wildfire smoke with it, prompting the issuance of hazardous and unhealthy air quality alerts across the state.

On 22 May Montana sent wildland firefighters to Alberta to help more than 2000 firefighters from around the world with the more than 100 active wildfires.

On 1 June Musselshell County was hit with major flooding after 5.5" of rain fell in only two hours. Roads were washed out and residents were stranded.

On 2 June County commissioners signed an emergency declaration for a declared emergency for flash flood and flooding events in Musselshell County. Blaine, Daniels, Fergus, Garfield, Hill, Liberty, Meagher, Park, Petroleum, Sheridan, Stillwater, and Valley Counties, in addition to the City of Laurel also signed emergency declarations due to flooding in addition to the Fort Belknap and Fort Peck Reservations.

Also, as of 2 June there have been 394 wildfires so far in 2023 with only 761 acres total burned. There have been no large fires yet this year.

As of 6 June, drought was persisting in 30.2 percent of the state. Go to https://www.drought.gov/states/montana#outlooks to see current and forecasted drought conditions.

As of 9 June Executive Order 2-2023 Flooding Disaster for Flooding and Flash Flooding Events Due to Heavy Rainfall with Hail Coupled with Rapidly Melting Snowpack was signed.

The threat of flooding continues for counties north and east of Billings as thunderstorms with heavy rainfall are expected.

Please be aware of the following weather alerts:

- 1. Flood warning Take Action! A flood warning is issued when the hazardous weather event is imminent or already happening. A flood warning is issued when flooding is imminent or occurring.
- 2. Flood advisory Be Aware. A flood advisory is issued when a specific weather event that is forecast to occur may become a nuisance. A flood advisory is issued when flooding is not expected to be bad enough to issue a warning. However, it may cause significant inconvenience, and if caution is not exercised, it could lead to situations that may threaten life and/or property.
- 3. Flood watch Be Prepared: A flood watch is issued when conditions are favorable for a specific hazardous weather event to occur. A flood watch is issued when conditions are favorable for flooding. It does not mean flooding will occur, but it is possible.

The heavy rains are hastening snow melt in the mountains – please check weather forecasts before venturing into wild places and be prepared for conditions!

Due to the prolonged heavy rains, wildfire season has not yet ramped up in Montana; however, that doesn't mean it won't this summer. All this rain is allowing grasses to flourish. Those grasses will dry and cure to become the fine flashy fuels that wildfire can travel through much faster than any person can run. Please be situationally aware. Please be prepared!

HIGHWAY FATALITY MARKER

I had every intention of making this conference but have family commitments that are keeping me out of state during much of May and all of June. I apologize for this.

This last period of report has been a challenge due to the expanded winter that has spanned the past six months, or so it would appear. The grounds have only recently thawed sufficiently for placement of new markers in many areas.

CORRESPONDENCE

Since my last report, I have reached out to posts across the state and have increased the number of positive contacts to 33 posts. There still remain a number of areas where the posts do not appear to have a representative or a program in place. In particular, I have no feedback from regions 1, 3, and 10. All other regions have at least one active post with a program. I continue to reach out to expand the program to as many posts as possible.

I continue to appreciate the number of posts willing to share resources with me and with other posts. I have received favorable feedback from several posts who keep in contact with me on a fairly regular basis.

Jim Kelly continues to act as a mentor as is ever willing to share his knowledge and insights, as well as suggestions with me. For this I am very grateful.

I have attempted to stay on top of all the calls coming into the Adjutant's office. If possible, I have been able to resolve issues with a single phone call; some issues do take longer, and a couple of issues aren't resolved due to the nature of the call itself. Nonetheless, I feel this issue is being addressed satisfactorily. It also gives me an opportunity to educate the caller on the nature of a "fatality marker" versus a "memorial" and it has been received with some surprise, but greater understanding and appreciation.

Newspaper and other media communications is improving; I have had two articles published in the local county newspaper; one a letter to the editor and the other an interview with the local reporter. Two other posts have sent me articles posted in their local areas, one with photos. I think that I, along with the rest of the program, need more outreach to community media.

Finally, I publish a bi-monthly report of all fatal accidents in Montana to all posts that have acknowledged their existence to me. Unfortunately, some of the data is limited by the data within the incident report. I look up information further in local newspapers, but that is usually limited to my local area. Fortunately, posts will contact me with corrections and updated fatality numbers.

HELP (STILL) WANTED!

Even though my outreach has increased the number of posts that I have access to, I am still tormented by the simple fact that three Areas have no known representation in the program. I urge the members of the Conference to ask all posts to reach out to me with their post number, name of fatality marker representative, a good email address and a good phone number. Many traffic deaths are not being represented with a marker.

OTHER GOALS

- 1. I still need to reach out to various organizations for assistance
- 2. We need more media coverage, but it has improved
- 3. We have a better coordination of resources and willingness to assist other posts. We can improve still.
- 4. Clean up the markers. I have seen a marked, though imperfect, improvement in the status of markers. I often drive through Area 7 when I travel for family visits and am impressed

- by the quality of the markers. I see the same in many parts of the state when I am about and I commend those posts who do such a fantastic job.
- 5. Communicate. We are doing better and my hat goes off to those who have become personal internet or phone friends by their contacts. Keep it up.
- 6. I still need to make a better report in the future, but you can only report what you know.

HOMELESS VETERAN COORDINATOR

Ray Read

The Montana Department's participation in The American Legion's Homeless Veterans Program is now moving into its sixteenth year. Lowell Long, 2022-23 Montana Department Commander, reappointed me as the Coordinator of Homeless Veterans initiative at the 2022 Department Convention. I respectfully submit the following report of the record to date.

Montana Statistics Related to Homeless Veterans is as follows:

Last reported 2022 --Of the 89,275 veterans recognized and recorded by the VA as being in Montana, 70,333 are indicated as wartime veterans. Breakdown by era is Gulf War- 35,651; Vietnam-29815; Korea-5,485; WW II-1,559. Peacetime veterans' number 18,943. The ratio of gender is Female veterans 8,906 and Male veterans 80,367. Comment: It is estimated that based on averaging 2.5 members per veteran's household that the total veterans' population including family members is at 223,190+- or nearly 1/4 of the total population of Montana.

National Statistics indicate that up to 3.8% of Montana's population of veterans is at risk or homeless. The definition of homeless as defined by United States Department of Housing and Urban Development (HUD) is, "Without and abode or home, living with family or relative because they cannot afford or qualify for a home residence, or living in an institutional setting because they cannot qualify or are financially unable to rent or own a home."

In the latest Montana Homeless Survey conducted in January 2022 of the total Homeless population in Montana was surveyed at 1,545 Total Household experiencing homelessness is 167 person respondents of which 165 Veterans were identified as to the as to being homeless. This indicates that homelessness among Montana veterans was up 10.7% of the total homeless of Montana based on the Survey similar to the results from the previous year, this includes incomplete information on rural veterans' homelessness. The 2023 PIT is being processed at will be available later this year.

The following information was provided for the January 2022 Point in Time Survey by Housing & Urban Development conducted in January 2022. These reflect the collection effort based in cities and towns broken into Districts by Housing and Urban Development (HUD). These districts do not emulate Montana Department /American Legion Districts as currently configured. HUD District 1,2,3-Eastern Montana; District 4- Havre; District 5- Great Falls; District 6- Lewistown; District 7-Billings; District 8- Helena; District 9- Bozeman; District 10- Kalispell; District 11- Missoula; and District 12-Butte. **Survey areas did not totally encompass Montana rural areas**. The thing to take away from this is that Homelessness is present and is a growing problem that we all must address at Post/Community level and above:

Recommendations for 2022-2023:

- 1. That the Montana Department of the American Legion continue to develop and conduct its Homeless Veterans strategy in coordination with the National Economics Division of The American Legion, the Veterans Administration of Montana, Federal Housing and Urban Development, the Montana Department of Health and Human Services and the many local service organizations who dedicate resources to reduce and eliminate homelessness in Montana.
- 2. That the Department of Montana of the American Legion strive to establish volunteer homeless Veteran's coordinators at Post, District and, Zone levels as necessary to interface with the Department on issues and offer solutions of Veterans homelessness. In lieu of dedicated resources the responsibility falls to the post, district, and zone commander by default.
- 3. That the Department of Montana of the American Legion supports the various Homeless Veterans Stand downs scheduled throughout Montana 2022-2023. Several have been conducted according to the VA in Great Fall and other locations starting in Early October. One and two day stand downs are classified as a veterans' resource programs rather than a full stand down. Veteran related events previously identified as being in Plains, Helena, Missoula, Dillon, Miles City, and Libby, and on the High line of Montana with Havre, Montana as the hub. If you hear of such events please notify the Homeless Veterans Coordinator to have them recorded in the Annual Report.
- 4. That those American Legion Posts conducting a Stand down coordinate and apply utilizing VA Stand Down Notice of Proposed Event Form available online and complete the VA Stand Down After Action Report available online at the National Coalition for Homeless Veterans. Email kmcevilly@nchv.org the website is www.nchv.org. Telephone number is 202-546-1969.

In the last 12 months we have received two disbursements totaling \$8686.95 in premiums paid to the Department of Montana for Long Term Care, HIP, AUX HIP and Cancer, Cancer Disability, AD & D and Life Insurance. The promotional bonus is based on membership; to increase the bonus we obviously need to increase membership.

The LIT offers 13 different insurance products, but our most popular products are the cancer and EA+ insurance. There is a myriad of promotional information available for the Post to use, please contact me if you require any information. Our job is not to be insurance salesmen, but to inform our members of the insurance benefits. Please remind your members of the Accidental Death benefit periodically so they can take advantage of this program and remind them they must register.

The information LIT gathers from these sign ups is the number one source of policies written. Signing up for the free AD is our best way of ensuring the LIT markets to the right age group. Remember when you transfer a member from DMS to provide them with the information on the free AD, they do not receive the info from National. If a member is in doubt about being registered, they can call LIT or go online at www.theLIT.com/LegionCare2 to check their status, every year we have family members of deceased members attempt to file a claim only to find their loved was not registered. Once a member registers, they are now registered for as long as they are members.

We have got to ensure our members are registered for this benefit, especially our new members, and <u>remember any member acquired through DMS has never been given a registration opportunity for the free AD.</u> Senior (18 or older)Auxiliary and senior Sons of the American Legion members can sign up for the free AD & D under the same conditions.

Every Legion member is Montana should register for the benefit. The LIT offers both free and cost based products and recognizes that they must continue to offer good reasonably priced products.

In 2020 the LIT instituted a new incentive program for those Departments with innovative membership programs; the best three will receive \$12,500, \$7500.00, and \$5000.00 respectively.

Since 1967, when our Department joined with the Legionnaire Insurance Trust the Department has received over \$725,000.00.

Registration for LIT has never been easier! I will assist Legionnaires with registration at Convention and in my travels to District meetings.

The Department no longer receives insurance revenue from USAA, however we do receive a disbursement from USAA based on membership.

LEGISLATIVE

Roger Hagan

Your Legislative Committee has been extremely busy since I last reported to you at our Fall Conference in October of last year. The major focus of the past several months understandably was the 68th Legislative Session of our state government. I believe this session involved more 'Caps in the Capitol' than ever before. My thanks to all who took the time to come to the Capitol to testify in hearings, went on-line to make their voices heard, and dialed in to the hearings via Zoom to have their say. Your work has paid big dividends!

And during that session your department was also represented at the Washington Conference in February. Vice Commander Scott Miller, Department Service Officer Candice Hering, Legion Auxiliary Legislative Chair Christine Nelson, and I were honored to attend the Conference. Over the several days in D.C. we received training in our respective positions, and all were briefed on legislative issues that we were to discuss when visiting our congressional members. We were fortunate to have visits with all four of our members; Senator Tester, Senator Daines, Representative Zinke, and Representative Rosendale. I can assure you, the presence of the Montana Department of the American Legion on The Hill was noted.

The Montana State Legislative Session of 2023 came to an abrupt close on Tuesday, May 2nd, following an unexpected early motion to 'sine die' (adjourn) made in the Senate. While your Department experienced one of the most productive and beneficial lawmaking sessions that I have seen in my many years of representing you, the early adjournment did leave us with a few loose ends and unanswered questions.

Entering the legislative session, we had several priorities. We worked in unison with the Montana Veteran's Affairs Division (MVAD), making it one of the best sessions ever. Additionally, over the course of the session, several legislators brought forth other bills that were of importance to our membership. All told, we discussed or testified for or against 48 bills and monitored an additional 100+ bills or bill draft requests. We worked closely with the Montana National Guard Officer and Enlisted Associations, and various other groups, on many legislative pieces, recognizing the common benefit for both the American Legion members and all veterans of Montana.

By far the most significant legislation that we were successful in passing was a state income tax exemption of military retirement. While HB 219, one of the two income tax exemption bills, was tabled in the House, SB 104 made it to the Governor's desk. This bill was signed by Governor Gianforte on May 16th.

Our organizations have been working on the tax exemption effort since 2008 and we were finally able to convince our legislators of the economic and workforce value of encouraging military retirees to relocate to or remain in Montana after they retire. While the legislation only provides an exemption for up to 50% of military retirement, based upon the retiree's Montana Wage Source Income, it certainly is a great step forward. This bill had 4 committee hearings, 18 votes, was left for dead once, revived thanks to a good effort by a legislator, and in total was moved from the Senate to the House and back to the Senate for votes over the period of 4+ months.

While the passage of SB 104 was the most long sought after legislation of our efforts, our Department promoted several other bills successfully. HB 264, that established a decennial (every 10 years following the U.S. Census) requirement for the Department of Public Health and Human Services (DPHHS) to conduct a Veteran Long Term Health Care and Veteran Cemetery Needs Study. The last time this study was done was in 2006 and it became very beneficial when validating a need for a 3rd Veterans Home.

The American Legion was the lead on this effort starting during the 2021-2022 Interim. We can be proud to claim our ownership of this successful effort. Of course, this is just the beginning of the effort. In order to have a meaningful study, it will include a survey of Montana Veterans. That is where you come in. As soon as the DPHHS has formulated the procedures for conducting that survey, <u>each and every post</u>, <u>district</u>, <u>and zone must step up</u> and insure that as many veterans (regardless of their membership in our Legion) are given the opportunity to submit their survey. More information on that will be available at this Convention.

Other successful efforts by your Department include an increase from \$4 million to \$5 million the minimum amount annually set aside from the cigarette tax for operation and maintenance of the three veterans' homes, \$5+ million for the SW Montana Veteran's Home cottage connectors, \$6 million for Cottage 6 at the SW Montana Veterans Home (UPDATE: recently line-item vetoed by Governor Gianforte). These allocations and appropriations are, by far, the most we have ever seen other than the original construction of the SW Montana Veterans Home. Additionally, we secured approval to pursue a fourth Veterans Cemetery, planned to be located in Columbia Falls.

Our Department also opposed a couple of bills that we considered to be detractors from our veteran and military members. We opposed and defeated HB 527 and SB 560. Both of these efforts were named the <u>Defend the Guard Act</u>. Had either of these bills passed, the law would have prevented our Governor from allowing Montana National Guard members to deploy for overseas contingent operations unless there was a formal declaration of war by Congress. While the intent of forcing Congress to do their constitutional duty of declaring war was genuine, keeping the Montana National Guard home would not accomplish this effort. The 'Defend the Guard' effort was promoted by a national organization in over 31 states, and we fully expect the bill to come back in two years.

Additionally, we opposed a bill that would have mandated the Board of Veteran's Affairs members to hold town hall meetings each year across the state. While this sounds like a good way to reach out to our veterans, the Veteran Service Officers of the MVAD are already doing outreach and the Board members would not have the tools to resolve any issues brought up at those town hall meetings.

Again, my thanks to all American Legion members who responded to our "Legislative Alerts", your involvement in the process is very important and has been valuable. In the past we have been in the top 5 so it would be great if we could achieve that level of membership again. Our state is under some extreme transformations with population growth, and we have an ageing veterans' group so we need to get everybody to come to the table with all the ideas.

National American Legion has a conference in Indianapolis every year the help train and update the department on membership. We need to continue to train and mentor our members about membership and the process of growing it while continuing to maintain current members as well.

We do a lot of work recruiting members but then we seem to forget about them or never follow through on our promises and we need to remember that without our members we have no Legion. Hold our Organization Values up and insure you have a good character as a legionnaire when representing us all.

NATIONAL SECURITY Ken Simon

National Security in the past year has suffered some really serious setbacks over a cross section of articles related to certain areas of our government. It ranges from the ongoing fiasco at the Southern Border to a Leak of Secret documents that may or may not have contained relevant, pertinent, and true information. The Southern Border folly has only gotten worse as a result of the lackadaisical attitude shown by the administration towards keeping our country secure and free from unchecked aliens from entering. Then add to this the appearance of nonchalant attitudes about the nation's budget/debt ceiling mess.

Let's first look at the Southern Border and the continued influx of illegal and unchecked aliens from several countries. One thing that occurred was the naming of someone who was born outside the U.S. and immigrated here as a child with his parents. That was Alejandro Mayorkas who was an American lawyer and politician who had served during the Obama administration from 2009 to 2016. He was named as the Secretary of the Department of Homeland Security, however Mayorkas was not new to the government or the Department of Justice and the Department of Homeland Security as a result of his being the director of the U.S. Citizenship and Immigration Service (USCIS) under President Obama for eight years. He had a working knowledge with how the system worked and was more sympathetic in regards to how Illegal Immigrants should be treated.

What has occurred under the Biden administration is that because of COVID, President Trump had announced an emergency order and related Regulation based on Title 42 of the Public Health Service Act. That order and regulation gave the director of the Centers for Disease Control and Prevention (CD) the authority to prohibit entry of anyone the director believed posed a "serious threat of the introduction of a communicable disease into the United States." When Biden was elected, he attempted to remove the ban on immigration by signing an Executive Order that lifted immigrant visa ban in February 2021. That allowed illegal immigrants to reunite with family in the US who were citizens. Due to this attempt, President Bidens order did not remove the ban to those non-immigrant work visas for exchange visitors and temporary worker visas.

In conjunction with this, Senate Democrats proposed a new \$3.5 trillion budget that spelled out a dramatic increase in the number of available green cards and also included amnesty for illegal immigrants. It not only provided this, but also a pathway to citizenship to just under 1.1 million

annually! By preventing those who have applied legally to enter and work in the past, this reckless unfounded move will deprive the US of those people who are trained and or experienced in trades they have previously worked in here before. It will also take jobs away from US citizens who work the many jobs that do not require a degree or specialized training and hereby prevent them from earning a living wage. Does our government then plan to put them on Welfare, Unemployment, or the so-called favored SNAP plan? Who pays for their insurance or medical needs if jobs are given to illegal immigrants from countries that in many cases are anti US? My experience says that if they do not enter the US legally then they should NOT be allowed into the United States. And when they do, they should be required to learn English and assimilate into our country to become productive and loyal citizens not a drag on our economy or become a ward of the state! Let's take care of our own people before we cave in and allow illegal immigrants to move in and be provided with homes, jobs, and everything else Free! Spending some of that \$3.5 trillion on our own people will be better spent and bring our own people's standard of living up.

The next idea that came up was brought forth by a Democratic Congresswoman from Washington who teamed up with a Democratic Congressman and re-introduce a bill to "decriminalize crossing the US Border illegally!" Her reasoning was to deliver on a real, humane reform of the immigration system and fix the American racist, xenophobic immigration system that has been broken for decades! Under federal law it would prohibit police from apprehending illegal immigrants and mandatory deportation of those who have committed certain crimes in the US would be abolished. Further it would require immigration judges to impose the least restrictive detention conditions necessary! So, open the border up and just allow illegal immigrants to pour in because the former President had instituted a hateful policy against all illegal immigrants!

Another problem with the porous Southern border is it opens the possibility for terrorists to enter our country unimpeded and free to go wherever they please. That is a dangerous situation that unfortunately may already have occurred based on the fact that there have already been some illegal aliens of unknown country of origin who have been caught by the Border Patrol. Some of these individuals have been caught wearing ghillie suits which are camouflage wear that are used to make the individual harder to spot in the open terrain! Anyone not entering our country through a controlled Border Crossing where they can be vetted, have an ulterior motive for entering. Criminals or terrorists do not want to cross at a controlled Border Crossing for fear of being caught and returned to the country they are departing. Regardless of the reason that elected officials believe that our Customs and Border Protection officers have for enforcing the Immigration Law, it is being done to protect our country from being overrun with undesirable people. Why did I bring this up? Because the Biden administration made a decision to change federal law giving terrorists easier access to the United States. The rule change was allegedly changed to make it easier for Afghan Special Immigration visa holders to make entry as a result of their support given to the US forces. However, the wording was so vague that it would allow terrorists from Afghanistan and Iran to enter without being properly vetted. This would then be a National Security problem if these countries sent trained terrorists to South America and directed them to proceed to the Southern Border to cross undetected into the US.

The other problem is the sending plane and bus loads of immigrants to large cities around the United States in the dark of night. Who are these people, where did they come from, and were they properly vetted before being shuffled all across the country? Why is it that the government contractors provided to accompany these illegal immigrants across the country are told to ensure

there is no press, no interviews, and no pictures allowed. What is our own government and moreover the Department of Homeland Security hiding or withholding from the citizens of this country? Illegal encounters at the southern border numbers in the millions and we have no idea who these people are or possibly even where they ended up! Are there other entities involved and if so, why? Who really is in control of the influx of the illegal immigrants and how can the citizens of this country continue to allow or even to put up with the idea of no enforcement of the Immigration Law!

Wondering about the above I googled: Reports of illegal immigration being funded by World organizations. I found several references but one in particular which I will provide here for you the reader to check out and inform yourself and others. It is: United Nations Grantees Use U.S. Tax Dollars to FUND ILLEGAL IMMIGRATION! Monthly cash for food, lodging, and movement assistance amounts to material support for illegal immigration. It influences decisions to cross the border. Here is another from Amnesty International that I found that might interest you:

Laws for Migrants, Refugees and Asylum seekers!

The rights of migrants, refugees and asylum seekers are protected by international law, regardless of how and why they arrive in a country. They have the same rights as everyone else, plus special or specific protections including:

The <u>Universal Declaration of Human Rights</u> (Article 14), which states that everyone has the right to seek and enjoy asylum from persecution in other countries

The 1951 <u>UN Refugee Convention</u> (and its 1967 Protocol), which protects refugees from being returned to countries where they risk being persecuted

The <u>1990 Migrant Workers Convention</u>, which protects migrants and their families Regional Refugee law instruments (including 1969 OAU Convention, 1984 Cartagena Declaration, Common European Asylum System and Dublin Regulation)

Another interesting find was this one:

Nonprofits and NGOs assisting migrants who cross the border: humanitarian support or abetting a crime?

'I have been watching the United Nations, UNHCR distribute cash debit cards to migrants.'

The United Nations is assisting illegal immigrants to get to and or cross the southern border of the United States! No wonder we have so many illegals attempting to or making illegal entry into the United States.

Inform yourself on this issue if for nothing else than the Security or our nation!

The last item I will discuss in my National Security Report is that of several documents that were posted on line containing Secret or Top-Secret information recently. In March or April several documents detailing classified war documents were leaked on social media. The majority of the plans were regarding the U.S. assistance to Ukraine in its war with Russia. Information regarding the use of military weapons and munitions as well as how intelligence was being gathered and disseminated to the Ukrainian military was part of the information. Some of the information released mentioned the scope of the intelligence gathering and it was done on both allies and adversaries. Many of the documents were prepared over the winter for the Chairman of the Joints

Chiefs and other senior military officials. According to the report this information was available to other US personnel and contract employee who had the proper clearance to access it. Not all of the documents were allowed to be shared with our allies and was so marked and was not supposed to be put out in the open. This leak was not isolated to just one of our Intelligence agencies tasked with gathering intelligence, rather five of our agencies. A leak of this nature gives cause for concern into whether it was done by someone in one of the several agencies responsible to gather, analyze, and decide how it should be shared across the spectrum of those countries involved in any one situation or conflict. The documents demonstrated how the U.S. intelligence community had been able to garner intelligence on Russia and how that had been done. The leaks regarding the Ukrainian military caused concern for the Ukrainian President and his military commanders as well. After the information had been located and assessed it was determined that much of it was outdated intelligence and or had been altered so as to be only minimally valuable to any country who was able to access and read it. As a result of the leak a statement was issued by the Air Force that the intelligence unit responsible for the leak had been ordered to stand down. And on April 18th, 2023 the FBI made an arrest on an individual identified as Jack Teixeira who was serving with an intelligence unit of the Massachusetts Air National Guard. He was charged with two counts of retaining and distributing classified and national defense information online in recent months.

Defense Secretary Lloyd Austin ordered a comprehensive analysis of security protocols as a result of the large leak of classified information. What harm has this leak of intelligence data and how will it affect the co-operation between the U.S. and its Allies in the coming months and or years? Will the intelligence community as a whole lose the ability in some cases to conduct intelligence gathering worldwide without suffering the loss of people who were providing it? Can we convince our allies that this was a careless breach of security by someone who was doing it to show off to some of his friends on line and will likely not occur again in the near future? The old saying that goes: "Loose lips sink ships" could never be true than what occurred with this incident. People who are given the trust to handle our nations secrets should be vetted carefully so this never happens again and it should also be stressed that this could be considered treason. The matter has been referred to the Justice Department do a formal criminal probe.

Lastly, the budget and debt ceiling of the United States and what affect it could have on our National Security. Part of the problem is the tax and spend rut our elected officials have been in for so long that they have dug a pretty deep hole for us to this point. Our government cannot continue to spend more than it takes in and continue to raise the debt ceiling so they do not default on what is owed. One of the ways they mentioned was to print more money but that is not the answer because then we would end up with run-away inflation. The people negotiators would be to be more reasonable with a mixture of spending cuts and tax increases. Cutting Social Security and Medicare was brought up however those are not popular because of the support it gives those who have worked and count on that money when they retired. It also provides support for those who cannot work due to a medical condition or disability. There has been talk of cutting defense spending but that only accounts for 15 per cent of the budget and is used in various aspects of our nation's economy. To be sure, it also ensures our Nations military is properly equipped and provided the tools to do the job as well as medical care when it's needed. Provided in the bill before the House is continued Health Care Coverage for Veterans and the PACT Act and that Veterans health care would be fully funded. We can't just keep throwing money at countries who really do not support us or to a cause that really has no value to the United States. By continuing to raise the Nations Debt we are just digging a bigger hole than if our elected officials would sit down and honestly do the job they are sent to do. Quit spending the publics money like you're a drunken idiot and begin to run the government like a business where what's brought in is enough to pay for what needs to be done! If we as a business which we are spent our veteran's money the way our government spends the tax-payers money, we would not last very long. There comes a time when we have to take a long hard look at what we can afford to do with the cost of doing business. The price of everything has gone up and so it just makes sense to ask ourselves as a nation and or a business if we can Continue the Way It's Always Been! We as a Nation have to live within the budget that will cover what needs to be done at home with the money taken in from the citizens. If we default on our debt, the bank, countries, or places that loan us money or support our loan will either reduce the rating used when money is loaned or we as a Nation Default. Then what happens? The U.S. debt ceiling and what happens if it is not raised according to the reports, could cause major issues world wide because the dollar is used as the mainstay. Biden and House Republicans have agreed in principle to address the debt limit and cap spending. So now it is up to the House and Senate to pass the bill.

What I have covered in this National Security report does not minimize what I have written about in my past reports. Some of the things that were relevant in the last three are still relevant today. North Korea, Iran, the Taliban, Russia, and Cuba and other countries like them are still not our allies and would do anything to do us harm. Damage could still happen to our infrastructure with a storm here on earth or in space. Crime in our country is not just something that happens in the large cities or municipalities, but anywhere at anytime due to the ability of people to travel great distances. Drugs are becoming more prevalent and continue to plague our country with the abuse of several types by people of any gender, race, or color! Remember that National Security is everyone's job. If you see something, say something. While it may not seem important to you, the smallest thing can turn out to be a much larger issue once it is analyzed. If we are aware of our surroundings, we will keep not only ourselves Safe but those around us.

The Detachment of Montana met last fall and addressed some outstanding issues that could not be resolved at the 2022 Detachment convention meeting. The items that were not resolved was recognizing the Belgrade Squadron No 30 (small) and Glasgow Squadron No 41 (medium) with a plaque. All plaques with American Legion Emblem sales were on back order. We still recognized those Squadrons and will work on getting a better resource to obtain plaques in the future.

The Detachment was again briefed about the lack of submissions for the three individual awards for the year: Top Recruiter, SQL American Legion Family Recruiter.

American Legion Boys State Chair, Josh Clement provided another brief update to the Detachment of Montana about the program and asked for continued support of the program.

As NEC, I reported to the Detachment of Montana body that elections held in 2022 had an error. The NEC and Alt NEC were elected in 2021 and then elected again in 2022. The problem is that the Bylaws specifically state that NEC and Alt NEC are to hold the position for two years. By vote, it was affirmed to consider the election in 2022 for NEC and Alt NEC to be starting their first year at that election, therefore, the next election which will include NEC and Alt NEC will be in 2024 Convention.

Current Detachment Membership as reported by National, as of the 100% Target date of May 17, 2023 is 93.50%. We are 6% better than we were last year. However, Department of Montana fell short of 100% by 72 as of May 18th. It is STILL Possible to make 100%. The 105% goal is still reachable by July 26th, 2023. This has been communicated with the SAL Leadership team.

The Detachment of Montana is in a great position for 2023-2024 Membership year and I have full expectations that they will continue to support not only the Department of Montana, but their respective Posts and Post Auxiliaries as well

Since my last report, Department has received the results of the 2022-2023 competition. And like the 2021-2022 competition the almost unbelievable has repeated itself. For the second year in a row, the Gallatin Valley Sharpshooters (Manhattan Post 87) swept the entire 33rd Annual Competition. They were Montana Team Champions in both the "Sporter" and "Precision" disciplines and a member of each disciplines team won the title of Individual State Champion. Last year was the first time I've heard of such a complete sweep of the awards.

The Individual Montana Precision Champion was Alison Sutherlin. The Individual Montana Sporter Champion was Nicole Berger.

The Montana Team Precision Champion was the Gallatin Valley Sharp Shooters. The team members were Alison Sutherlin, Paige Hildebrandt, Ethan Bates and Hannah Todd.

The Montana Team Sporter Champion was the Gallatin Valley Sharp Shooters. The team members were Nicole Berger, Naya Talarico, Natalie Samson, and Marlie Sampson.

Because of the clean sweep by an individual team, I at first wondered how many teams had competed. In a conversation with Kim Shriver, Youth Shooting Sports Chairman at National in May 2023, I learned that Montana had five teams that competed. The competing teams were the Gallatin Valley Sharpshooters (Post 87 Manhattan), who entered three teams, two in the precision and one in Sporter, The Yellowstone Rifle Club (Post 4 Billings) and Phillips County 4H Shooters (Malta

Post 57). There should have been six, but one (Hellgate Post 27) did not complete the registration/get it in on time.

The second round of completion selects the top fifteen shooters in the nation in each discipline to compete at Colorado Springs in the National Championships. Based on scores, Montana had three individuals qualify. (Alison Sutherlin from Gallatin Valley Sharp Shooters and Ainsley McFarland from American Legion Montana (Billings Post 4) in the Precision Discipline. In the Sporter discipline Nicole Berger from Gallatin Valley Sharpshooters. The rules do not allow an individual to compete two years in a row in the same disciple and Alison Sutherlin competed last year and will not be able to do so this year. As of 1 June 2023, National tells me that Ainsley McFarland has completed her registration to attend. Nicole Berger is unable to attend.

VETERANS ECONOMICS

Ray Read

Purpose

- To supervise and coordinate all activities of committees assigned to the Veterans Employment & Education Commission at the Department level;
- When necessary, to initiate action concerning all matters affecting the economic well-being of veterans and/or the re-establishment of all war veterans returning to civilian life after a period of active service in the Armed Forces of the United States located in Montana
- To keep Department Commander and the Department Executive Committee informed concerning all developments affecting the economic welfare of veterans in all areas under the jurisdiction of the Veterans Employment & Education Commission;
- Such other purposes as may be assigned to it by the Department Executive Committee
- Two Sub-committee areas:

(1) Veterans Employment & Education

Purpose

- To survey, study and recommend solutions on problems relating to employment, unemployment, underemployment, re-employment, and workers compensation of all war veterans who seek, or have, attachment to the labor force, public or private;
- To study all questions involved in the protection of preferential rights of veterans in civil service;
- Such matters as may concern the obtaining of veterans' preference by legislation, with special attention to securing a more rigid enforcement and broad extension of federal, state and municipal civil service, with adequate

preference for veterans by legislation, and assisting veterans in the enforcement of the veterans' preference provisions of the law in cases which may be referred to it that show a violation of the spirit or letter of said provisions contained in the federal statutes, federal civil service regulations, executive orders or otherwise in all federal governmental employment;

• Such other purposes as may be assigned to it by the National Executive Committee.

(2) Veteran Education, Other Benefits and Homelessness

- To ensure that veterans educational benefits provided by the United States government to veterans are sufficient to pay all of the cost of a college education at state-supported colleges, all of the costs of trade school education, and a substantial portion of education provided by privatelyowned colleges;
- To ensure that every generation of veterans has substantially the same as, or better benefits than, the previous generation;
- To ensure that the federal and local governments are allocating sufficient resources to alleviate and end the challenge of homelessness among America's veterans;
- To ensure that all veterans receive the benefits to which they are entitled as recompense for their military service on behalf of a grateful nation;
- Such other purposes as may be assigned to it by the National Executive Committee.

Those Who Served: America's Veterans from World War II to the War on Terror American Community Survey Report

INTRODUCTION The first veterans of the United States served during the American Revolution in the Continental Army, created in 1775 when colonial militias formed a common army under command of George Washington. Since then, the United States has declared war 11 times and fought in conflicts around the world. More than 41 million Americans have served over the course of the nation's history. More than 16 million did so in World War II alone.

Who are America's veterans? Throughout history, they have included the Green Mountain Boys, Buffalo Soldiers, Tuskegee Airmen, Women Airforce Service Pilots, Screaming Eagles, and Green Berets. They are the men and women who served their country at home and abroad, on land, sea, and air—and since 1973, have served as an all-volunteer force.

This report looks at the roughly 18 million Americans, or about 7 percent of the adult population, who were veterans of the U.S. Armed Forces in 2018.1 Ranging from 18 to over 100 years old, they served in conflicts as diverse as the Korean War and the Global War on Terrorism.

This report provides an overview of these men and women, such as how many veterans alive today served in World War II, the characteristics of Vietnam veterans, and how many Gulf War veterans are disabled. The report primarily uses data from ¹

Importantly, the report focuses on veterans who were alive in 2018. It does not describe all veterans who served during a specific period in the military or the characteristics of veterans at the time that they left service.

HIGHLIGHTS

- The number of veterans in the United States declined by a third, from 26.4 million to 18.0 million between 2000 and 2018.
- There are fewer than 500,000 World War II veterans alive today, down from 5.7 million in 2000.
- Women make up a growing share of veterans. Today, about 9 percent of veterans—or 1.7 million—are women. By 2040, that number is projected to rise to 17 percent.
- The largest cohort of veterans alive today served during the Vietnam Era (6.4 million), which lasted from 1964 to 1975. The second largest cohort of veterans served during peacetime only (4.0 million).
- The median age of veterans today is 65 years. By service period, post-9/11 veterans are the youngest with a median age of about 37, Vietnam Era veterans have a median age of about 71, and World War II veterans are the oldest with a median age of about 93.
