This year the two programs came together to Honor the Nations birth by assisting with carrying the large flag and helping to secure it to the flagpole just east of Carroll College. You all know where that flagpole is and just how big that flag is and those young girls and boys did a really Great Job!

On July 20th I travelled to Miles City for the start of the American Legion Eastern District Baseball game, where I met up with Past Department Commander Richard Klose and Clancee Collins of Post 5 Miles City. We were able to visit with some of the folks in the stands before the presentation of the colors and the National Anthem.

July 23rd, I travelled back to Miles City for the Eastern American Legion Baseball playoff and Championship Game. Following the Championship Game I congratulated and presented the Runners Up and the Winners with their trophies.

Some of the Resolutions voted on by the NEC at the Spring meeting in Indianapolis.

Our National Adjutant Daniel S. Wheeler retired after 45 years of service.

Resolution #1 named him as "Past National Commander" with rights and privileges.

Resolution #2 named room 301 at Nation HQ as the "Daniel S. Wheller Conference Room.

Resolution #3 Increasing Military Tuition Assistance.

Resolution #4 Appropriation of Funding for Credentialing Assistance Programs.

Resolution #5 Rescinding of 24, various obsolete and outdated resolutions.

Resolution #6 Amend the Rule of the National Executive Committee Pertaining to Legislative Resolutions.

Resolution #7 Amend the Uniform Code of Procedure for the Organization of National Conventions.

Resolution #8 Definition of Gold Star Family.

Resolution #9 Artificial Intelligence. Call upon Congress to study security, ethics, law and potential risks.

Resolution #10 Improve security at Department of Veterans Affairs Health-Care Facilities. This came about because of a couple of shooting incident where Georgia security guard was forced to shoot and kill a Veteran experiencing a mental health crisis when the Veteran came at him with a knife.

Resolution #11 Creation of Adjutants Advisory Board to the Americanism Commission American Legion Baseball Committee.

Resolution #12 Authorize Issuance of a Temporary Charter to a Foreign Post. Guadalajara, Mexico.

Resolution #13 Four Rules of an American Legion Program. That the purposes of the resolution, the "parent organization" denotes The American Legion organizational levels as it relates to the sponsored program by a post, district, department and/or national organization.

The Four Rules of a Program shall be as follows:

Rule #1 "Leadership" all elected leaders must be confirmed by the parent organization.

Rule #2 "Rules" all bylaws, amendments and/or rules must be presented to the parent organization.

Rule #3 "Reports" monthly activities report, quarterly financial reports, annual financial reports.

Rule #4 "Controls" parent organization may provide EIN #. 2 parental signatories.

Resolution #14 Support of the Presidential Medal of Freedom Award. To Dian Carlson Evens of Post #2 Helena Montana for her service as a nurse in Vietnam and The Vietnam Women's Memorial.

Resolution #15 Identifying Ideal Candidate for the National American Legion College. Asking graduates to commit for the next eight to ten years in leadership positions at all levels.

Resolution #16 Restricted Fund Allocation to the Reserve Fund.

Resolution #17 Department Retention Award. \$2000.00 to the Department with the highest retention rate.

Resolution #18 National Convention Contract. Holding The American Legion National Convention in Kansas City, Missouri, August 27-September 2, 2027.

California tried to put forth a resolution allowing girls to be in AL Boys Nation because of a diversity law in California.

I attended the Americanism Commission Spring Meeting in Indianapolis May 6th & 7th 2024.

PNC Jake Comer let of with "Our job is the appointments and the disappointments. We don't do enough in American Legion Boys State or the Oratorical contest!" (A lack of participation and enthusiasm by the Post seems to be Nationwide, while some Departments are having tremendous success with their programs.

The following is a brief synopsis of what was discussed short of doing a copy/paste of all the reports.

The Department of California presented a resolution to allow girls to be accepted into Boys Nation because of diversity laws in California. This was sent back for further study and its possible effect on The American Legion Auxiliary and Girls Nation.

American Legion & Scouting

Lauren Tyree, of Pennsylvania was named the 2024 American Legion Eagle Scout of the Year and will receive a \$10,000 scholarship. Runners-up recipients of the \$2,500.00 are Hayden Shaffer, (CO), Robert McPhie (CA), and Jackson Kramer (MN).

American Legion Junior Shooting Sports Program

The 33rd American Legion Junior Shooting National Championship will be held July 17-20, 2024, at Hillsdale College in Hillsdale, Michigan; 824 athletes entered the individual National Postal Match Competition from 123 clubs.

American Legion High School National Oratorical Contest

The 85th National Finals Contests will be conducted on May 17-19 at Hillsdale College. There will be 52 Department winners who will be competing for scholarship money.

The pairing bracket for the 2025 national finals, Quarter-Final Contest 8 will be New Hampshire, New York, Maryland, Delaware, Mississippi, Montana.

Assigned topics for the 2025 National Oratorical Contest are:

Amendment I – Congress shall make no law respecting an establishment of religion or prohibiting the free exercise thereof....

Amendment VII – In Suits at common law, where the value in controversy shall exceed twenty dollars, the right of trial by jury shall be preserved.

Amendment XVIII, Sections, 1, 2, & 3 – After one year from the ratification of this article the manufacture, sale, or transportation of intoxicating liquors within....

Amendment XXVI – The right of the citizens of the United States, who are eighteen years of age or older, to vote shall not be denied.

American Legion Boys State and Boys Nation

Will again be held at Marymount University in Verginia.

The Legion Riders were responsible for accumulating over \$17 Million in donations for scholarships.

In accordance with resolution #6 of the NEC October 2011, the COYE named Chad Johnson of South Dakata for 2024 National Education Award.

\$1,747,000 awarded to 48 states in scholarships including the Samsung Scholarships. Apparently, the Federal Government got involved in the disbursement of funds and some of the previously qualified kids may now be dropped.

Departments are being asked to consider a Department level "Law Cadet Program" this may be tough to implement as for whatever reason we are struggling to maintain the programs we currently have now.

An idea for prepping grade school kids for Oratory and Essay contests was to buy from Emblem Sales and placed into school's comic books. There are \$1.00 each and are,

"Our Country's Flag", "Our Country's Veterans", "Light of Liberty", and "I Pledge of Allegiance".

The 2025 American Legion Membership Card will feature The American Legion Baseball Centennial.

The unique locations of our District meetings show the continued Statewide Department communication efforts and travel challenges necessary but emphasizes the continued strength of our community involvement. Outreach allowed Department leadership to emphasize the various programs available in Montana my program surrounding the importance of history to American Legion posts attending leadership. I appreciate the interest shown by the various attendees at these events. I was also able to continue my look at local veteran monuments and attend commemorations in various communities.

I found throughout Montana that the American Legion is continuing to do what they have done best for 105 plus years. They are supporting the veterans and their families as best they can, utilizing the Four Pillars of the American Legion's National Program: That is Supporting the many facets of Veterans Affairs; Supporting a Strong National Defense; Supporting viable Americanism; and supporting our Nation's most precious resource our Children and Youth. The Montana Department district meeting systems has allowed me to travel the State, work with many seasoned, as well as newer, younger veterans who populate the 117?? plus American Legion Posts, mostly in a rural with all the challenges that manifest themselves in the Frontier State of Montana.

I thank all who made my visits so memorable. I want to thank all those who helped me with Operation Ruptured Duck program. This program is still active, and I am in the process of filling requests by various posts. The program will continue if World War II veterans living in our communities and still serving their fellow veterans are able to participate.

The tenth annual commemoration of Welcome Home Vietnam celebration was successful due to the attendance of Lowell Long and other Legionnaires at the Capitol Rotunda event. See you next year, the final year of the Vietnam 50 Commemoration sunsetting in the year 2025. If you have not signed up for this program do so. All materials and assistance are FREE. Many of the handouts are starting to be in short supply.

I am asking all Montana Department American Posts to continue establish their history and Local Legacy. Your Post's History is important to defining your Post accomplishments. To facilitate National Headquarters has developed a webpage that will allow each participating post its own place online where photos, text and videos can be posted and shared. So, whether your post was established in 1919

or just few years ago you have the opportunity to tell your story in your community and throughout the American Legion.

I emphasize again that all posts continue with the attributes of The American Legion Centennial Program. The now historical program remains available on the National website www.legion.org/centennial.

It is a goal of the Montana Department to update its historical record by incorporating the current written record of the past years in creating Montana American Centennial History. With your cooperation and participation that can happen.

I encourage all Legionnaires to participate in the annual or special Veteran related events. Ongoing Veterans and Memorial Day and upcoming events. Including Law Enforcement officer the year, Firefighter of the year, all veteran related employment awards, the Children and Youth /Americanism programs such as the Government Survey the Constitutional essays, The American Legion Oratorical program, and the 76th annual American Legion Boys State and American Legion Auxiliary Girls State. Get out there, get involved and make it happen.

Annual One Year Narrative and one year yearbook (pictorial) history Contests.

By utilizing the National Program of Post one-year Narrative and Yearbooks (Pictorial) history the efforts to produce the Post Web based Legacy History will support the collection of Post history and the Centennial program. For your information, there are four (4) annual contests conducted on the National level. The contests involve the Post "First Place" winners in the Montana Department for a one-year narrative and yearbook contests. As well as entries for a one-year Department Narrative and Yearbook, I 3will forward a first-place winner in each Post category to the National Historian by September 2024. The Judging will be accomplished in October 2024. Post entries are due at the beginning of the Montana Department Convention, Glasgow, Montana June 26-30,2024.

The American Legion Officer's guide and Manual of Ceremonies contain much information about the history contest. Also, in that section of the Guide are "Capsule History of the American legion" and "Helpful Hints for District/County Historians." Please notify your Posts in your District of this readily available material. This information will also be sent out through electronic means via the

Montana American Legion website www.mtlegion.org or by mail, as necessary. All entries will be judged and the first-place winners in either category (narrative or yearbook) will be certified, and I will forward them to National Historian for entry in the announced contest for that category. Keep in mind the requirements that must be met for the National Contest. And I refer to the most current edition of the Officers Guide for the official rules of the 2022-2023 Legion year, or at the legion website www.legion.org.

DEPARTMENT ADJUTANT

Overall, it has been a good year for the American Legion of Montana, after last convention we set to work on many projects, some that have been completed and some that still needs addressed. Western Vice Commander Randy Edwards from Utah was out in the fall and his visit was highly successful. National Commander Daniel Seehafer visits Montana at our convention this year in Glasgow and we anticipate it being another successful endeavor.

Financially we face some future challenges with our programs, there are obvious reasons for this, as we failed to reach our target with membership, which is what fuels the engine. We will finish 2024 around the same 94-95% that we seem to have fallen into the last few years. That isn't because of a lack of effort. We currently have an outstanding group of Zone and District Commanders who have taken on the challenge, and I can only thank them for their ideas and efforts. We as a Department saw a large number of our comrades pass away the last few years and we simply are not replacing them fast enough. We need to really look at ways to reach the younger Veteran and educate them on what the American Legion is and what we offer within the community and its importance.

I attended the Spring Washington Conference and our Montana delegation had very good and to the point dialogue with our Legislative Representatives in both the House and the Senate. The American Legions voice was heard, and I also want each and every Legionnaire in Montana to start or continue to monitor and respond to Nationals Grassroots Action Center where you can easily reach out to our congressional representatives and support Veteran initiatives.

As I begin my second term as your Department Adjutant, I am really seeing a few things that we as a Department need to address. The Department Constitution and By-Laws needs to be reviewed and or updated. It has been longer than it should be since they have been reviewed. Other issues that have popped up that I think need to be at the very least placed in this report follow since there is some confusion with each.

American Legion Riders

The American Legion has a program, program being the key word, called American Legion Riders, it is a program much like AL Boys State or Oratory that is sponsored by an American Legion Post

within the Department. The Riders are not separate, nor are they their own entity within the American Legion. The Riders chapter, if a Post sponsors them, falls under the Constitution and By-laws of the host Post. AL Riders do not have their own separate Constitution and By-laws. Any chapter that operates under the belief or claims to have a separate Constitution and By-law other than the Post's that is sponsoring them is in violation of National Constitution and By-laws and faces termination as a chapter.

Below is National Resolution No. 5 Guidelines for the ALR National Program. The Whereas clauses have been left out to limit the size but can be easily searched on-line. Resolution 5 dated 5/6 May 2021 combines and rescinds Resolutions 19, 35 and 32. In short, it is the rule.

RESOLVED, By the National Executive Committee of The American Legion in regular meeting assembled virtually on May 5-6, 2021, That all American Legion Riders (ALR) groups be organized as programs supported by a post, department or other duly constituted department governing body of The American Legion and shall uphold the declared principles of The American Legion as well as conform to, and abide by, the lawful regulations and decisions of their department, post and/or other duly constituted department governing body; and, be it further

RESOLVED, That because The American Legion owns, controls, protects and defends The American Legion's intellectual property, composed of trademarks, emblems and copyrights (Emblem or Emblems), the following guidelines are required to fulfill protective standards:

- 1. All members of the ALR shall be current members of The American Legion, Sons of The American Legion or American Legion Auxiliary.
- 2. Each ALR member shall establish and maintain ALR membership by owning, individually or through marriage, a common-law marriage, a life partnership or a long-term relationship, a motorcycle licensed and insured as required by the ALR member's state laws.
- 3. ALR programs may allow for continued ALR membership for those ALR members who have given up motorcycle ownership because of age, illness, injury or other reasons outside the ALR member's control.
- 4. ALR programs may allow current members of The American Legion family to join ALR chapters as supporting members.
- 5. The only approved titles for ALR officers shall be chairman and vice-chairman or director and assistant director.
- 6. All ALR members shall maintain the image of The American Legion, protect The American Legion's Emblems, which symbolizes the integrity and principles of The American

Legion and if wearing Emblem items then the Emblem items will be American Legion authorized Emblems.

- 7. ALR members' vests should display the integrity, principles and values of The American Legion and the ALR by avoiding patches or pins with (1) explicit or offensive language and/or images and (2) political or partisan language and/or images since The American Legion is a non-partisan organization.
- 8. The ALR chapter should strive to represent the virtues, values, ethics and morals of The American Legion in support of freedom, democracy and the safety of our citizens.
- 9. Per NEC Resolution No. 37, May 4-5, 1988, ALR chapters do not have the authority to enter into any formal association or club/council membership with any outside organization that may act or vote in any manner outside the control of The American Legion.
- 10. All ALR members shall obey the laws of their respective state and/or the state(s) in which they ride.
- 11. The ALR chapter's sponsoring organization (post, district and/or department) are strongly urged to review liability insurance coverage to ensure that adequate insurance coverage is available to insure/cover the sponsoring organization, including insurance coverage for any specific special riding event; and be it further

RESOLVED, That American Legion Riders programs shall abide by the American Legion National Constitution and National By-laws as well as their established post, district and department directives; and be it further

RESOLVED, That American Legion National Headquarters and the respective departments shall maintain general oversight of the American Legion Riders program in regard to proper use of the Emblems of The American Legion, the American Legion Riders and the American Legion Legacy Run and to ensure compliance with the American Legion National Constitution and National By-Laws; and be it finally

RESOLVED, That Resolution No. 19 (NEC, Oct. 2020), Subject: "Updated Program Guidelines for the American Legion Riders (ALR) National Program" is hereby superseded and rescinded.

The Department American Legion Riders Director and I recognize the need for some form of document that can organize and give direction to the Riders Chapters. A Standard Operating Procedures (SOP) has been put together and will be reviewed and voted on by the Department Executive Committee, hopefully at Convention. This SOP was written with the intent of not being restrictive but still following the National guidelines and requirements. I want to thank Montana ALR Director Brian Carpenter for both his input, passion, drive and vision in assisting putting the

SOP together, it will be a working document moving forward, so changes and updates can be made. We all agree that the AL Riders program does great things, opens the door for new Legionnaires and provides visibility to the American Legion, but we also agree that a standard operating procedure is needed to get us all on the same page.

Funeral Honors

I received a call from a large funeral home in Montana recently asking for clarification on a so called "policy" of the American Legion for third party solicitation of "donations" to Posts that provide funeral honors. After speaking at length with the funeral home it came to light that the funeral home was directed by the Post to solicit on their behalf a \$75.00 donation for providing funeral honors to Veterans in their community. My first thought was that there had to be a mistake, sure, donations from the family of Veterans who pass are accepted on behalf of the Veteran, but no way was the American Legion charging for the honor of providing services to a fallen comrade. Unfortunately, I was incorrect.

After conferring with my counterpart with the VFW of Montana we issued a joint statement that at no time should a Post or Post member providing funeral honors to a fallen comrade solicit in any way donations for the honor of providing the service. This includes having a third party, such as the funeral home solicit the request on the Posts behalf. Both the American Legion and the VFW believe that providing funeral honors for Veterans is a solemn duty, honor and privilege. We honor the service and sacrifice of our Veterans with dignity and respect and certainly do not place a potential financial burden on the grieving family. Unsolicited donations for honors are certainly acceptable and welcome.

There has been a lot of confusion or instances of disagreement while providing honors at funerals as well, I understand many of our honors teams have a traditional way of honoring our comrades, however, if a family requests a certain agenda or way, they would like the service to go, we should always try to accommodate that if possible. I have gotten calls regarding the refusal of honor teams to adjust how they do the service, this should never happen as it is the family's decision on the protocol, assuming it's within reason.

It is also important to remember that the US Army is in charge, if present at any funeral and we are to follow their direction. The US Army funeral honors regulation, 10 U.S. Code § 1491, mandates that military units provide funeral honors for eligible veterans if requested by the family. The regulation states that the funeral honors detail must consist of at least two people, with at least two of those people being armed forces members who are not retired. The remaining members of the detail can be armed forces members, Veterans' organizations, or other organizations approved by the Secretary of Defense. One member of the detail must also be a representative of the deceased Veteran's parent service.

The minimum funeral honors ceremony includes the folding and presentation of the US flag and the playing of Taps. Other traditions, such as a three-volley salute, are optional. The number of shots fired in the salute depends on the veteran's rank or status, but it will always be an odd number.

The US Army in Montana works closely with the various Veteran Service Organizations in Montana, and if funding allows, they provide a stipend to the Post for the funeral honor service. We must work with them and not try to sell them on the "traditional" way that the Post has always done it. Regulations change, and we have to adapt as well.

CHAPLAIN

In the past, as I have read the book of reports published by the Department the Chaplain's report is short or not at all. A Chaplain is an integral part of the American Legion and is a post that should not be taken likely.

There are a couple of points that I feel should be taken seriously.

- 1. Give respect to the office.
- 2. Work with other chaplains within your district
- 3. Work with your post officers
- 4. BE A NETURAL VOICE in any and all meetings.

All chaplains should be familiar with Chaplain's manual and handbook, not saying have it memorized but be familiar and above all else ask questions to those who have held the position in the past they have a great wealth of knowledge. Another point is checking the legion web site for any type of training for chaplains.

There is a requirement that each post or district have a Four Chaplains Ceremony each year and a lot of posts did do one. Thank you.

The Department ceremony was held at the post chapel on 3 February 2024 at Fort Harrison at 2:00 PM. It was one of the largest in recent times according to the comments that I received.

I want to thank all the help I have received this year to do this job; it has been a rewarding experience Thank you.

FINANCE OFFICER

I officially took over the Department Finance Officer position in February this spring when Mr. John Joyce deployed overseas. Our first order of business was to conduct a complete Internal financial review of the American Legion Department of Montana finances the week of 31 Jan 2024. Present for this review were the American Legion Department Adjutant, the American Legion Department Office Manager, and me.

During our review, we noticed that we had numerous checks that were over a year old. Stockman bank checks are only good for 120 days, after 120 days Stockman returns all checks. The bank will return the checks to your post with a \$30.00 service charge. So please ensure all checks are cashed promptly. Any checks beyond 120 days that the holder would like reimbursed for would need finance committee approval for reissue.

Our Stockman Wealth Management account grew by 9.6% from \$445,694.62 on 1 Jul 23, to \$492,978.33 on 1 Jun 24, a gain of \$47,283.71. Assets are broken down by \$306,755.03 in Equities, \$175,136.72 in Fixed Income, and \$11,086.58 Cash & Equivalents.

As of 1 Jun 24, our current funds available is \$699,003.48 across all accounts.

Our biggest expenditures for this year were the purchase of a new department truck for \$85,000 and department sold the old truck for \$23000, and the proceeds went into the American Legion Operations account,

The gross income for American Legion Boy State was \$27,415.50 and a total expense of \$36,171.17. A checking account shortfall of \$8,755.67. The largest program expense items were \$20,322 for contract meals, \$6,136 for lodging, \$4,093 shirts, and \$2,588 in transportation costs for its 2023 program, of which was all paid out in FY 2024. The shortfall was moved over from the AML BS savings account.

The Executive Committee executed two new Employee contracts (Dept Adjutant and Officer Manager) on or about 1 April 2024. Currently payroll expenses have been averaging \$8600 a month. A more accurate amount will be provided after a couple monthly payrolls are processed and averaged out.

The publication and mailing of the Legionnaire newspaper cost us \$3 per members which comes out of the membership. We pay \$39,600 per year for layout and distribution of the Legionnaire Paper. This is down from \$44,000 in 2020.

National has changed our business practices regarding how membership dues are collected and paid. Currently, the Department only gets \$11.50 per membership, out of the \$36.00 dues, the Post gets \$6.00, and National gets \$18.50. Membership goal for 2024 was $9844 \times 11.50 = 113,206$. As of 1 June, our membership number was 9252, a shortfall of 592 memberships or -\$6,808 short of our goal of \$113,206.00.

Our department fundraising raffle campaign came in short by ~\$18,679.00 of the \$27,000 originally budgeted. In March to help offset this shortfall, both Ken Simon and Bill White each donated a rifle to the raffle. I would like to recognize and thank both Ken and Bill for their donations. So please get your rifle raffle tickets before they are gone.

This spring we got a notice from QuickBooks stating they will no longer provide support for our current Department finance "legacy QuickBooks" system. Starting 1-20 July 2024, we will be

moving to a new online version of QuickBooks that will allow us to correct some legacy accounting codes listed below and potentially allow members of the finance committee read-only rights to the system. Allowing for better financial transparency and reporting. The auditor and tax accountant will be sitting with us during this period to ensure we correct all the items listed above. Department staff will not be able to cut checks or answer financial status questions during this conversion process window.

External Audit findings:

- 1. Too many accounts in QuickBooks. (example: Should only show balance sheet of typical Assets, Liabilities, and funds balance.) Will be corrected during roll over to new QuickBooks program.
- 2. QuickBooks needs a complete hard reboot to correct years of data fields that cannot be deleted or changed. (example: accounts closed in 2011 are still rolling up in current liabilities account).
- 3. Ten-(10) Legacy closed accounts still showing up in reports. (will be fixed in hard reboot and rebuild of the new online cloud version of QuickBooks)
- 4. Cross payments being made across different American Legion EIN programs. (example: American legion paying for Auxiliary legionnaire paper mailings).
- 5. Scholarships not being paid out. (SAL and AML). (develop proper bylaws on how scholarships are paid out and how much).
- 6. Fixed Assets not properly accounted for due to hard coding numbers set in Legacy QuickBooks program. (example: American Legion vehicle value at \$120k). This will be fixed in the new program.
- 7. Other current assets are not properly accounted for due to hardcoding numbers set in the legacy QuickBooks program. (Example: Office inventory supplies not able to adjust numbers. This will be corrected during the reboot)
- 8. Too much money on hand for a non-profit organization. (Need to develop a spending plan to satisfy the IRS).
- 9. Old closed credit cards showing up in the report because of hard coding in legacy QuickBooks not allowing change. (example: line 2214 USAA MasterCard shows \$375 still owed). This has been paid and closed! This will be corrected when we move to the new online program.
- 10. Endowment fund needs reworked on how funds will be invested and how interest will be spent as we move forward.

Each Committee needs to look at its programmed budget and look at how that committee could raise funds to meet its yearly program requirements. Due to inflation and higher costs, we had a couple of programs go over their allotted budget and we had to move funds around to cover the expenses.

The official FY 2024 year-end closeout financial report will be published NLT first week of August 2024 and presented during the fall convention.

JUDGE ADVOCATE

Greetings to all my Legionnaire friends and colleagues. Once again, I will be unable to join you at the summer convention. I will be in France to attend the dedication of a memorial to my Uncle Jack and his fellow B-17 bomber air crew members who were KIA (and one POW) on June 22, 1944. The memorial will be dedicated in Epagne-Epanette France on the 80th anniversary on June 22, 2024. We are expecting there to be 40 or 50 family members of the air crew at the dedication ceremony.

ELECTION QUESTIONS

In November and December 2023, I conducted an investigation and wrote a report to the Department Commander with respect to the 2023 officer elections at the 2023 Summer Convention. My report included recommendations for steps that might be taken to strengthen the election process.

ADJUTANT'S EMPLOYMENT CONTRACT

Also in October, November, and December 2023, I assisted the Finance Committee with making final revisions to the Adjutant's employment contract. I participated on a Zoom call on December 6, 2023, with the Finance Committee to discuss the Adjutant's contract, the Department's endowment account, and questions about the Adjutant Assistant's lack of overtime pay over the years. The final contract was approved by the DEC on April 3, 2024.

ADJUTANT ASSISTANT'S OVERTIME PAY

On May 2, 2024, I attended a meeting at Fort Harrison with members of the Finance Committee to discuss how to handle issues with overtime pay.

IRS FORM 990 AND SECRETARY OF STATE ANNUAL REPORTS

On April 8, 2024, I wrote an e-mail to the Posts to explain how IRS Form 990's and Annual Report's filed with the Montana Secretary of State are handled. That message is worth repeating here:

"Hello everyone -

Erin's e-Mail message refers to two types of filings required of all non-profit organizations who wish to maintain their tax-exempt status and their corporate existence.

Form 990 is an Internal Revenue form that must be filed with the IRS every year. An organization that fails to file the required information return (Form 990, Form 990-EZ, or Form 990-PF) or e-Postcard (Form 990-N) for three consecutive tax years will automatically lose its tax-exempt status.

Once the IRS has revoked an organization's tax-exempt status, there are forms and fees that must be filed to obtain a reinstatement. You can learn more about that process here:

The Montana Secretary of State requires that all companies (for profit and not for profit) must file an Annual Report each year between January 1st and April 15th. A failure to file a report each year subjects the organization to being involuntarily dissolved. An organization can request reinstatement by filing the required forms and by paying a fee. You can learn more about the Annual Report and the reinstatement process here:

If you scroll down the page on the above link, you will find an explanation on how to seek reinstatement of an involuntarily dissolved organization. You will note that the request for reinstatement must be made within five years of dissolution. After that you will have to start over and file as a new entity.

If a Post fails to file the required 990 with the IRS, and/or the Annual Report with the Montana Secretary of State, there are legal and financial consequences. A failure to maintain a Post's non-profit status prohibits that Post from claiming tax-exempt status and the Post cannot solicit or accept charitable donations. In addition, a failure to maintain a Post's non-profit status and a failure to adhere to the corporate formalities of operating a Post may subject individual members of that Post to liability if someone claims that they or their property were injured or damaged at a Post event or on Post premises. Other problems can arise with your bank accounts, your insurance policies, or with contracts/leases/agreements that the Post has with other parties, if the Post's non-profit status and corporate existence lapse.

Posts that are set up as non-profit corporations should also hold at least one corporate meeting each year and keep minutes of those meetings. If the Post is sued, the plaintiff's attorney might try to ignore the liability protections of the non-profit corporation and instead try to recover damages

from individual Post members. Keeping the Post's non-profit corporate status up to date, and adhering to all corporate formalities, can help protect individual Post members from getting sued.

So, the long and the short of it is that these forms are very important, and they must be filed every year.

If your Post's tax-exempt status has been revoked by the IRS, or if the Secretary of State has dissolved your non-profit company, you should consult an attorney about how to get reinstated or, if it's too late to get reinstated, about how to recreate the non-profit company from scratch.

I hope the above information is helpful. While I am prohibited from giving legal advice to Legion members, Posts, or the Department in my role as Judge Advocate, I might be able to steer you in the right direction if you have questions.

ODDS AND ENDS

On February 21, 2024, I attended a meeting at Fort Harrison to discuss possible revisions to the Department Constitution and By-Laws.

On March 8-10, 2024, I accompanied the Department Adjutant to Chinook and Glasgow for District meetings.

On March 27, 2024, I had a Zoom meeting with National Judge Advocate Mark Seavey to discuss various Department matters including procedures for how a Post might reprimand a member.

In April 2024, I spoke with a Post Commander about possible ways to handle a situation involving a Post member and a Post employee.

Also in April, I assisted the Adjutant's Assistant with answering a District officer's question about how to complete a District IRS Inclusion letter.

On May 14, 2024, I contacted a friend at Town Pump Corporation to lend my support for the grant request that the Department made to the Town Pump Foundation for funds to assist with Boys State and Girls State. On May 15, 2024, I met with the CEO of the Town Pump Foundation, Bill McGladdery, who notified me that the Foundation had approved a \$10,000 grant for Boys State and Girls State.

On May 21, 2024, I did some research about the propriety of a Post being paid by the families of Veteran decedents for honor guard services. I determined that it is improper for Posts to make arrangements with funeral homes (mortuaries) to have them collect money from families to pay a Post for honor guard services. To be clear, a family may voluntarily give a gift for an honor guard, but that gift should not be solicited by a Post.

On May 16, 2024, the Adjutant's Assistant notified me that a TAL member had called the Department office seeking some assistance with his estate plan. I called the member and learned

that he wishes to leave a generous cash gift to the Department in his last will and testament. He asked me to help him find an estate planning attorney. I am presently speaking with potential attorneys who might assist this member.

SERGEANT-AT-ARMS

Linda Cousineau

For the past year as SSA, there is little to report. First, I was appointed late in the job and second, the department conference was via Zoom. No fines were collected and everyone did very well. One suggestion I have is that during official American Legion Zoom meetings, the meeting host should remind members to still wear their cover and follow proper protocols during the POW/MIA draping, prayer and Pledge of Allegiance.

I attended the Department Oratorical Competition and the Remembrance Day ceremonies in Coleman and Bellevue, Canada as a Department representative.

American Legion Cap protocols - The cap is part of the official uniform so there are some rules to follow: only service pins and authorized AL membership insignia, membership stars and/or decorations can be worn on the right side of the cap. The left side is reserved for the AL emblem and lettering as set forth by resolution for post, county, department or national caps. You may also display the offices you held, as embroidered or pin, but on the right side only. Rank, names or nicknames cannot be displayed on the cap. American Legion has no rank in the organization.

Standard of Conduct

- The cap is to be placed two fingers above the eyebrows and not tilted left or right.
- The cap should be worn at all times when attending official American Legion meetings and ceremonies or when representing The American Legion on public occasions. DO NOT wear the cap to any political functions, demonstrations or rallies.
- When removing the cap for Pledge of Allegiance, POW/MIA flag placement and prayer
 place the right hand in the cap and the cap over your heart with the emblem facing out. For
 cap belt clips, again the emblem faces out. When placing it down on a surface, the emblem
 always faces up.
- And, please remove your cap during meals.
- Females have the option of removing the cap or following the prescribed rules of the armed services.

It's your badge of DISTINCTION, HONOR, and SERVICE. It stands for GOD and COUNTRY.

SCOUTS BSA

On the 26-28 of April I attended the annual convention in Missoula of the Montana Council 315 Boy Scouts of America. The Montana Council is listed as one of the top councils in the country and membership is increasing. The American Legion, Department of Montana presently has fifteen Posts that sponsor twelve Cub Scout Packs and eleven Scout Troops.

On the 10th of May I talked to the American Legion National Scouting Chairman Jeff Bennett. Jeff told me that there are no new National Scout resolutions pending at this time and the next Department Scout Chairman virtual meeting will be scheduled later this year. The last meeting was on 16 September 2023.

As of the 13th of May, I have received only 5 Scouting Award Post Evaluation sheets back from Posts: 1 Butte, 2 Helena, 25 White Sulphur, 27 Missoula and 137 Kalispell. I emailed and called all fifteen Posts. The submittal of these forms is important as it gives the Post Adjutant and the Department the number of youth we sponsor each year.

Eagle Scout of the Year: I did not receive on American Legion Eagle Scout of the Year application for 2024. Applications were due to the Department by the 15th of March and forwarded to National by the 1st of April.

BOYS STATE

Duane Cunningham

I was asked by the American Legion Boys State Committee to step in as the temporary Boys State Chairman until a replacement could be identified to assist the American Legion Boys State Director with putting together the 2024 American Legion Boys and American Legion Auxiliary Girls State Program. I have no intent of remaining in this position after the conclusion of the 2024 program as it should be filled by a Legionnaire dedicated to the amount of time and work that the position requires.

The last few years we have seen a reduction in attendees for the Boys Program. I did a little research, and it was only 20 years ago where we were averaging 400 plus Boys attending the program. What has caused the reduction? Many things, beginning with competition from other camps and programs. High school sports are no longer a seasonal program, coaches expect kids to attend summer camps if they plan on playing the following season. While this is unfortunate, it is a reality. The other elephant in the room is our ability as Legionnaires to connect with both the local schools to promote the program and our ability to "sell" the importance and opportunity that attendance at Boy's State represents.

The traditional and historical way of doing business with the local school districts is failing for the most part and we need to change tactics, or our program is slowly going to fade away. Times have changed and we simply cannot just walk into a local high school and be heard. From Covid to school shootings, schools are now much more inaccessible to just anyone. We have started working with the Montana Office of Public Instruction to help educate and advertise our programs, there is opportunity to work with OPI to establish actual school credit for attending ALBS as part of the newly mandated Government/Civics credit requirement. We need to get in front of this opportunity.

This year we had at last count around 45 boys and 65 girls attending the two programs, this is a far cry from the days of 400 kids. The cost of the program will also need to be something that the future committee addresses as it currently takes around \$40,000 to run the program. At the current rate of attendance, the program is continually in the red. Sponsorship, grants and advertising are the real future of paying for the programs. If we had not gotten a \$10,000 grant from the Town Pump Foundation, we probably would have had to cancel the 2024 program. We have to get better at finding funding and that includes Posts that don't provide delegates to ALBS. All Post's should be budgeting for at least one delegate and if they cannot find a delegate, why not still forward that \$300 to the ALBS Program to keep the program alive?

All is not doom and gloom, there are many Legionnaire and Auxiliary members out there working hard to make the program a success, we just need more assistance, and we have to lose the mentality of we are two separate programs, and we cannot help each other. The last two years of a combined boys' and girls' programs have shown that it can be done, but we still have some of the old mentality of mine versus yours. That mentality leads to failure and needs to be left at home.

Let's get back to remembering what opportunities and doors the American Legion Boys State and Auxiliary Girls State programs offer to the kids that attend them. Children and Youth and Americanism are Pillars of who the American Legion is. The delegate you convince to attend, assist during the week, or sponsor the opportunity for, could be the next Governor of Montana or Legislative Representative in the House or Senate. That really is the opportunity we are providing, we seem to have forgotten that unfortunately.

FINANCE CHAIRMAN

On May 29th and 30th, the Finance Committee met via Zoom at 19:00 hours to discuss the Department Budget for 2024 – 2025. Those in attendance were the Department Finance Officer Lonnie Cook, Finance Chair Ken Simon, Committee Members Bill Cummins, Andy Rice, Clancee Collins, Mike Allison, Joe Yeoman, Jed Damson, Department Adjutant Duane Cunningham and Office Manager Erin Carpenter.

The first zoom meeting covered the Income portion of the Budget with emphasis on Fund Raising, Big K Raffle Sales, and the Cash Calendar Sakes. We discussed what could be done to jump start our Fund Raising in regard to the Raffles such as Big K, tickets, and Cash Calendars as the past two years we have not been able to fully support the Programs that the Department of Montana - American Legion operates. This is due possibly to the increase in the cost of living and what Posts are doing to support their own programs and running those at the same time as the American Legion Raffles and Fund Raisers. It was suggested that the Big K raffle tickets be sent to the Posts and have them placed in the members Renewal envelope as it has been done by some Posts around the State with success. Another comment was that we as leaders need to educate our members that the BIG K raffle is a way to raise money for their Posts and the programs around the American

Legion of Montana. It should also be noted that when the Posts sell the BIG K they retain \$8.50 from each one goes into the Post account. BIG K is the Top Fund Raiser for the American Legion of Montana and if every Post sold from seven to ten, then we could make it possible for the programs to be funded along with the ticket and cash calendar sales. The BIG K is not the only way to raise money for your Post without having to pay for raffle tickets or cash calendars. With the sale of every ticket or calendar your post gets to keep \$2.00 from each individual sale, plus you are supporting the various programs such as Oratory, American Legion Boys and Auxiliary Girls State, as well as Children and Youth.

There are minor changes to the budget line items in that some are no longer needed and will be going away and the History Book line item 6131 will now be Publication Fees.

The meeting ended at approximately 20:30.

The second Zoom meeting was conducted on May 30th and began at 19:00. The Finance Committee discussed the Expenses for the Department. Some of the items discussed was the cost of the three storage rooms for the Montana Historical Building that we pay for, the cost to have the Auditor conduct an audit on the Department Books once a year, Adjusting travel to the Fall Meetings as well as the Fall Conference in Helena and the pending travel to Calgary for the 2025 Spring Convention. The adjustments to travel to District Meetings and Fall Conference was discussed as a way to trim the budget due to the higher cost of fuel, food, and lodging for those Department Officers who have to travel. Other possible savings discussed was by changing the Legionnaire from paper to Digital due to rising cost of printing the paper and the fact that many newspapers are going digital and so having one close by to print the paper may soon not be a possibility! The plus side of being done digitally is that it could be put out more than twice a year, thereby providing the Members of current and constant news if it was produced digitally with less cost. All articles would then be current and not old news and it is a very real possibility that all news will be digitally produced within the next five years! It is common knowledge there are members who do not have computers or do not desire to use advance technology to read the paper. A copy printed can be printed at the Post level and provided to those members. The cost of the digital Legionnaire was discussed in regard to how that will be borne by the various organizations desiring to have articles placed in it. Those costs will be researched and announced before production online is started. Other savings will be made by dropping the Go Getters Breakfast as attendance has dropped off and it is not cost effective to pay for meals that are paid for and not consumed. The Americanism Committee will discuss this and decide if there is no increased interest shown, then the breakfast will disappear. In regard to American Legion Boys State, it will be the responsibility of the Committee to conduct fund raisers to provide the needed support to fully fund the program. This can be accomplished through fund raisers, donations, and/or grants.

Regarding the Oratory Program, only five per cent of the Post Participate! Like the Law Enforcement Officer and Fire Fighter of the year, and the American Legion Boys State and

Auxiliary Girls State Programs there should be more participation from the Posts around the state! It would make not only the fund raising worth-while and also recognize the caliber of people that surround us every day! We have eleven Districts and one hundred and twenty Posts in our Great State, and there should be more than a handful of participants for these programs. Costs for plaques and certificates have added to the expense of the programs as well as the cost of bringing those people selected to our Annual Department Convention. This year, it was decided to present the Law Enforcement Officer and Fire Fighter of the Year awards at the home District Meeting to save the Department money in travel and/or lodging if needed due to distance!

What we as Legionnaires need to begin to look at is that the cost of doing business is increasing and we have to look at ways to conduct our business to make it less costly for all who may need, or want to attend those meetings. Like you at your home or business, the Department Finance Committee is constantly looking at cost cutting moves but with the members in mind. Our Finance Committee has conducted the majority of our Meetings via Zoom this past year to save on travel pay for the committee members. While everything is not covered in this brief report, the Finance Officer will give a more detailed report at the 2024 Spring Convention in Glasgow June 27th to the 30th.

Also similar to last year, this reporting period has been a challenge due to the unpredictability of the weather...yeah, it snowed last night in the west and rained copiously in Yellowstone County. Due to that, many markers are still waiting for Mother Nature to give an "OK" to the program.

CORRESPONDENCE

I reach out to posts every two weeks with any updates to fatalities in their districts. I do this on a post-by-post basis. The number of posts that I am in communication with is 54, up from 33 last year on this date. I have NO communication with District 3 which has incurred a number of fatalities that I am unable to support. If anyone at this meeting is from District 3, I encourage them to contact their posts to find out if there is any availability for doing the job.

We still enjoy a number of posts that share resources. I have found someone who is willing to manufacture crosses for me; I am reliant

on others for posts. I have not succeeded in finding a resource. A big thank you to all those posts who help each other out.

I have done my best to stay on top of calls that are passed on down the line from the Adjutant's Office. My goal is to resolve to some degree of satisfaction the problem; educate the callers concerning the nature of the Fatality Marker Program; and, finally, contact a district or a post that may have the ability to resolve the problem in finality. Nearly all the feedback I have received has been favorable. It may be an indication of satisfaction that a number of people have made donations to the program via the Adjutant's Office. I have reached out to thank these generous folks with a personal letter.

We have had a good rapport with the news this period. Greg Harbac from Post 14 wrote a terrific article for the Montana Legionnaire, while I was interviewed for the Distinctly Montana magazine which ran a nice article (with photos) earlier this year.

THE BOTTOM LINE

I had reports from 24 of 54 posts. 8 new posts have been set; all other reports indicate cleaning and maintenance is on-going. I believe that as the weather improves, so will the placement of posts.

HOMELESS VETERAN/VETERAN ECONOMICS COORDINATOR

In Montana, there was a 56.4% increase in Veterans who were homeless from 2021 (110) to 2022 (172) based upon the Point-in-Time count done in January 2023. I could not find PIT count data for 2024. In 2022 the Montana VA was able to help 211 Veterans secure housing. Unfortunately, it was anticipated that more Veterans in Montana will experience homelessness during 2023-2024 due to the housing shortages and rising housing costs throughout the State.

One of the many programs out there for our Veterans is the HUD-Veterans Affairs Supportive Housing (VASH). HUD-VASH is a program that provides landlords with an opportunity to rent to Veterans. The VA Supportive Housing Program (VASH) pairs HUD's Housing Choice Voucher program with VA case management and supportive services for homeless Veterans, it also helps homeless Veterans, and their families find and sustain permanent housing.

I am trying to learn as much as I can.

INSURANCE DIRECTOR

In the last 12 months we have received two disbursements totaling \$18,773.88 in premiums paid to the Department of Montana for Long Term Care, HIP, AUX HIP and Cancer, Cancer Disability, AD & D and Life Insurance. The promotional bonus is based on membership; to increase the bonus, we obviously need to increase membership and get folks registered for the AD&D benefit.

The LIT offers 13 different insurance products, but our most popular products are the cancer and EA+ insurance. There is a myriad of promotional information available for the Post to use, please contact me if you require any information. Our job is not to be insurance salesmen, but to inform our members of the insurance benefits. Please remind your members of the Accidental Death benefit periodically so they can take advantage of this program and remind them they must register.

The information LIT gathers from these sign ups is the number one source of policies written. Signing up for the free AD is our best way of ensuring the LIT markets to the right age group. Remember when you transfer a member from DMS to provide them with the information on the free AD, they do not receive the info from National. If a member is in doubt about being registered, they can call LIT or go online at www.theLIT.com/LegionCare2 to check their status. Every year we have family members of deceased members attempt to file a claim only to find their loved was not registered. Once a member registers, they are now registered for as long as they are members.

We have got to ensure our members are registered for this benefit, especially our new members, and remember any member acquired through DMS has never been given a registration opportunity for the free AD. Senior (18 or older) Auxiliary and senior Sons of the American Legion members can sign up for the free AD & D under the same conditions.

Every Legion member is Montana should register for the benefit. The LIT offers both free and cost-based products and recognizes that they must continue to offer good reasonably priced products.

In 2020 the LIT instituted a new incentive program for those Departments with innovative membership programs; the best three will receive \$12,500, \$7500.00, and \$5000.00 respectively.

Since 1967, when our Department joined with the Legionnaire Insurance Trust the Department has received 0ver \$745,000.00. Check out www.theLIT.com for further information on LIT products.

 - a. Attendees: Sign-In Sheet was passed around. Copies of NEC Resolution 5, an example of unofficial Department Bylaws, and chapter start up guidelines were made available.

II. Introductions & Orientation

III. Post Reports

- a. **Post 1 –** Butte No Report.
- b. **Post 2** Tri-County (Helena) Will Leitzke summarized 2023 & briefly went over upcoming 2024 events. Stated they offer \$100 for gas to members who need to get back-and-forth to drill weekends. They have the Lincoln Ride & other poker runs coming up. They do a coat drive every winter & a hat/sock/glove drive for the YWCA. On May 18, 2023, their poker run raised \$2040 for the National Guard. Their Poker Run this year will be on June 15th.
- c. **Post 4** Yellowstone (Billings) Trevor Barnhart started by gifting "Carp" a bottle of whiskey & said he's doing a great job as our director! Trevor stated chapter

membership has more than tripled since last year. They've presented flags for Fusion Fights & were told they've become the "Gold Standard" for flag presentations. Also presented flags at the 3-day PBR event. They have a Poker Run set for Sept 27, which has a wide-open invite to everyone. They're helping with the Indian Rally August 11-18. They'll be hosting 2 events at Post 4 in Billings, as well as leading the ride over Beartooth & Chief Joseph passes. Asked for help from other Legion Riders since they'll be responsible for keeping over 150 riders safe. In 2023, they did flags at fights in Cody, the Iron Horse Rodeo during Beartooth Rally, supported a Dog-Tag Buddies benefit dinner, supported a Young Marines auction & dinner. They currently have 18 active members & are growing.

- d. **Post 10** Deer Lodge No Report. They just began a chapter last week!
- e. **Post 11** Havre Bob Brewer summarized 2023 activities... they had several flag ceremonies. Les is Commander of Vet. Honor Guard they do funerals, rodeos, etc. Their Wounded Warrior Run raised \$14,000 last year (\$10,700 the year before). They do a Memorial Day event with the Boy Scouts. Businesses in town donate money to a scholarship they manage for H.S. graduates; criteria is they have to have a military affiliation. They sponsor Havre youth girls' softball so they can purchase uniforms, helmets, etc. they do a "pass the hat" under the ALR title. They donate gift bags to veterans at the retirement home during Christmas time.
- f. Post 16 Lewistown Derek Manseau stated their Veterans Meat Pantry distributed 140 packages of wild game meat last year, in addition to 3 whole beef donated by local meat growers. They also give out hams at Easter. They had a walk through downtown & a BBW at Veterans' Park. Rally in the Valley is coming up (same weekend as Havre's Wounded Warrior Run Memorial weekend). They present flags for Memorial Day & funerals. They do highway memorial marker maintenance every June; they replace both the post & the cross. In September, they have a booth at the Chokecherry Festival to conduct outreach. They have 2-gun raffles per year to support their expenses & meat processing costs. In December, they co-sponsored a tree at the Boys & Girls Club Festival of Trees (had a bear hunt theme). They currently have ±25 members.
- g. **Post 23** Livingston No Report.
- h. **Post 30** Belgrade No Report.
- i. **Post 39** Forsyth No Report.
- j. Post 91 Corvallis Don Goodnight reported they had elections in March. They currently have 28 members. They do a HUGE Memorial Day parade that's been hosted by the Post for 102 years it's the largest parade in MT. They are challenged to get as many bikes as possible; last year, they had 96 bikes! They host a river ceremony for Navy personnel lost at sea. In June, they hold the Post 91 Poker Run to support Hamilton Project Healing Waters. Last year, they raised over \$4,000. In August, they do security at the annual Creamery Picnic in Stevensville. They do a gun raffle to take 2 vets on a week-long bear hunt in Idaho. October, they participated in a Trunk-or-Treat in Hamilton; they gave out ±15 LARGE bags of candy. In November, they help the Post host a Veterans' Day parade. In December, they donate a full Christmas dinner plus gifts to TWO veteran families. They do funeral escorts.

- k. **Post 112** Polson No Report. This Chapter has disbanded.
- l. **Post 135** Lolo No Report. Don Goodnight will be going to meet with them next month to help facilitate their growth.

IV. Miscellaneous Discussion

- a. Discussion was held about forming a District/Zone committee that is Riders specific so Brian won't have to drive the entire state for necessary outreach. If formed, Don G., Gil F. & Trevor B. volunteer to serve on the committee.
- b. Trevor B. made a motion at the District 11 Spring Meeting to post Rider Info on the bulletin boards at the different Posts. They have 20 posts in their district & Post 4 has the only Riders' Chapter. They'll start holding Riders' meetings at different posts in their district to start letting others know they're out there.
- c. Brian C. stated Havre has a member who lives in Kalispell. Great Falls is having 1 Riders Chapter for both of their posts until they get enough growth to justify splitting.

VIII. New Business

- a. Bob B (Havre) suggests having a "Directors Forum" to be run via text messaging, email, Zoom, Microsoft Teams, etc. It would be nice to stay in touch, at least quarterly to discuss ideas, problems, etc. It would assist in cohesion between chapters. Decision made to meet once a month during riding season and quarterly during the off-season. Carp will start an email thread.
- b. Trevor B (Yellowstone/Billings) asked other chapters about how they deal with membership voting? Dues? They vote theirs in by majority it helps to see if Riders will be active rather than someone who just wants a patch. They also require a ride with an officer before joining to judge their riding level. Don G. says they have requirements: they must attend at least 6 meetings/year & 2 events/year. They use an incentive program: Riders get a ticket for every meeting they attend & every year, those tickets go in a drawing for a \$250 gift certificate to a gun store. They have probation if you don't meet the requirements. Gil states Yellowstone/Billings requires \$20/year in dues & 1 ride/year. They do have laxity for some members who are literally unable to make meetings/rides. Brian (Havre) states they take dues & have no expulsions, even if no one ever shows or volunteers. Question about voting rights do only Riders get to vote? What about Passengers? Don G states they're in the process of changing their Constitution & ByLaws they've made some provisions for disability. They've started a "support group" to allow disabled

or non-riders to still participate by driving a chase vehicle, etc. Helena allows supporters; Some don't like having a supporter provision due to those who don't understand the motorcycle world. Don states they give voting rights to supporters on everything except officers. Everyone agrees Passengers should have voting rights but Carp states the Director of the Chapter should probably be a Veteran. He does remind everyone that each post/chapter has their own Constitution & ByLaws; there are none at the Dept level, so each chapter can put whatever voting rights and/or rider requirements in their ByLaws. Sara F (Yellowstone/Billings) asked how "answerable" to the Host Post is the Riders Chapter? You still have to bring causality/issue to the general post membership & get a vote. Discussion about account holders, signatories, etc. REMINDER: The State Director is appointed by the Dept Commander, so it's important to have ByLaws at every chapter level so the Dept can't come in & "appoint" things carte blanche.

c. Questions were brought up about next year's meeting location, maybe have it somewhere easier for the western MT folks to make it. We should wait until after the convention to see if the new commander appoints a different director, maybe leave it for the Directors' meeting. Trevor B (Yellowstone/Billings) makes a motion that the 2025 Annual Meeting be held in August in Helena to coincide with the POW/MIA run (3rd weekend); Jerry seconded. All agree – Passed.

LEGISLATIVE

Roger Hagan

Your Legislative Committee has continued to represent the Department in a variety of venues since the Fall Conference. During that time, we have coordinated on the Veterans Long Term Care and Veteran Cemetery Study, met with the State Administration and Veterans Affairs Interim Committee (SAVA), and attended the Washington Conference in February.

The major focus continues to be Veterans Long Term Care and Veteran Cemetery Study. The Department of Public Health and Human Services (DPHHS) has made some progress in marketing the program to many entities in the state, however, there remains to be further efforts on their part to get the message out to as many veterans as possible. We were able to convince the DPHHS to extend the study cut-off date from April 8th to July 15th. The online site will remain active until then. As of this report we have had over 3,000 surveys completed, with a few hundred completed

in hard copy. While that sounds like a lot, there are over 90,000 veterans in Montana, so we have only touched just over 3% of our veteran population. We need our Legion Posts to aggressively work to get their members to complete the survey, either online or by hard copy. As I said in my last report, each and every post, district, and zone must step up, to ensure that we reach as many veterans as possible.

Since the Fall Conference, your American Liaison to the Governor, Bill White, and I have attended two SAVA Interim Committee meetings. We continue to have a positive, beneficial relationship with the members of that committee. I was pleasantly surprised that three American Legion members from Lewistown attended the May SAVA meeting and expressed their concern about the workload of our current Veteran Service Officers (VSO's), the time it takes to get a claim filed due to the shortage of VSOs, and the propensity of some veterans to turn to lawyers to process their claims, at a fee that never ends.

Members of the SAVA committee queried one of the Lewistown veterans about the proposed fix and the committee was on the record of seeking further efforts to provide up to 10 additional VSO's and 3 additional Administrative Assistants (completing the effort to have an Administrative Assistant in each of the 10 VSO offices). Please understand, this discussion was very preliminary and may or may not result in legislation supporting the increase in VSO's and Administrative Assistants. But both Bill and I were pleased that our members were willing to travel to Helena to express their concerns about the care our veterans deserve. I encourage all Montana Legionnaires to do the same. You don't need to travel to Helena, you can just meet with your state Senator and Representative in your community.

The National American Legion Washington Conference, held in D.C. in February, was attended by Larry Dobbs, Duane Cunningham, Bill White, Christine Nelson, Karen Susag, and me. We met with Senator Daines, the staff of Senator Tester, and the staff of Representative's Zinke and

Rosendale. We shared the American Legion Legislative Agenda and our views on Montana veteran issues with each group. We were joined by the President of the MT Enlisted Association of the National Guard, Teresa Parker, who was attending the National Enlisted Association Legislative Forum during the same week. I serve as the Vice Chairman of the National Legislative Commission, representing the Montana Department, and participated in the Commission meetings during my stay. I believe that our visits with our Congressional members or staff, and our Committee/Commission meetings were very productive.

One thing I will repeat in this report, and will continue to harp on in the future, is the need for more members of the Montana Department to participate in our Congressional Outreach program. It is important that all our members subscribe to the national program called VoterVOICE. You can click on the link (votervoice.net/American Legion/home) and "Sign up for Alerts". While we have improved some, Montana is still near the bottom of the list of states contacting their congressional members concerning our national issues. As of the February report, for the year of 2023, we had only 196 responses, which was 2.689% of our membership, and we are 12th lowest in the nation.

Again, I ask you to become/remain engaged in the political process. Get to know who your state legislators are and contact them early and often. With our elections coming up this fall, you should be contacting all the candidates that will be on your ballot. Let them know your (our) needs, interests, and preferences. Talk with them about military and veteran issues and find out where they stand on those issues. Then, let your Montana Department know of the results of your engagement. Grassroots is the lifeblood of legislative efforts, both on the state and national level.

NATIONAL SECURITY Ken Simon

My National Security Report will not be as lengthy as those in the past due to the fact that the biggest threat we as a Nation suffer right now, is the influx of illegal immigrants coming across the Southern Border as well as being flown into our country by our own government.

The vast number of those crossing on our Southern Border that have NOT been apprehended or crossed at a secure border crossing have NOT been vetted or screened! PUBLIC AFFAIRS & PUBLICATIONS

Having served as the Chairman of the Public Relations and Publications Committee since last Summer, I respectfully submit the following report for the Belgrade Annual Convention at the end of June.

While Public Relations was part of my position title, my efforts in this last year were entirely focused on helping to prepare various editions of the Legionnaire for publication. While I stated in last year's report that I wanted to better help the organization and restructure, my contributions have entailed producing articles of interest for the quarterly newsletter and offering editorial reviews and modifications of various editions.

As I noted in last year's report, I thought we should thoroughly review past editions to determine the layout and composition of our quarterly communications. I began that process last year but did not completely finish it in order to draw up any solid conclusions. The main issue I noticed was not enough focus on the specific posts.

During this review and my assistance in reviewing and editing three editions, a couple other issues became more obvious, as follows:

- putting together these 20+ page quarterlies required quite a bit of time.
- · it was difficult to get timely reports and articles from across the department.
- \cdot since there was no single particular guide for people to use, standardizing writing styles, grammar use and punctuation took much time and effort; and
- · with the timed compilation of these quarterlies (every three months), a latency occurred in which, by the time a quarterly was published everything in it was old news.

When I agreed to come on to help produce the Quarterly Legionnaire, we had some conversations about increasing our digital presence. My understanding is that Department-level analyses and discussions have taken place, resulting in a decision to move from a quarterly hardcopy periodical to a monthly virtual publication.

I believe that conceptual change in format has merit for a couple reasons. First, it should save printing costs and the labor involved in soliciting, receiving, editing and in designing a hardcopy product. Second, it would help us get news and information to our Legionnaires across the state in a more-timely manner.

I understand that analyses done to validate the move to a fully digital format have driven this decision and concluded it would be more beneficial to the Department and the Legionnaires. I was told that the Veterans of Foreign Wars have already made that digital move but are still producing quarterlies. I believe our transitional effort will require some time, effort and further discussion. I suggest that we inform the Districts and Posts of this anticipated format and timing change as soon as possible.

I think digital IS the way of the future for Legion communications, however, I would like to ensure we're best capturing the rhythm and attributes of what our posts, districts, committees and department are contributing across the state for veterans, their families and our communities. To that end, I still believe our communications outreach moving forward should entail the following:

- \cdot a pro-active program of reaching out and maintaining contact with elements across the state to ensure enhanced coverage.
- · create a standardized reporting template to be used to collect stories, articles of interest and supporting digital photographs for publications; and
- \cdot a compilation and dissemination of some sort of style guide or primer to ensure everyone is writing to the same standards and format.

SON OF THE AMERICAN LEGION (S.A.L.) ADVISOR

At the 2023 Convention, the Detachment of Montana officers were retained for a 2nd year with John Meacham as Commander. Since there was no Fall Conference, the Detachment pushed all business to this year's convention. Therefore, below is a brief synopsis of Detachment business discussed at the 2023 Convention:

- · Reports by each Zone, Squadron (as in attendance), Detachment officers and NEC were made. In particular, coordination for attendance of the Fall Meetings throughout the state.
- · The budget was accepted and approved a proposal to include Detachment Executive Committee members to insurance program that the Legion Department Executive Committee is covered.
- · Adding more Squadrons to the Detachment discussed and brought to light that awareness needs to be coordinated between the organization team for the Squadron and their Legion Post Leadership.

 \cdot The Detachment ended up short for the year (95.76%) and for the second year in a row. We were short of the goal by 107 members on the 100% Target date. Just to point out, the overall percentage has improved after the target dates. So, the detachment is getting our membership, but the target dates are not being met.

The most concerning part of the discussion is that Post leadership needs to not only accept the establishing of a SAL Squadron, but also ensure that they have a Liaison/Advisor assigned to their Squadron. This is key to ensure their SAL program is a success and to do that, implement and maintain good communication between the SAL Squadron and Post Leadership.

The Detachment identified three SAL National Convention representatives for the 2023 National Convention as: Commander John Meacham, NEC Eddy White and SAL Member Lonny Johnson.

A few items brought forward from the SAL National Spring Meeting will be presented at the Detachment meeting at this convention. They are:

- · SAL PUFL Program This was proposed in the late 70's and was revived at the 2023 Fall SAL NEC meeting. The resolution is pending The American Legion Finance Committee review for fiscal impact
- · Flags for Heros Squadrons and Detachments can sign up there for their activities. I encourage Squadrons to sign up!
- · Centennial Committee is still looking for ideas from the Detachments and a contact to work with.
- · SAL National Newsletter is offered monthly now just need to register with Mylegion.org
- · Snapshots Of Service Due end of June (at this time). They added a video option this year. There are Squadrons that do this already, they just need to submit it.
- · Nationally, SAL membership is pushing closer and closer to 400,000 members. SAL is projected to surpass both the Legion and Aux combined in the next year, year and a half.
- · VE&E Brochure is being updated with current information and coordinated with the American Legion
- · Four Pillars program for Squadrons To qualify, the Squadron needs to is raise one dollar per member each for Operation Comfort Warriors (VA&R), the Child Welfare Foundation (Children & Youth) and your department's American Legion Boys State program (Americanism) and hold a blood drive (National Security).

Current Detachment Membership as reported by National, as of the 100% Target date and last report date of May 27th is 90.28%. We are just under where we were last year.

The 105% goal is still reachable by July 24th, 2024. We will need to renew/sign up 135 new members to make this targe. It is will within reach.

The Detachment of Montana is in a great position for 2024-2025 Membership year and I know the leadership has great confidence that the Detachment will continue to strongly support the Department of Montana, but their respective Posts and Post Auxiliaries.
