American Legion and Chris Nelson Department Auxiliary President, both of whom I am glad to call good friends. The


40 & 8 BBQ at the Airport was not only good food but very educational as we got to take our picture under Miss Montana and learn the history of her recent

And now on to National Convention in Milwaukee Wisconsin. Thirty-three yes 33 hours one way on a train. I hope I never have to ride another train in my life.





Highlights so far this year: With the assistance of American Legion National Headquarters and supporters such as Jeff Stoffer and Holly Sori, Montana Department, TAL, was able schedule two major exhibits: The Exhibits: The Flag of Our Nation and 1944 Veterans Readjustment Act known as the the GI Bill. These were on display at the Montana Military Museum and also the Flag of Our Nation at the  $103^{\rm rd}$  Department Convention.

The Judging will be accomplished in October 2023. Post entries are due at the Montana Department Convention, Lewistown, Montana at the start of the 2023 Department end of June.

The American Legion Officer's guide and Manual of Ceremonies contain much information about the history contest. Also, in that section of the Guide are "Capsule History of the American legion" and "Helpful Hints for District/County Historians." Please notify your Posts in your District of this readily available material. This information will also be sent out

through electronic means via the Montana American Legion website <a href="www.mtlegion.org">www.mtlegion.org</a> or by mail, as necessary. All entries will be judged and the first-place winners in either category (narrative or yearbook) will be certified, and I will forward them to National Historian for entry in the announced contest for that category. Keep in mind the requirements that must be met for the National Contest. And I refer you to the most current edition of the Officers Guide for the official rules of the 2022-2023 Legion year, or at the legion website <a href="www.legion.org">www.legion.org</a>.

## **DEPARTMENT ADJUTANT**

The last few month have brought a lot of activity; the first piece of news would be that Department has finally resettled back into the Headquarters space. After 10 months and 4 moves, Department has its home back, and while it is a bit smaller, the use of a conference room on site should be helpful.

The National Convention was held in Milwaukee in late August; by car, plane and even train, 37 Montana delegates attended Convention this year. Eight of us took the train to Milwaukee, the Amtrak experience wasn't too bad at all; the tickets were inexpensive and check in procedures, luggage rules and carry-on baggage were easier, and less stressful than flying. Really enjoyed the conversations with fellow Legionnaires and was even able to catch up on a little work. The ride was around 26 hours and dropped us off 4 blocks from the hotel. If the opportunity to take the train to Convention comes up again, I recommend giving it a try.

A lot of American Legon business was completed throughout the week and a new National Commander was installed as Vincent James Troiola became the American Legions 104<sup>th</sup> National Commander. Commander Troiola's theme as national commander is "V.E.T.S., Veterans, Education, Teamwork and Sponsor." Commander Troiola's initiative is the "Be the One" campaign designed to bring Veteran suicide awareness to the forefront of Veteran issues. The American Legion's new "Be The One" campaign aims to raise awareness about the veteran suicide rate and empower everyone to take the initiative to save the life of a veteran who is at risk.

There were 26 Resolutions passed at the 103<sup>rd</sup> National Convention; of them Montana had two out of 3 of its own resolutions pass. The resolutions were:

**Resolution No. 6:** Increase Cancer Screenings by the Department of Veterans Affairs Origin: Montana Submitted by: Convention Committee on Veterans Affairs & Rehabilitation (As Amended)

WHEREAS, Early detection of cancer improves the likelihood of surviving it; and

WHEREAS, Virtually 50,000 Department of Veterans Affairs (VA) enrolled veterans are diagnosed with cancer each year; and

WHEREAS, If VA enrolled veterans were a state in the U.S. it would rank 10th in the nation for cancer diagnoses; and

WHEREAS, Eight cancers were the most frequent among veterans in 2010: prostate, lung, colorectal, melanoma, kidney, bladder, liver and intrahepatic bile duct; and

WHEREAS, All veterans have a 40 percent increased rate of breast cancer; and

WHEREAS, "Beating cancer starts with knowing you have it" and "71% of cancer deaths are caused by cancers not commonly screened for"; now, therefore, be it

RESOLVED, By The American Legion in National Convention assembled in Milwaukee, Wisconsin, August 30, 31, September 1, 2022, That The American Legion urge the Department of Veterans Affairs to increase cancer screenings including novel screenings; and, be it finally

RESOLVED, That The American Legion urge the Department of Veterans Affairs to add liquid biopsies for cancer screening to annual physicals for all veterans with a preference on those with Food and Drug Administration approval.

**Resolution No. 4:** Energy Independence Origin: Montana Submitted by: Convention Committee on National Security (As Amended)

WHEREAS, The United States has fossil fuel (coal and oil) energy sources capable of sustaining a growing economy for at least 200 years; and

WHEREAS, Status of energy independence was recently achieved; and

WHEREAS, Our national energy capability exceeded the combined capability of the Middle East and Russia combined; and

WHEREAS, National policies were established to protect the world climate against climate change; and

WHEREAS, The climate change concerns resulted in actions to modify our national energy independence; and

WHEREAS, The surrender of national energy independence has resulted in our energy needs for both civil and military purposes dependent upon foreign, often unfriendly, sources; and

WHEREAS, Energy resources are a key component of our economy which in turn is directly related to military capability; now, therefore, be it

RESOLVED, By The American Legion in National Convention assembled in Milwaukee, Wisconsin, August 30, 31, September 1, 2022, That, The American Legion immediately contact the House and Senate Committees for National Defense, Energy, and Homeland

Security to advocate for renewal of efforts to attain and retain energy independence; and, be it finally

RESOLVED, That the National Executive Committee instruct the National Security Commission to call for immediate advocacy efforts at the department level seeking support from elected officials, in a manner similar to the previous efforts to encourage protection of our Flag.

There was one other resolution that came from Montana regarding the National Defense budget not being dependent on a federal Continuing Resolution when lawmakers cannot agree on a Federal budget. This resolution was tabled because of its similarity to a previous passed resolution.

Fall brings Fall District meetings and a National Department visit from the new National Commander. The first few weekends of District meetings went smoothly with the new start time and agenda, most meetings were wrapping up just prior to lunch and ran more smoothly and efficiently with the District business being completed prior to any guest speakers. The only snafu to our plans was District 4, when they had a COVID outbreak in Libby 2 days prior to the event and we had to improvise with an impromptu Zoom meeting. There were some technical issues, but once folks figured out the importance of turning their microphone on and off, it went just fine and could be an option in the future if gas and hotel prices continue to rise.

Commander Troiola's visit to Montana was a whirlwind but successful event. The Commander and his Aide arrived in Helena around 10:30 Thursday night and after a quick night's sleep we attended a POW/MIA Remembrance Event in Helena Friday morning. Commander Troiola gave a poignant speech about the day and its true meaning. Upon completion of the reading of the names of Montana's remaining POW/MIA brethren; the day continued with a stop at the State Capital and a visit with Governor Gianforte's Policy Director Glenn Oppel to discuss Montana Veteran specific issues. It was a lively, informative and effective discussion.

After a quick trip through the Montana Historical Society and the Nutter/Shore Trophy Room, it was off to the Veterans Hospital at Fort Harrison for a tour of the facility and a quick lunch with Veterans in the VA canteen. We wrapped up at the VA and then we headed to Three Forks, Montana where Post 93 and Commander Don Carlson hosted a tailgating event prior to Friday nights Class B football game against Whitehall. With around 35 Legion Caps in attendance the National Commander acted as the Honorary Captain and conducted the coin toss. The officiating crew for the game were all Veteran's and Legionnaires. Both the Whitehall and Three Forks fans, school administrators and players thought it was a big deal to have a distinguished guest in attendance; and made the event very memorable. We do need to work on the whole American Legion recognition thing though; one of the captains

asked me after the Commander departed the field if he was a General; I of course responded with a simple "No son, he had bigger dreams than that, he is an Admiral".

Saturday morning, we took a trip to Dutton, Montana, and the Fall District 8 meeting. The District held a great meeting and the Commander enjoyed meeting the Legionnaires from that area. We stopped in Craig at Izzac's for a wonderful dinner that night and then put the National Commander on a 6am flight to Kansas. Since the convention, the Commander has been on the road and still had an additional 53 days of travels before he returns to Maine for a well-deserved break. I would like to thank everyone who made the Commanders visit a success. He truly enjoyed the stop.

A quick trip to Indianapolis and Fall Conference was next on the agenda, where National pushed many of the same initiatives that Department has been attempting to bring forward; streamlined District meetings; using technology to enhance and replace unnecessary face to face meetings; and the need to innovate and find ways to bring the Iraq/Afghanistan War Veteran into the American Legion Family. I will end with a quote from the National Judge Advocate that resonated at Fall Conference because we have all heard it before; "We've done it this way for years.....". It is never a proper response; it's simply admitting you've done something wrong for years and it doesn't make it better; in fact it calls into question even more things."

I would like to thank you all for your service in the armed forces and for your membership in the American Legion! My name is Candy Hering and I am the new Department Service Officer for the American Legion Department of Montana. I served overseas in the Marine Corps from 2002 to 2007, and I have been a Veteran's Service Officer with the Montana Veteran's Affairs Division in the Great Falls field office for eight and a half years. I am very thankful for everything these two organizations have done for our veterans, and I thank you all for allowing me to represent you all and our great state!

Since Convention the biggest thing to happen was the signing of the largest VA benefit expansion ever, the PACT (Promise to Address Comprehensive Toxins) ACT of 2022. There is a comprehensive list of newly added presumptive conditions, service locations and dates, and healthcare eligibilities that can be found at the VA.GOV website. In short, here are a few of the highlights:

If you served in VIETNAM, THAILAND, LOAS, CAMBODIA, GUAM, AMERICAN SAMOA, or JOHNSON ATOLL (during specified dates listed on the website) you are now PRESUMED to be exposed to AGENT ORANGE and now qualify for the presumptive conditions associated with that toxin to now include HYPERTENSION and MONOCLONAL GAMMOPATHY OF UNDETERMINED SIGNIFICANCE. All the previous AO presumptive conditions remain.

If you participated in the cleanup of ENEWETAK ATOLL, or B-52 bombers carrying nuclear weapons near PALOMARES SPAIN and THULE AFB GREENLAND, you are presumed exposed to radiation.

If you served in the Gulf War (Bahrain, Iraq, Kuwait, Oman, Qatar, Saudi Arabia, Somalia, United Arab Emirates, or the airspace above these locations) or Post 9/11 (AFGHANISTAN, DJBOUTI, EGYPT, JORDAN, LEBANON, SYRIA, UZBEKISTAN, YEMEN or the airspace above) and have any form of BRAIN CANCER, GASTROINTESTINAL CANCER, GLIOBLASTOMA, HEAD CANCER, KIDNEY CANCER, LYMPHATIC CANCER, LYMPHOMA, MELANOMA, NECK CANCER, PANCREATIC CANCER, REPRODUCTIVE CANCER OR RESPIRATORY CANCER, you are now in the presumptive category for service connection.

If you have served in the Gulf War or Post 9/11 and been diagnosed with ASTHMA (diagnosed after service), CHRONIC BRONCHITIS, COPD, CHRONIC RHINITIS, CHRONIC

SINUSITIS, CONSTRICTIVE BRONCHIOLITIS or OBLITERATIVE BRONCHITIS, EMPHYSEMA, GRANULOMATOUS DISEASE, INTERSTITIAL LUNG DISEASE, PLEURITIS, PULMONARY FIBROSIS or SARCOIDOSIS, your illness is now presumptive.

## If you think you may be eligible, please contact the field office nearest you right away.

Belgrade: 406-551-7855, Billings: 406-248-8579, Butte: 406-533-0910, Great Falls: 406-452-2265, Havre: 406-265-4225, Helena: 406-495-2080, Kalispell: 406-755-3795, Miles City: 406-232-1203, and Missoula: 406-542-2501

Even if you have filed a claim or tried to enroll in VA healthcare before and were denied, the law has changed now, and you <u>may</u> be eligible.



#### Lessons Learned

- 1. Registration fees need to increase by \$5. Reason: Hotel costs have gone up and we have to adjust.
- 2. Registration on convention days need to increase another \$5. Reason: Takes member away from participating in meetings to oblige late registrations.
- 3. Have price list for all (TAL, ALA, SAL, Riders, etc.) so they know the cost if they request the items (projectors, monitors, etc..). Reason: Convention host is not unlimited in funding the convention. They need to make some monies, especially any donated funds which must go to programs.
- 4. Registration form need to be clear and specific. Reason: Some participants still do not understand that Past Dept Cmdr. BK, Incoming Pres Lunch, and Past Pres Lunch are closed meals and are turned away with no refund.
- 5. Registration forms need to contain e-mail address of person registering and number of days for response from host post upon receipt. Reason: Cheaper and faster to verify with people what they requested and so people registering when they should receive a response. (Could do this by phone) Had one couple's registration form and check disappear into the USPS void. We lost money on meals, and they lost meals.
- 6. Registration form needs to state two people max, if more people use multiple forms. Reason: Had forms with 3 or more people and meals did not match number. I had to call to clarify who was going to what meals since we were putting meal tickets on name tags.
- 7. Keep 3 ringed binders with copies of registration forms and checks. Reason: A few people started to argue that they had purchased additional meals and copies put a quick stop to their arguments.
- 8. Make it clear to hotel and Legion Family that hotel room rates are only good to certain dates. Legion Family also needs to understand that if they request certain bed accommodation that they may be out of Kings and only Queens are left. Hotel staff don't always explain the reason for no rooms available.
- 9. Double check spreadsheet registration list with name tags.
- 10. If using name tags for meal tickets use better colors so letters can be seen in box. Recommend dark colors with white lettering.
- 11. Have Registration in a controlled area with limited access. We were able to lock the room and leave name tags, registration list, and computer for peace of mind.
- 12. Have one entrance for meals with people checking meal tickets to ensure no one cheats. Also have any bars in the room with the meals.
- 13. Personal contact (email or phone) when registration received and entered. Found multiple mistakes on meals and math. We did collect about \$100 from math errors and saved a few people of signing up for meals that were closed to public.

- 14. Get all the donations you can, it will save you big time in profits.
- 15. Start asking businesses for sales/donations 1 year in advance. Most businesses plan for limited funds 1 year prior to their business year.

Ramon's, thank you letter to Post No. 2 (the post took up a collection to help) reads, "Thank you for your generosity and thoughtfulness during our time of difficulty. As we work on settling into our new normal, I look back and think of the support we received and just how much encouragement it provided my family and me.

Losing our home was difficult to say the least. We were at a loss for where to start after the disaster. Your assistance helped provide us with the stability to focus on rebuilding, and the comfort of knowing that this community stands together in times of need.

I am proud and thankful to be part of an organization whose members would come together to help one of their own the way you all did for me. I do not take this assistance for granted. I will always remember that you thought of us and then acted to help when we were in need."

#### LETTER OF INTRODUCTION

Initially, as the FM program representative from Post 119 in Yellowstone County, I was approached by Jim Kelly to see whether I would be interested in being considered for his position as he was retiring from it. I received a confirmation of appointment on 27 June of this year.

Although I would have liked to personally introduce myself at the Fall Conference, prior commitments prevent me from doing so.

I have spent the time since my appointment pouring over Jim's extensive information regarding the program and am still attempting to absorb much of the data.

My other priority has been to reach out to the American Legion posts across Montana. I have attempted to contact as many post commanders/fatality marker representatives as possible in the time since my appointment.

I can only say that I still have much to learn and am humbled at attempting to fill the shoes of such an extraordinary man as Jim Kelly.

### **CORRESPONDENCE PLUSSES AND MINUSES**

Since assuming the chair, I have had limited success in positive contacts with the posts across Montana. To date, only 24 posts have responded to my emails. A  $25^{th}$  post responded that they do not have a program in place. Although I have sent out several sets of email requests over the past months, the results are somewhat disappointing as I have several requests for fatality markers without a representative from those particular areas

The positive feedback that I have received has been uplifting. Several of the posts have demonstrated very positive successes. Along with that, there has been an out-pouring of generosity, sharing materials to those who are short or out of supply. With great individuals, such as these, the program with continue to flourish.

A final point about correspondence. I am continuing to follow Jim Kelly's lead by alerting all posts on a bi-weekly basis ( $1^{st}$  and  $15^{th}$  of the month) of fatalities occurring in Montana. This has been received well.

#### **HELP WANTED!**

I would have personally liked to reach out at this conference to appeal to all posts to create a fatality marker program. I will be attending the department meeting in Fromberg, Montana, and will be pushing in District 11. If the other 10 districts will commit to do the same, maybe the program can expand as needed.

#### **OTHER GOALS**

- 1. I need to reach out to various agencies, such as the MHP, DOT, etc., for their assistance.
- 2. Newspaper coverage in the end, the best free advertising is showing what you've got. I need to do so, and so do the other posts.
- 3. Co-ordination of resources let other posts in your area know if you have a treasure trove of posts, crosses, etc.
- 4. Clean up the markers. I see many markers across the state, while I travel, that need to either get cleaned up or denuded of flowers and other inappropriate devices that are attached to fatality markers. Some just need a shot of fresh paint, others, a lot more. Markers that are left unattended are an eyesore and detract from the program. Sometimes a little sensitivity is necessary, just use common sense.
- 5. Communicate, communicate! I have bared my soul to all members by leaving my email, cell phone, and private phone numbers. No excuse to not contact me with a question or a suggestion.
- 6. A better, more data-driven report next Fall. Not an excuse, but I fell into this in June, and don't have as complete a data flow as I would like.

## **INSURANCE DIRECTOR**

## **Duane Cunningham**

Legion Insurance Trust or "Legion Care" recently lost one of its biggest supporters and a true friend of the American Legion when Howard Bender the program manager passed away unexpectedly a few short weeks before National Convention. His loss continues to be felt throughout the program. Rest in Peace Howard.

The interim Program Manager is Christina Garibay and we have not gotten much information or guidance regarding LIT from her as this is an additional duty. Because of this I have very little to report on; we have received no new disbursements since the last report in June; our next anticipated disbursements will be in April 2023.

We continue to show a decline in policy holders; therefore, we will see a decline in revenue from the insurance programs. The free Accidental Death and Dismemberment Insurance called Legion Care; is insurance for all Legionnaires. SAL and Auxiliary members are also eligible for the AD & D free insurance.

#### **LEGISLATIVE**

As we close in on the upcoming November election, please engage your local, state and fede ral candidates to let them know and understand our veteran needs and how your American Legion plays a great part in securing those needs. This report will address our Legion effort s directed toward the 2023 State Legislative Session. Additionally, I will report some activities of our Legislative Liaisons and finally, I will share with you information concerning our C ongressional and Governor Liaison duties and the need for another liaison for the newly for med Congressional District #1 (Western district).

The Montana 68<sup>th</sup> Legislative Session will convene Monday, January 8<sup>th</sup>, 2023. It is imperative that I repeat my June Convention announcement advising our Department membership that this will be the last session I will represent the American Legion as their lobbyist. I will remain as the Legislative Committee Chairman and Vice Chairman of the National Legislative Commission, with the approval of the current Department Commander and future Commanders who may ask me to serve. Again, it has been my pleasure to represent our membership at Helena for many years and I appreciate the opportunity to do so one last time.

The priority legislative effort for this session will be seeking a state income tax exemption f or military pensions. This has been our primary legislative effort for at least 8 sessions (16 y ears). We have come close a couple of times and hope we can put the ball over the goal line t his time. It is important to note when you are talking to your State Representative and Sena tor that this is not a bill to 'thank us for our service', this is an economic development bill de signed to entice military retirees to come to Montana, start a 2<sup>nd</sup> career or a new business a nd help solve our employment needs.

Our second effort is to authorize the update of the 2006 Montana Veterans Long Term Healt h Care Study. The 2006 study was very valuable in many ways, including providing great fac tual justification for the third veteran's home. This effort will include funding for the study, expanding the study to include projected veteran cemetery needs, and establishing a recurr ing study every 10 years following the U.S. Census. The data gathered will be used for many veteran initiatives during the next decade.

As usual, we will be engaged with several Department of Military Affairs and Montana Veter an Affairs Division efforts, primarily focused on funding for the upcoming biennium. We ask

that all Montana Legionnaires get with their legislators and let them know you want them to support our veteran and military efforts.

Last month, during our National Commander Troiola's visit, we had the opportunity to meet with Glenn Oppel, Policy Director for Governor Gianforte. Bill White, our Governor Liaison d id an excellent job of coordinating the meeting and Commander Troiola remarked that he th ought Montana may be the only state with a Department position of Governor Liaison. That was a great compliment, and we had a very productive meeting.

Another of our Liaison's made headlines with our National Legislative Team and I want to personally thank him for his outstanding work. Here is the story:

For nearly a half-century, American Legion members have served on the organization's National Legislative Council. The council is a 535-member group designated to serve as direct liaisons to every member of the U.S. Congress.

With the midterm elections a month away, The American Legion is beginning the process of rebuilding its National Legislative Council for the 118<sup>th</sup> Congress. Interested candidates may submit their applications for their departments' consideration. Legionnaires are encouraged to submit their applications before the Nov. 8 election.

Approved in Resolution 45 by the National Executive Committee in 1975, the council's aim is to "propagate an interest in a furtherance of the legislative goals of The American Legion and to serve as a medium for disseminating information and developing an understanding with our elected representatives.".

Members of the Legislative Council are relied on to reinforce The American Legion's overall legislative efforts, particularly at times when immediate and personal contact with lawmakers is necessary – typically referred to as "grassroots contact."

They routinely email, write, and/or call lawmakers and their staff regarding veterans legislation. Members should strive to visit the lawmaker's local office at least once per month to discuss issues that will directly impact The American Legion's legislative goals.

#### Members work to:

- Promote an interest in and a furtherance of The American Legion's legislative goals.
- Serve as a liaison for disseminating information to elected lawmakers and staff.
- Develop and maintain strong working relationships with elected lawmakers and staff.
- Disseminate information on proposed and adopted veterans legislation to posts and members of the Legion within the congressional district.

## **Position requirements include:**

- Current Legionnaire willing to work in concert with The American Legion to achieve its legislative goals.
- Experience working with public relations and/or elected officials is a plus.
- Excellent verbal and written communications skills are necessary.
- Comfortable speaking and making presentations to larger groups.
- Ability to use social media.
- Ability to represent The American Legion and veterans to various groups and organizations.
- Ownership of an email account and internet access is required.
- Personal relationship with the member of Congress to whom they are assigned, senior staffers in their office, or willingness and ability to establish relationships with them.

Again, I ask you to become/remain engaged in the political process. Get to know who your state legislators are and contact them early and often. Let them know your (our) needs, interests, and preferences. Talk with them about military and veteran issues and find out where they stand on those issues. Then, let your Montana Department know of the results of your engagement. Grassroots is the lifeblood of legislative efforts, both on the state and national level.

#### NATIONAL SECURITY

#### **Ken Simon**

Last year I discussed several world events that were of concern in regard to National Security and to date at least two of those are still in the forefront. It appears that the Taiwan situation is still one that bears watching, however the Chinese have not really pushed any more than they already had over the past year! And the other event worth watching and that the United States as well as the NATO countries are watching is the Ukrainian and Russian conflict ongoing in the Ukraine!

One new event that really has been present for quite some time is the North Korean regimes leader who has had his military firing missiles either into the waters between Japan and South Korea or into the sea on the eastern side of Japan! This was cause for concern to shipping and any vessel that happened to be in the area when the missiles impacted into the sea! The North Korean leader has indicated that these missile launches are in connection with the American and South Korean joint military exercises being conducted.

I will briefly discuss the Ukrainian / Russian war and what the NATO countries and other Western Nations are doing. As the conflict grew and both sides traded ground, the U.S. and the rest of the NATO countries began to provide military hardware as requested by the Ukrainian government and armed forces. This assistance has helped to tip the balance somewhat to the Ukrainian armed forces and they have retaken ground that Russian forces held after the invasion. Due to the Ukrainian militaries resolve and ability to overcome some of the obstacles, they have defeated a superior force and forced them to retreat leaving military equipment and soldiers behind. In some cases, Russian soldiers surrendered not only themselves but their arms, ammunition, and equipment. This has not come without a cost to the Ukraine in the loss of soldiers and equipment but still their determination and

resolve have overcome those shortfalls. In all of this, the Russian military has committed atrocities against the civilian population in the Ukraine as has the Russian use of missiles and artillery being launched into civilian sections of towns and villages. What the outcome of this war will be is anybody's guess although one thing is certain. The Russian military did NOT roll in and over the Ukrainian military as Putin had planned or thought they would! If the Ukrainian military pulls off a defeat of the Russian army, it will be the biggest loss that Russia has ever suffered! Only time will tell.

When we think about National Security, we need to make sure that we look at what events, trends, or threats could be of dire consequence to our nation if left unchecked. I believe that the ongoing situation on our Nations Southern Border is a threat to our National Security because of the fact that so many illegal immigrants are crossing in so many different locations, that our Border Patrol is unable to cover and apprehend all of them. Bare in mind that there is a Law concerning foreign nationals who want to enter our country. They first must present themselves at a Marked and Manned Border Crossing! Once there they are screened for identification, country of origin, and why they want to enter. I know that I discussed this in last year's National Security Report, however I felt it needed to be brought up due to the number of illegals that have entered since then! Of the thousands that have entered, we as a nation have absolutely no idea who they are, where they came from, and what their true intent is because they crossed illegally into the United States! Think about the consequences that we as a nation could suffer because of the Open Border concept that has been allowed to go on. As a result of the types of people that very well could here now, we could have something impact our country from within than what occurred on 9/11! One of the really glaring consequences that has reared its head is the homelessness that is occurring across our country and there seems to be no end in sight to it. What about the strain on our law enforcement, community infrastructure, Emergency services, hospitals, clinics, and schools. Who pays for the welfare of the illegal immigrants? What impact will that have on taxes in the communities who have all these homeless folks? While we are a Nation of immigrants, the vast majority of them came here legally and assimilated into and became productive members of society!

One other glaring situation we are facing is the rising cost of living, which includes food, clothing, housing, fuel, rent, mortgages, automobiles, transportation, and other essential services. Our government is concentrating on internal problems and world situations instead of the citizens of our country. What was costing less more than two years ago now cost double and is still rising which in turn creates stress. That stress is boiling over in the form of crime, which is on the rise in all of our major cities across this country. Violence is causing the fabric of our society to begin a downward spiral. People no longer trust their neighbors, city, county, or national government to take care of them. Drugs are running rampant all across the country and is being brought in and distributed mainly from the unsecure southern border. And to top it all off, we are in a recession, and no one seems to know when it will end. More stress! All of this is part of National Security.

One thing that is disturbing is how many of our military service members are getting out which in turn is dropping the number of soldiers, sailors, airmen, marines, and coast guard personnel left on Active Duty. And this is not only the Active side of the house, but the National Guard and Reserve as well. From: The Heritage Foundation, Heritage Foundation President Kay C. James Annual Index downgrades the Air Force to "weak," rates Space Force as "weak," Navy trending in the wrong direction, though improvements have been made by the Marine Corps and Army. According to a release from The Heritage Foundation's Center for National Defense, the 2022 Index of U.S. Military Strength on Wednesday in conjunction with a keynote address from U.S. Rep. Mike Rogers, ranking member of the House Armed Services Committee. The report exposes the state of the U.S. military and its level of ability to defend American interests. The 2022 Index comes at a critical time as the U.S. military looks toward lean years of funding under the current administration and rising challenges to U.S. military readiness. I read an article recently that discussed the recruiting of young men and women for the Armed Forces and what I read was quite alarming. In researching further, I found also found this in an article from the Heritage Foundation. The military depends on a constant flow of volunteers every year. According to 2017 Pentagon data, 71 per cent of young Americans between 17 and 24 are ineligible to serve in the United States military. Put another way: Over 24 million of the 34 million people of that age group cannot join the armed forces - - even if they wanted to. This is an alarming situation that threatens the country's fundamental national security. If only 29 per cent of the nation's young adults are qualified to serve, and if the trend continues, it is inevitable that the U.S. military will suffer from a lack of manpower. A manpower shortage in the United States Armed Forces directly compromises National Security. More recently I read an article that indicated only 25 per cent of the young adults between 17 and 24 are eligible to serve. I checked a site from the Selective Service and found this information: Vietnam War from Aug 1964 to Feb 1973 there were 1,857,304 inductees into the military. Between 1960 and 1968 the number of inductees fluctuated from over 325,000 in 1960 down to around 162,746. In 1968 when I entered military service there were 296,406, compared to only 646 in 1973, when the last man was inducted under Selective Service!

The last aspect I want to mention is very important and that is the Defense Budget. Looking at what is going on with the Ukrainian situation, the present Administration is sending billions of dollars of American Military hardware to support their war effort. Much of what is being provided is resulting in the reduction of military supplies that our nations Armed Forces would need to provide and replenish the needs as a result of combat losses! That includes ammunition for the artillery and missile units, which may take longer to restock due to the lag in being able to obtain components from a foreign supplier and then to produce the finished product. The needs of our military are not being met as times and situations change with regard to technology. The Military Defense Budget of 2022 article by Jim Garamone of DOD News, where Army Gen Mark A. Milley, chairman of the Joint Chiefs of Staff told the Senate Armed Services Committee that the fiscal year 2022 budget request strikes a balance between readiness today future modernization. and

The \$715 billion request preserves present readiness, the general said, but it's also a down payment on future readiness. Gen Milley said, and I quote: "It is now that we must set ourselves on a path to modernize the Joint Force and this budget contributes to doing that!" Unquote.

I would like to leave you with this with regard to our Nations National Security. Are you comfortable with the state of our nation in light of what is occurring within the borders of our country? Do you believe that a change needs to take place in one or several areas to change the posture of National Security in the United States? Do you feel more or less safe and secure in your community, State, and Nation?

Several Detachment Leaders attended registration day for The American Legion Boys State that was hosted at Fort Harrison in June. available to ALL American Legion Family members. The Post/SAL Adjutant or Aux Secretary just needs to submit the form to the Detachment with the qualifying information.

The Detachment of Montana established new leadership for the 2022-2023 Year. Officers selected were Commander: John Meacham, Vice Commander: Andy Rice (retained), South Central Zone Commander: Dan Smart, Eastern Zone Commander: Joe Yeoman, NEC: Eddy White and Alt-NEC: Larry Steele. Past Commander David Driver conducted the proceedings. I was fulfilling the Detachment Adjutant and have stepped down to focus on NEC duties. Jed Damson has accepted the position as Detachment Adjutant.

We discussed the issue of formalizing Districts in the Detachment. Some clarity was needed regarding establishing them. ### **SHOOTING SPORTS**

Since my report to the Department Convention, not much has happened concerning the Junior Shooting Sports program. As I reported in June, the Department of Montana has at various times had twenty-seven posts that participated in this program. Some sponsored more than one team or individual competitor. In 2019 we had eight posts participate in 2020 only six and in 2021 only four. In the 2021-2022 matches we only had three. There would have been four, but one team waited till the closing day of registration to send it in electronically. It did not arrive at National until after the close of business, so it was not accepted. There have been a number of changes in the registration process, such as a shorter time frame to register, an updated online only registration process and a credit card only option for payment all of which may explain some of those who did not participate in recent years. In addition, the year before last year at least one sponsored team did not complete in time the Risk Management requirements required by the Protecting Young Victims from

Sexual Abuse and Safe Sport Authorization Act of 2017 (Public Law 115-126) which was signed into law in February 2018.

The 2021-2022 competition did produce something I have not seen before. One club, the Gallatin Valley Sharpshooters (Manhattan Post 87) swept the entire competition. They were Montana Team Champions in both the "Sporter" and "Precision" disciplines and a member of each disciplines team won the title of Individual State Champion. I've never heard of such a complete sweep of the awards by an individual team.

The winners were Nicole Berger, Individual State Champion in Sporter discipline and Alison Sutherlin, Individual State Champion in Precision discipline. The members of the State Team Champions in Sporter are Nicole Berger, Natalie Samson, Marlie Sampson and Evan Lubick. The members of the Team Champions in Precision are Allison Sutherlin, Paige Hildebrandt, Ethan Bates and Mariah McPhee. In addition, Allison Sutherlin placed in the top fifteen in the nation in Precision and was selected to compete in the National Championships in Colorado Springs last summer. I do not know where she finished overall, as the website at National only shows the first eight places. But making it to that level is a significant achievement.

I still need to get to the posts to award the medals and certificates. We did not receive the medals from National until the end of June and I have been trying to get something set up at the Posts involved. I was supposed to be at St Regis this evening (19 Oct), but the Posts called to cancel as the coach of the team could only locate one of the team members. This is my highest priority at this time.

#### **VETERANS AFFAIRS & REHABILITATION**

The commission met on Saturday the 27<sup>th</sup> of August and 28<sup>th</sup> 0f August 2022 we had speakers the first day that included Dr. Linda Torres who spoke of Veterans Health care, Rural Health Care and Telehealth and VA Video Connect. There are some interesting points that she brought out and they included the following.

8% of women Veterans use VA Video Connect

Telehealth has increased 3000%

Veterans are not charged data if they use VA Video Connect it is supported by three (3 ) major carriers, this still doesn't address those without computers, smart phones or those not computer savvy

We were told to let people (Veterans) know you want some service over broadband. The provider can arrange to get you a tablet or a free internet service provider.

Cancer care was another big item covered on Saturday and these big facts were given us:

Veterans diagnosed with cancer is approximated at 43,000 per year and VA is the number one (1) Cancer researcher with the goal to reduce caner depths by 50% in the next 25 years

Dr. Torres put up another slide that talked about the Telehealth ATLAS Program which is still in a pilot program which Montana is part of. I was noted that the pilot program in Eureka Montana has provided no accurate data and more research is being done as to why.

The next speaker was a Mr. Robert Burke a VBA spokesman who spoke about the hiring of an additional 5000 by the end of 2022 and an additional 3000 in 2023, under the PAT Act to adjudicate claims. The VBA is expecting that many new claims to be in the system.

Under the PACT ACT's new presumptive. We were asked and then told to tell our fellow Veterans that we **RECOMMEND FILING WITH YOUR VSO NOW AND DO NOT WAIT UNTIL 1 January 2023** 

Claims will begin to be adjudicated beginning 1 January 2023. Go to VA.gov/PACT for more information. Surviving spruces, children up 23 can apply for survivor benefits

VBA has also reinstituted mandatory overtime beginning on 1 September 2022. There are still 170,000 claims pending.

Automation, things may be missed human hands will still need to be involved, Collecting evidence using automation to find evidence key words for more than one condition at a time

Work with VSOs to file burial benefits online-can be granted within minutes It was emphasized again get this word out

Legacy appeals 28,512 still pending Working on Caregiver Programs, Best Practices, and Adjudication.

The afternoon secession on Saturday was a breakout secession and Ms. Kate Hahn went to the VBA and I did the VHA secession

Under the breakout secession for the VBA Mr. John Detty that during the Covid shut down exams exploded to 300,000 as of March 21, 2022. Claims were still moving. At this time there are 170,000 claims in the queue at this time and Nothing is guaranteed at this point other than keep the claims moving.

Brown Water Navy to be done by October?????

In the VHA break out secession Dr. Torres again talked on two items National Standards Practice. This is criteria for personnel treating Veterans across state line is simplified and standardized which the American Legion has not taken a stand on more information needed and telehealth

Before adjourning for the day the American Legion legislative staff came and talked to us about all the adds about Camp Lejeune and the legion is working on criteria for veterans because there is so much information out there **They recommends that check your sources carefully and make sure that by filing with one of the law firms that you do not lose benefits.** 

The VA&R committee finished meeting on 28 August 2022. The final order of business included reviewing total of 19 Resolutions from three different sub committees Veterans Benefits Administration, Veterans Health Administration and National Cemetery of the resolutions for all three sub committees all except one (1) were either sent back or rejected the one that passed with flying colors that the one submitted by the Department of Montana by Elizabeth Cook concerning an additional test for cancer screening.

The Montana Department's participation in The American Legion's Homeless Veterans Program is now moving into its fifteenth year. Lowell Long, 2022-23 Montana Department Commander, re-appointed me as the Coordinator of the Program as the as the Homeless Veterans Coordinator at the 2022 Department effective July 2022. I respectfully submit the following report of the record to date.

Montana Statistics Related to Homeless Veterans is as follows:

Last reported 2021-Of the 89,275 (down nearly 3,000 previous reporting) veterans recognized and recorded by the VA as being in Montana, 70,333 are indicated as wartime veterans. Breakdown by era is: Gulf War- 35,651; Vietnam- 29,815; Korea-5,485; WW II-1,559. Peacetime veterans' number 18,943. The ratio of gender is Female veterans 8,906 and Male veterans 80,367. Comment: It is estimated that based on averaging 2.5 members per veteran's household that the total veterans' population including family members is at 223,190+- or nearly 1/4 of the total population of Montana.

National Statistics indicate that up to 3.8% of Montana's population of veterans is at risk or homeless. The definition of homeless as defined by United States Department of Housing and Urban Development (HUD) is, "Without and abode or home, living with family or relative because they cannot afford or qualify for a home residence, or living in an institutional setting because they cannot qualify or are financially unable to rent or own a home."

In the latest Montana Homeless Survey conducted in January 2021 of the total Homeless population in Montana was surveyed at 1,545 Total Household experiencing homelessness is 167 person respondents of which 165 Veterans were identified as to the as to being homeless. This indicates that homelessness among

Montana veterans was up 10.7% of the total homeless of Montana based on the Survey similar to the results from the previous year, This includes incomplete information on rural veterans' homelessness. The 2022 PIT is being processed at will be available later this year.

The following information was provided for the January 2021 Point in Time Survey by Housing & Urban Development conducted in January 2021. These reflect the collection effort based in cities and towns broken into Districts by Housing and Urban Development (HUD). These districts do not emulate Montana Department /American Legion Districts as currently configured. HUD District 1,2,3-Eastern Montana; District 4- Havre; District 5- Great Falls; District 6- Lewistown; District 7- Billings; District 8- Helena; District 9- Bozeman; District 10- Kalispell; District 11- Missoula; and District 12-Butte. **Survey areas did not totally encompass Montana rural areas**. The thing to take away from this is that Homelessness is still present and is a problem we must address at Post level and above:

### Recommendations for 2022-2023:

- 1. That the Montana Department of the American Legion continue to develop and conduct its Homeless Veterans strategy in coordination with the National Economics Division of The American Legion, the Veterans Administration of Montana, Federal Housing and Urban Development, the Montana Department of Health and Human Services and the many local service organizations who dedicate resources to reduce and eliminate homelessness in Montana.
- 2. That the Department of Montana of the American Legion strive to establish volunteer homeless Veteran's coordinators at Post, District and, Zone levels as necessary to interface with the Department on issues and offer solutions of Veterans homelessness. In lieu of dedicated resources the responsibility falls to the post, district, and zone commander by default.
- 3. That the Department of Montana of the American Legion supports the various Homeless Veterans Stand downs scheduled throughout Montana Some of the current Stand downs should be classified a veterans' resource program rather than a full stand down. Veteran related events have been previously identified as being in Plains, Helena, Missoula, Dillon, Miles City, and Libby, and on the High line of Montana with Havre, Montana as the hub.
- 4. That those American Legion Posts conducting a Stand down should coordinate and apply utilizing VA <u>Stand Down Notice of Proposed Event Form</u> available online and complete the VA <u>Stand Down After Action Report</u> available online at the National Coalition for Homeless Veterans. The Community Living Center in Miles City reopened for patients on 6 September 2022. They currently have four residents. I talked to the head nurse earlier this month and she filled me in on several topics. First item discussed was access to the Living Center. Visitors may come through the back entrance of the hospital where they will be required to sanitize their hands and to wear a mask while in the center. There is no limit to how many visitors may visit one patient. She also informed me that the new Activities Director was Ann Peterson. I informed the nurse that if she could ask Ann to call me at her earliest convenience to discuss the monetary budget that Custer Post #5 has set aside for the Living Center. As of this writing I have not heard back from the Activities Director.

The nurse informed me that they are currently working on activities for the residents, but nothing has been implemented as of yet. As soon as I here from the Activities Director, I will let her know that Custer Post #5 will budget \$300 to \$500 dollars for the Living Center. This money may be used as needed for essentials for the residents; sweats, coffee, prizes for bingo, and transportation tickets for the residents to be able to travel to doctor

appointments. The monies will be allocated at our Post #5 monthly meeting in January for calendar year 2023.
