I would like to say Thank You to all of you who venture to the East Side of our Great State to attend the Department Convention. It was really good to see so many of you there and sincerely hope that you had an enjoyable visit and found something to see and or do while you were there. Several of you made comments to me about the "windshield time" you had on your journey to Glasgow and that you understood what my drive from here to wherever I go entailed, especially the trips to Helena, Missoula, or Polson. That drive never gets boring or tiresome for me because I see the beauty in our state during those drives and get to meet a lot of people along the way. And I have made the drive many times before as a member of the Montana National Guards  $163^{\rm rd}$  Armored Cavalry Regiment. Again, Thank You to all who ventured to Glasgow and made the Convention a Really Good one.

July 4<sup>th</sup>, I attended the Flag ceremony at the Vets Club parking lot done by the Legion and VFW, as well as the Parade at noon and the Dedication of the Veteran's Memorial in Plentywood along with VFW Department Commander Lonnie Johnson, Post Commander Paul McKay, members of the Montana Highway Patrol, Customs and Border Protection Border Patrol, Sheridan Country Sheriff's Officers, Plentywood and Rural Fire Departments, EMS and Sons of the American Legion. The Veteran's Memorial was completed through a fund drive and also some donation work from various organizations.

On July 13<sup>th,</sup> I attended the funeral for Past Department Commander Art Sell in Big Timber. Art was a member of Post 19 and as Department Commander from 1999 to 2000.

During the Montana State Fair in Gt Falls on July 29<sup>th</sup>, I worked the American Legion Booth with Zone Commander Andy Rice and Department Vice Commander Kim Kay. We sold cash calendars, and raffle tickets and talked to people about the American Legion.

August 8<sup>th</sup> my wife Corinne and I drove to Helena for the funeral of Past Department Chaplain and Western Zone Commander Bill White, who passed away at his home on July 31<sup>st</sup>.

District 10 Vice Commander Cindy Tusler invited me and my wife Corinne to Terry Post 32 for the 100<sup>th</sup> Bomb Group USO Party and Dance. Jeff Scheid gave a presentation on Rosie Rosenthal, who flew 22 bombing missions with the 100<sup>th</sup> Bomb Group over Europe and John E Schwarz who was in charge of the photography lab and documented the war through his film and photographs. They showed a New Documentary (2024) that features True Story Interviews and video footage of the Real-Life heroes of the 100<sup>th</sup> Bomb Group. The film Titled "Bloody Hundredth" was Narrated by Tom Hanks and Executive Producer Steven Spielberg. (NOTE: There is a Miniseries about the 100<sup>th</sup> real-life airman who inspired the "Masters of the Air" miniseries as they share their stories. The Documentary premiered in March 2024!

It was a very interesting evening and made more so as relatives of John E Schwarz were in attendance. On the wall of the Post are colored photos of the aircraft and crews, all taken by John Schwarz. Interestingly, they are but a few of the many photos that John Schwarz took. There is a discussion about the possibility of having them rotate the photos through the Posts across the state in the future. Those discussions hinge on how, when, and where that can be accomplished. The final determination will be made by the Schwarz family relatives. If you are travelling East further than Terry or returning home, I encourage you to stop in and visit the Terry Post to see the photos!

I travelled to New Orleans, Louisiana August 22 with my wife to attend the American Legion National Convention. As part of the National Security Commission and Committee I was in attendance at the Commission Meetings on the 24<sup>th</sup> and 25<sup>th</sup>.

I attended the General Session on August 26<sup>th</sup>, 27<sup>th</sup>, and 28<sup>th</sup> in the Convention Center, the 28<sup>th</sup> being the Election of the new National American Legion Commander James A LaCoursiere of Post 91 in Connecticut, and the Five National Vice Commanders. Our new Western Regional Vice Commander is Gary Leach from California. We returned home to Montana on the 29<sup>th</sup>.

September saw the district meetings with the new schedule whereby all of the Fall District Meetings were held on Saturday on a trial basis. The meetings would be conducted by the Zone and District Commanders aided by the information sent in a pamphlet format with the same information that the Department Adjutant would normally put out. One of the reasons for this was due to the cost of travel to and from and motel rooms for Department personnel. I attended District 1 Fall meeting here in Plentywood, hosted by Post 58 and the meeting was chaired by District Commander Jerry Davenport. Roll call was taken and there were enough Posts present for a quorum. Veterans Assistance Officer Earl Edmonds from Miles City was present to assist anyone who needed to go over their claim or talk to Earl about getting one started.

October  $5^{th}$ , I sat in on a Zoom meeting of the Department Finance Committee chaired by the Department Finance Officer.

October 6<sup>th</sup> through the 9<sup>th</sup> I travelled to Indiana to attend the Commanders and Adjutants call at the American Legion Headquarters in Indianapolis. On the 7<sup>th</sup> there was a Legal training class given by the American Legion Judge Advocate General, Mark Seavey. He advised us that this is normally a three-hour class that he was going to condense down to one hour! It was a very informative class on the proper doe's and don'ts of a Commander that will keep one out of trouble! He also pointed out that it was NOT wise to cut corners – make sure your 990 was filed – Read your Constitution and Bylaws, which I took to include your Adjutant and Vice Commander and Keep minutes of ALL meetings! Next came the Nine Corporate Rules that could apply to All Posts! Another important Point that was brought up was: Four Rules of a Program, with Rule 1: Leadership – Rule 2: Rules – Rule 3: Reports, Rule 4: Controls. Other classes covered by other instructors were Member Engagement, Americanism: Children & Youth, 250<sup>th</sup> Anniversary of the signing of the Declaration of Independence. That date is July 4, 2026!

Sons of the American Legion Dominates the donations to National Emergency Fund & Child Welfare. Their National Commander issued a Challenge to the American Legion Commander and the American Legion Auxiliary President.

American Legion Baseball's 100<sup>th</sup> Birthday is coming up. The Initial Resolution proposing an American Legion Baseball program was passed at the Department of South Dakota's Convention on July 17<sup>th</sup>, 1925. You can keep up on plans for American Legion Baseball's 100<sup>th</sup> Anniversary celebration at Legion.org/baseball and on Social Media Face Book or X.

Marketing discussion was on Suicide and Be The One! We all know that the two Past National Commanders have carried the Be The One Program through their year and our New National Commander, James A La Coursiere is carrying on that program this year! To put Veteran Suicide into perspective, there were 7,000 Combat deaths since 2001 and 131,000 Veteran Suicides since 2001! I ask each one to keep the Be The One Program in mind and in our Posts activities and we as a team can help reduce Veteran Suicide!

October  $14^{\rm th}$ , I sat in on a Department Zoom meeting on Constitution and Internal Affairs discussion where planning was discussed in regard to updating our Department Constitution and Bylaws. That committee will meet again four times between now and Spring Convention to fine tune the updated Constitution and Bylaws.

This brings me up to our Fall Conference and I want to say a personal Thank you to ALL of you for the hard work that you do every day for the Veterans, not only in our Great State of Montana, but around the country. We can accomplish a lot by working together for the Posts, community, our fellow Veterans, and our Department. I Greatly Appreciate ALL that you do – Keep up the Great Work. We are Team Montana – Making a Difference! More importantly, we are a family: American Legion, American Legion Auxiliary, Sons of the American Legion,

and Riders. It is a combination of All the Past Department Commanders Themes that remind us of our obligation to the Community, State, and Nation. It is Service Before Self!

Below are five Resolutions that came up in the National Security Commission Meeting and I felt they were important to share. Due to the length of all of them I will have them by Resolution number, Subject, Disposition, and the Final Resolve clause. The following Resolutions were presented at the One-Hundred and Fifth Annual National Convention in New Orleans, Louisiana August 27, 28 and 29, 2024.

Resolution No. 1

SUBJECT: Support for Concurrent Receipt of Military Retirement Pay and Department of Veterans Affairs Disability for Medically Retired Veterans

Referred to Committee on: National Security

WHEREAS, all medical retirees with qualifying service-connected disabilities should receive the same fair and equitable treatment from a grateful nation, therefore, be it

RESOLVED, By the American Legion in National Convention assembled in New Orleans, Louisiana, August 27, 28, 29, 2024, That the American Legion strongly encourages Congress to amend Title 38 and allow medically retired veterans with less than 20 years of credible service, receipt of their military retirement pay concurrently with disability compensation; and be it further

RESOLVED, The Defense Finance and Accounting Service (DFAS), use retirees account statements indicating VA Waiver to determine retirement due to veterans; and be it finally

RESOLVED, DFAS use the provided payment address on retiree account statements to direct deposit military retirement payments to each qualified veteran.

Resolution No. 34

SUBJECT: Congressional Commission on Military Recruiting

**REFERRED** to Committee on National Security

WHEREAS, Efforts to address the recruiting crisis by military leaders have had minimal success and are in need of major overhaul; now, therefore, be it

RESOLVED, By the American Legion in National Convention assembled in New Orleans, Louisiana, August 27, 28, 29, 2024, That the American Legion, fully endorses the creation

and implementation of a Congressional commission to study and address the many factors contributing to the recruiting crisis, including the decline in public trust and willingness to serve in the military; and be it finally

RESOLVED, That members of the Veteran Service Organization community, such as The American Legion, be included as participating members of the Commission.

**RESOLUTION No. 33** 

SUBJECT: Addressing the Deportation and Earned Benefits of Honorably Discharged Veterans

**REFFERED to Committee on National Security** 

WHEREAS, legislation has been introduced in Congress since 2016 to rectify this objectionable situation. The bill introduced by Congressman mark Takano passed the House in the  $116^{th}$  Congress session. The bill failed in the Senate, but Congressman Mark Takano plans to reintroduce it in the  $118^{th}$  Congress, an

RESOLVED, by The American Legion in National Convention assembled in New Orleans, Louisiana, August 27, 28, 29, 2024, That the American Legion support legislation that would enable the Director of Homeland Security to allow and settle the issue of reparations of those members of the Armed Forces of the United States that were honorably discharged; and be it further

RESOLVED, that the legislation supports the efforts of the Military Members and Veterans Initiative (MMVI), a joint effort of the DHW and the VA to give deported veterans a chance to come home and improve their access to VA benefits.

RESOLVED, that the veterans be provided financial and medical support while waiting for their reparations. The bureaucratic process of Homeland Security controlling their return is completed expeditiously, resulting in the veterans' safe return home.

RESOLVED, that those veterans who were deported for criminal acts, many of whom committed these acts while suffering from PTSD, be investigated appropriately and that their cases be referred to Veteran Treatment Courts or other specialized courts designed to determine if the criminal act was due to mental or psychological disorders acquired as a result of service to our country.

RESOLVED, that the Department of California American Legion supports the latest legislation embodied in HR 7946. The House voted on it in December 2022, and it passed the House but failed in the Senate. It was the latest in a long line of legislation proposed and failed in both houses of Congress.

RESOLUTION No. 30

SUBJECT: State Funeral for FINAL Medal of Honor Recipient of the Korean and Vietnam War

REFERRED to Committee on National Security

WHEREAS: only 2 Congressional Medal of Honor Recipients still live from the Korean War and of the 261 Recipients of Vietnam as of today (4 Sept 2023) only 66 are still alive according to Wikipedia, therefore, be it

RESOLVED, By The American Legion in National Convention assembled in New Orleans, Louisiana, August 27, 28, 29, 2024, That to support and endorse the "State Funeral for All Wars," be requesting the President of the United States designate a state funeral for the last Medal of Honor recipient of Korea and Vietnam as a final salute to the millions of men and women that collectively served in our armed forces during those two wars; and be it finally

RESOLVED, that support be in form of signing the "State Funeral for Veterans for All Wars" national petition asking the President of the United States to authorize a State Funeral for the Final Medal of Honor recipients and a copy of this resolution to the State Funeral for All Wars; Headquarters 1000 North Rampart Street, New Orleans, LA 70116

**RESOLUTION No. 27** 

SUBJECT: Border Security Enforcement

REFERRED to Committee on National Security

## NATIONAL EXECUTIVE COMMITTEEMAN (N.E.C.)

## **Larry Dobb**

Key Updates from the National Executive Committee (NEC)

## 1. Membership Dues and Revenue Sharing

- o Departments need to inform their members about the \$11.50 per member that is returned from National.
- o Of the \$23 annual dues, \$3 is allocated to *The American Legion* magazine.

## 2. Membership Strategies

- Efforts to promote multi-year memberships continue. It was noted that the recent \$5 dues increase should have potentially been \$10, given that inflation and other factors mean dues increase typically only sustains financial needs for about seven years.
- Members who recruit three new members will receive the National Commander's coin.

## 3. Partnerships and Sponsorships

- The American Legion lost substantial revenue from USAA, attributed to not effectively communicating the extent of USAA's contributions to the organization.
- The Legion is the sole veteran group sponsoring this year's Army-Navy football game and aims to achieve similar publicity success as with the IndyCar sponsorship. Plans are in place to engage the Air Force and Coast Guard in future events.

## 4. Operational Improvements

- National is acquiring a state-of-the-art embroidery machine to address issues encountered with external vendors.
- o Continuing challenges with the Personify membership management system have resulted in significant costs. The current contract with Personify expires in 2027, and alternative systems are being considered, with a potential replacement estimated at \$7 million for a system to last 25 years.

#### 5. Disaster Relief and Assistance

The National Emergency Fund (NEF) currently has \$6.7 million available to assist with hurricane and tornado damage relief efforts.

## 6. Membership Status

- o Membership numbers are currently 36,000 below last year's figures.
- The goal for new members is set at 150,000, with 26,000 new members recruited to date.
- The Sons of The American Legion (SAL) membership stands at over 390,000, with a target of reaching 400,000. Notably, 60% of donations to the Child Welfare Fund come from the SAL.
- Auxiliary President Trish Ward (KS) reported that the Auxiliary's membership is struggling, particularly in small towns, with an aging member base.

## 7. Programs and Events

- The Americanism Youth Shooting Sports Program (YSSP) and Oratory competitions were successfully held at Hillsdale College, which has proven to be a receptive host.
  - The cost of hosting YSSP at Hillsdale was \$26,000, compared to \$74,000 in Colorado Springs.
  - There is potential to relocate the American Legion World Series to Hillsdale, though additional NCAA-compliant ballfields (two to four) would be required in the area. The rising cost of airfare for participating teams is also a consideration.

## 8. National Convention Report

- The addition of High School ROTC Drill Teams to the Drill Team Competition brought in around 17 teams this year. Attending the competition during the convention is highly recommended.
- The Exhibition Hall featured 107 booths, generating \$370,000 in revenue the highest figure since data collection began in 2004.
- Approximately 8,000 attendees participated in this year's convention.
- The last-minute addition of shuttle buses for the New Orleans convention incurred a cost of \$208,000. This issue is expected to grow as more hotels discontinue their parking garages and valet services. Future attendees may need to rely on off-site parking options. The Montana hotel was conveniently located across the street from the convention center.
- The 105th National Convention was considered very successful. A full report will be presented at the Spring Meeting. The 2024 convention is scheduled for

August 22-28 in Tampa, FL, pending any significant hurricane damage. Indianapolis may serve as a backup location. Bids for the 2031 convention have been submitted by Atlantic City, Philadelphia, and Pittsburgh.

## 9. Compliance and Legal Matters

- The entire NEC participated in Harassment and Diversity Training and signed a form confirming completion.
- The National Judge Advocate (JAG) reported three cases as of October 9, with ongoing issues in Washington and Colorado. Each department needs a key contact to address these matters. Departments should review their constitutions and avoid relying on outdated practices. Investigations by the National JAG will eventually be billed back to the department.

## 10. Marketing and Communications

- Marketing Chair Evenson (SD) emphasized the importance of distributing "Be The One" toolkits across departments.
- The Media & Communications team focused on three key topics, including suicide prevention. A special cover wrap on *The American Legion* magazine resulted in a one-time \$100,000 increase in sales.
- The Legiontown website continues to receive significant traffic, with plans to add a Department index for easier navigation.

## 11. Military Engagement and National Security

• The National Security Commission, led by Shuman (SD), completed a visit to the USMC base in Yuma, AZ, and plans to visit Shaw AFB (SC) and Joint Base San Antonio, TX, soon. The base visitation program has helped enhance the Legion's visibility with Congress and the Department of Defense.

#### 12. Historical Achievements

• Historian Jennifer Laux announced the winners of the digital online entries competition: Missouri, Idaho, and Nebraska. Fourteen hard copy entries are still under review.

#### 13. Resolutions and Governance

- All 23 resolutions presented were passed.
- The Department Advisory Committee is working on job descriptions and the transfer
  of Washington's oversight back from National. In Colorado, conflicts between various
  groups and IRS issues persist, necessitating a Constitutional Convention and a Special
  Convention in January 2025. A new constitution could be in place by May 2025,
  though some resistance remains within certain groups.
- The problem departments are experiencing issues primarily at the department level, not in the Posts or Districts. Departments must operate like businesses to avoid

complications with the IRS, state authorities, and other government agencies. Three individuals faced challenging situations as National employees, and Jim Lish has returned to Wyoming.

## 14. Cost-Saving Measures

• National has secured a new paper supplier, resulting in a 19% reduction in costs compared to the previous supplier.

## 15. Future Budget and System Updates

• The 2025 budget includes plans to replace Personify with a custom-built system estimated to cost \$7 million. This new system aims to last 25 years and will allow for necessary updates and changes without being dependent on an external vendor.

## **ALTERNATE NATIONAL COMMITTEEMAN (N.E.C.)**

I went to the National Convention in New Orleans Louisiana. There were several days of 98° and 98% humidity! I managed to find a couple of restaurants that served catfish and alligator.

The best one was Drago's and the most expensive was Mulate's, both within a fair walking distance from the hotel. The WWII Museum was worth the trip and a must for anyone planning a future trip to NOLA. It was so big you can't see it all in a single day. I was able to see the Mighty Mississippi River, it's a bit nerve-wracking to drive by the retainer wall and realize you are under sea level. I did not go to the French Quarter; I figured there may be too many of my relatives looking for a handout.

Prior to the start of the convention, we were asked to log into legion.org/legislative and tell our elected officials to pay VA disability payments. So far more than 44,500 legionnaires have done so.

The convention had a lot of great speakers, a couple of Medal of Honor recipients. Most inspirational was the address by National Commander Daniel Seehafer. Most entertaining was the speech by LT General Russel Honore, who oversaw the Hurricane Katarina aftermath 19 years ago. And he had some good LifePoint lessons.

A resolution was passed prior to the start of the Convention to Honor PNC Jake Comer by renaming the NEC room to John P. "Jake" Comer National Executive Room. Had no idea as it was kept very secret, and it was very emotional for him. This was the only resolution presented to the NEC all other were referred back to committee or received and recorded.

It was reported that The Department of Washington had its largest convention in 5 years and now has a new constitution and by-laws, election of new officers. It will get its non-profit status back and a recommendation to the NEC to reinstate the charter.

The Department of Colorado is still working on taxes for 2021-2023. A clear picture is needed of finances before reinstating the charter. They are working on a new constitution and by-

laws. A requirement is the must follow the Department of Massachusetts and must be "Unanimous". Maybe in May a recommendation for the reinstatement of their charter.

The Marketing Commission is working to customize digital services.

Update to the Awards Manual with a new Retention Award.

Seventy-Seven (77) Post Charters were presented to the NEC for cancellation consideration. None from the Department of Montana.

Fifty (50) Squadrons have been submitted and recommended for cancellation during the NEC meeting in NOLA. None from the Department of Montana.

Montana received a National Blood Donor Award for Post participation in Category VI.

#### AMERICANISM COMMISSION

At the 105th National Convention in New Orleans the Americanism Commission met Saturday, August 25th from 0830-1030.

A video of the meeting was recorded and will be released in a few weeks. We watched the "new"

PSA video about our Children & Youth Programs featuring many of the current program champions.

It can be seen by going to YouTube, searching American Legion and watching day 1 of the 105th National convention. It follows the speech by Britt K. Slabinski, medal of honor recipient and president of the Medal of Honor Society as just 2 hours and 18 minutes into the program (2:17:51)

No Resolutions were presented to the Commission.

C.O.Y.E. (Committee On Youth Education) said 95 applicants for Samsung Scholarship were received for consideration. All applicants will receive \$1,200.00

The Convention Committee of Americanism met again on Sunday, August 24th, 2024, from 0835-0900.

Mark Avis- was elected Chairman of Americanism Commission/Committee.

Michael Donnelly- was elected as Secretary.

## **Ray Read**

#### Introduction

Following my attendance at the 105th National American Legion Convention in New Orleans, Louisiana, I wish to address the importance of post and district histories for Montana American Legion posts. During the 2023-24 Montana Department Convention in Lewistown, no post histories were submitted for the annual history contest, marking the second consecutive year without entries. There is an opportunity for posts to submit histories for the upcoming 2024-25 year in two categories: a one-year post narrative history and a one-year post yearbook.

### **Importance of Post Histories**

The Department of Montana encourages the preparation of annual post histories to integrate this practice into regular post and district operations throughout the year. Recording post activities is crucial for future reference and adds considerable value. Although most posts do not have professional historians, this should not hinder the proper documentation of post activities. The focus should be on comprehensiveness, readability, and proper arrangement to create both an engaging narrative and a valuable reference source.

## Guidance for the 2024-2025 Cycle

On September 3, 2024, the Office of the National Historian issued guidance for the current cycle:

- 1. Annual Report Submission: The annual report of the Department of Montana's activities should be presented at the Department Convention and a duplicate should be sent to the National Historian in Indianapolis. Contributions from posts, districts, and zones are critical, especially since the Department's travel budget is limited.
- 2. Collection and Preservation of Records: In coordination with the Department Adjutant, I will assist in gathering and preserving records of historical significance, such as convention proceedings and department reports. Historical materials should be categorized for preservation and checked thoroughly before discarding. In case of uncertainty, consultation with the library and museum director is recommended.
- 3. Department History Compilation: The Department Historian should compile a comprehensive history covering the period from the department's inception. With two histories already submitted (1919-1967 and 1967-2000), a third volume for

2001-2025 is due. Assistance from post and district historians will be crucial for completing this edition.

## **Resources and Support**

The American Legion Officer's Guide and Manual of Ceremonies (61st edition, 2024) is available both in print and online at <a href="www.legion.org">www.legion.org</a>. It provides updated guidance on history preparation formats.

## **Department and National History Contests**

The Department will hold its annual history contest for 2025, with entries due by the first day of the 2025 Department Convention. Categories include digital and hardcopy submissions, with a best practice showcase for digital entries available online and hard copies displayed at the National Convention. Information on the contest and post showcase will be provided soon; posts are encouraged to start gathering materials.

## Recognition and Communication

Congratulations to posts utilizing news and social media to connect with members and the community. Regular communication on events and opportunities is beneficial. Posts are encouraged to submit their events for inclusion in The Montana Legionnaire.

## Additional Updates and Resolutions

- The 45th Annual POW-MIA Recognition Day and related items from the 65th Montana Legislative Assembly, including SJ0017 and SJ0018 resolutions, recognize military service and commemorate significant events in Montana's military history.
- Department Resolutions from the 104th Convention:
  - Resolution 23-06: Supports the America 250 Commission for the semi quincentennial celebration of the Declaration of Independence.
  - Resolution 23-01: Nominates R. Klose for National Vice Commander, representing District 6.

## America's 250th Birthday Celebration Planning

The Department Historian is researching Montana's participation in the nation's 200th birthday to develop a plan for the America 250 celebration culminating on July 4, 2026. More information will be published in an upcoming digital edition of The Montana Legionnaire.

#### Conclusion

This report emphasizes the need for Montana posts to actively prepare and submit their histories for 2024-2025. Proper documentation not only preserves the legacy of the American Legion but also educates and connects current and future members. #### **LEGION RIDERS**

The American Legion Riders (ALR) program officially kicked off at the Department level in Montana during the summer of 2024. We had the goal of uniting our established chapters from across the Department who's members are all motorcycle enthusiasts who are committed to supporting veterans, their families, local posts and communities. And while the program has generated significant interest and growth, the launch has not been without its challenges.

## **Challenges Faced During the Launch**

Chapter 4 Billings has experience organizational setbacks, making it difficult to establish a fully functioning ALR chapter moving forward. These issues, which include member coordination and administrative processes, have delayed progress. Similar challenges have been encountered across the Department, where other chapters struggle with consistent communication and operational structure as it pertains to the new SOP.

## **Strengthening Communication and Planning Efforts**

To address these challenges, we have initiated monthly Director Zoom meetings to enhance communication and provide a platform for sharing updates and addressing concerns. These meetings aim to improve connectivity and cohesion between chapter Directors which in turn elicits leadership bye in for Department goals and streamline the flow of information.

In addition to enhancing communication, we are actively planning two major initiatives: a Legacy Fundraiser to support the children of fallen service members and a Department ride to bring together riders from across Montana. Both events will help build camaraderie and raise awareness for the ALR program.

In addition to the monthly Zoom meeting the ALR has implemented a quarterly membership status worksheet to try and accurately track membership. There is estimated to be between 125 and 175 Legion Riders in 10 Chapters. Since Department Convention we have grown from 9 to 10 Chapters and the reporting chapters have all reported additional new members.

## **Ongoing Reporting Issues**

However, despite these efforts, our membership numbers remain questionable due to a persistent issue: Some chapters and individuals are simply not responding or recognizing the Department level ALR leadership. This lack of engagement complicates and restrains efforts to get an accurate count of membership and overall department wide cohesion and highlights the very reason there was a need to implement a department SOP. Efforts are ongoing to encourage responsiveness and accountability across all chapters.

## **Moving Forward**

While challenges persist, our commitment to the growth and success of the American Legion Riders in Montana remains steadfast. By continuing monthly Zoom meetings, pushing forward with our planned events, and addressing the reporting difficulties, we aim to build a strong network of ALR chapters that can effectively support our shared mission.

The path forward includes tackling these initial setbacks with resilience and ensuring that all chapters are actively involved and contributing to the program's overall success. Clarifying and implementing additions to the SOP with chapter participation.

Additionally, the ALR in Montana will be looking to implement chapter awards in the near future such as Rider of the Year and Mileage Champion of the year and will in turn be put in for selection at the Department level for those awards to be chosen from the winners of the chapter level awards.

The ALR future is looking bright!

## **DEPARTMENT ADJUTANT**

## **Duane Cunningham**

The last few month have been busy with National Convention, preparations for Department Fall Conference and the 2024/2025 National Commanders visit, changing locations of American Legion Boys and American Legion Auxiliary Girls State, the 2024 Membership Conference, and the National Fall Conference in Indianapolis.

The National Convention was held in New Orleans in late August, as 32 representatives of the Montana American Legion descended on the Big Easy. A lot of American Legon business was completed throughout the week and a new National Commander was installed as James A. LaCoursiere, Jr became the American Legions 106th National Commander. Commander LaCoursiere initiative remains as the "Be the One" campaign designed to bring Veteran suicide awareness to the forefront of Veteran issues. The American Legion's "Be The One" campaign aims to raise awareness about the veteran suicide rate and empower everyone to take the initiative to save the life of a veteran who is at risk.

In a very strange year, there was only one (1) Resolution passed at the 105th National Convention; of the many that were brought forward, including Montana's two were all referred for further study. The resolution that did pass at the 105th National Convention, was Resolution No. 10: "Post-Secondary Credit for Military Service," originating from South Dakota and was heard by the convention's Veterans Employment & Education Committee.

It calls on all colleges and universities to work with the Department of Defense to develop and implement a framework for assessing military training and experience for college credit. It urges Congress to enact legislation requiring colleges and universities that receive federal funding to adopt policies that recognize the educational value of military service and provide the appropriate credit in accordance with the American Council on Education.

Some interesting resolutions were referred back for further study, including Resolution No. 16: "Investigation of Anthrax Vaccinations." the resolution calls for federal agencies to investigate the anthrax shot given to troops during the Persian Gulf War, whether deploying or staying on base. The shot was given to about 10,000 civilians after the 9/11 attacks, when menacing anthrax-laced letters killed five and sickened 17. Resolution No. 17 also was referred that called for the removal of language in the Legion's Officer's Guide & Manual of Ceremonies that separates female cap practices from males. Resolution No. 20 "Compensation for Veterans Requiring Hearing Aids for Service-Connected Hearing Loss" was referred to the VA&R Commission for further study. It called for amending the VA's rating schedule to ensure veterans with service-connected hearing loss who require hearing aids receive a minimum rating of 40 percent.

This year's Fall District meetings ran differently as the Department Adjutant did not travel to all 11 meetings unless specifically requested. The intent was to meet both the requests of the Districts and allow the District Commanders to have full control and responsibility of their own District Meeting. The feedback received after all the meetings were concluded was very positive as most Districts reported that while it was different not having Department there, it also seemed to allow more open discussion and the sharing of information and ideas. There were a couple of comments about "Department" not being in attendance, but I remind everyone that Department was present, as all Department Executive Board members are "Department", the only person not there was the Department Adjutant.

On a different topic, the Nutter Shore Trophy Hall on the third floor of the Veteran's and Pioneers Building in Helena is set to reopen in the spring. The Montana Historical Society's grand opening is scheduled for May of 2025, I do have some concerns with the current administrations continual efforts to remove the historical significance and purpose of the building and the sacrifices of the Veterans who built it. We may have a future legal fight on our hands as the Montana Historical Society continues to squeeze the Veteran Service Organizations out of a building that has our name on it.

At the 2024 Department Convention, a resolution passed to retire the Montana Legionnaire in its current format. Beginning in November, the Legionnaire will transition to a monthly online paper emailed out to every Legion Family member and to all American Legion Posts for those members who don't have access to the internet. This change will allow us to more readily inform our members of current events, news and happenings within the Department. The biggest reason for the change was due to the overall cost of printing and mailing a newspaper. The hope is that going digital will be in the best interests of our members and allow us to use the digital version of the Legionnaire as a recruiting tool for future members.

I just returned from Fall Conference in Indianapolis as two days of meetings and trainings were held. Montana's representatives were the Department Commander, NEC, Adjutant, SAL NEC and the Children and Youth Program committee chair. It appears that while the National Headquarters expect a break-even budget for the first time in a few years, they have done it through both an increase in membership which is good, and a decrease in staffing and a transition of workload to the Department level, which is bad. The Departments are already overtaxed with responsibilities and reports formally completed by National staff, and this appears to be a continuing practice.

With all the things going on, I want to continue to stress the importance of our programs and what impact they make within our communities. Please support the fundraisers of the American Legion, our Cash Calendar and Big K programs, in addition to our 2024 cornhole boards and Canoe raffles, these are the lifeblood of our programs. I close this report on a somber note as while I attended and enjoyed the National Convention in New Orleans, it was also the first convention without my partner in crime. You are dearly missed Mr. Bill White.

The VA &R Committee does a lot for Veteran issues, and I look forward to becoming more involved in it. In September the American Legions "System Worth Saving" group visited VA Montana and listened at length to concerns and issues within the VA Healthcare system. Attendance was a low at the Town Hall, but the VA&R Committee members in attendance heard both positive and negative comments and inquiries, the 18 October issue of the VAR Weekly report is below as it mentions the visit to Montana.

VETERANS AFFAIRS AND REHABILITATION WEEKLY UPDATE Ending — 10/18/2024 Health Policy Team (HPT) Operations Meetings:

- October 9: HPT attended meetings with the Women Veterans Program and Telehealth teams from the Fort Harrison Department of Veterans Affairs Medical Center (VAMC) to identify challenges and best practices. These meetings were a continuation of the Montana System Worth Saving site visit.
- October 9: HPT attended a meeting on Capitol Hill with Representative Molinaro to discuss creating original legislation to address the telehealth needs of veterans living overseas.
- October 10: HPT attended a meeting with the Partnership to Advance Cardiovascular Health (PACH) about the cardiovascular health of veterans and how to work together to help veterans suffering from cardiovascular illnesses such as hypertension.'
- October 11: HPT met with Dr. Erik Vilen of Helena, a former physician at the Helena VA who has led a local Montana movement calling for accountability at the VA. Meeting discussed issues about the Helena VA and how to help address them.

October 17: Deputy Director for Health Policy (DDHP) attended the VetResources Community Network Office Hours. The meeting highlighted VA Buddy Check initiatives and how organizations like Vets4Warriors and Together We Served are assisting this effort.
- October 17: HPT attended Future of VA Healthcare Roundtable at the DAV National Headquarters.

As this is my first report, there is little to relate as everything is running smoothly with the Executive Committee and the Department currently. There are no known concerns or issues to relate, and I look forward to meeting you all during our upcoming fall conference in Helena later this month.

Adherence to Robert's Rules of Order during our upcoming meeting benefits each of us by ensuring:

- Justice and courtesy for all,
- Maintenance of order,
- Consideration of one item at a time,
- All sides get heard,
- Ability for each member to provide input,
- Majority rule, and
- Protection of the rights of all members including the minority.

#### FINANCE OFFICER

#### **Lonnie Cook**

The American Legion Department of Montana finance committee reviewed and approved the adjustments to the 2025 operating budget on 2 Oct 2024. The 2025 budget was adjusted to show changes to moving the department convention from Canada to Helena and scholarship payouts. The committee voted and approved to keep \$10k in the Oratorical scholarship account for 2025.

Dave Ashby from Stockman Bank Wealth Management Team briefed us on our current wealth management portfolio during the 2 Oct 2024 Finance Committee meeting. Currently we are roughly 40% bonds and CDs (fixed income) with long term locked in percentage rates, and 60% in S&P 500 stocks (Equities) that pay out dividends. He recommended no change to our portfolio as we have locked in some good interest rates, and most of our equities pay

dividends. Still looking good on making good returns in interest/dividends in 2025. However, dock strikes, and geopolitical environment could change our outcome a little.

On 2 July, per the resolution 24-06 (Resolution Concerning the Endowment) the department moved \$21,639.08 of endowment funds into the Department Operational Checking account and remaining \$11,106,72 of funds into the stockman wealth management non-sweep cash account. If future endowment funds are received, the funds will be placed back into a pending approved operational endowment account at that time.

We have transitioned to the new online QuickBooks, the accounts have been reduced down to three accounts; American Legion of Montana, American Legion Boy State, and Sons American Legion Montana. For each account, the finance officer and chairman for these programs have online read only access to all reports for better transparency. We are allowing our committee members access, so the Department of Montana will avoid what happened to the Department of Idaho.

Our current tax accountant is reluctant to use the new online system for payroll and taxes, so we will be moving to a new tax accountant, the beginning of January 2025. This new tax accountant is currently being utilized by many businesses around Montana and will provide additional services we currently are not receiving.

## **JUDGE ADVOCATE**

Greetings to all my Legionnaire friends and colleagues. As some of you know, I was unable to join you at the summer convention because I was in France to attend the dedication of a memorial to my Uncle Jack and his fellow B-17 bomber air crew members who were KIA (and one POW) on June 22, 1944. The memorial was dedicated on June 22, 2024, in Epagne-Epanette France on the 80th anniversary oof the B-17 being shot down by flak. There were 52 American family members of the crew present at the dedication, and the French government declared the dedication to be an official D-Day 80th Anniversary event. There were over 500 people at the event, including a French Foreign Legion honor guard. My Air Force Veteran brother Capt. Richard Fox (DFC), and my Uncle Jack's great nephew, Army Lt. Col. Brandon Merkley, were two of the speakers at the event. We traveled to the American Cemetery in Normandie two days later and the families eulogized the five crew members, including Uncle Jack, who are buried there.



#### THOMAS MANN POST 81 LEGION PARK LITIGATION

Over the summer I have monitored the litigation between Post 81 and the Knudsen Family Limited Partnership over the continuing failure of Attorney General Austin Knudsen's family to allow access to Legion Park. On August 7, 2024, Attorney General Knudsen's father, Miles Knudsen, and the Knudsen Family Partnership were found in contempt of court and ordered to pay Post 81 \$45,158.75 for the repair and reopening of Post 81's easement road which the Knudsen family had destroyed and blocked despite a September 7, 2021 final judgment ordering that the road be opened.

#### NATIONAL COMMANDER'S VISIT TO THE FALL CONFERENCE

For the last month or so, I have assisted the Department in attempting to secure meetings for the National Commander with Governor Greg Gianforte and with the Montana National Guard TAG, Major General Pete Hronek. Unfortunately, both the Governor and General Hronek are unavailable, but we did secure a meeting with Governor Gianforte's military and veteran policy advisors.

#### FRADULENT E-MAILS

Like many of you, I continue to receive bogus e-mails from individuals posing as either former Commanders Lowell Long, and Glen Sharbono, or legitimate companies. The bogus e-mails that I receive purportedly from past Commanders are now more sophisticated in that they more closely mirror actual e-mail addresses. The other bogus e-mails look like invoices for services or products from companies like PayPal, Microsoft, and McAfee. These e-mails typically have the words "Thank you for your order" in the subject line. If you receive e-mails like this, it is best to delete them and do not clink on any links, call any phone numbers, or reply to the e-mail. I have recommended in the past that our members' and officers' contact information not be listed on the Department's web site. However, you will recall during a recent Montana legislative session one of our members shared the Department's member list including e-mail addresses with an outside lobbying group. So, it is possible that the Department's member list could perpetually be in the "Dark Web" and available to scammers and fraudsters for years to come. This underscores the importance of members adhering to Department policy prohibiting the sharing of Department or Post member lists with anyone who is not a member of The American Legion, Department of Montana.

#### LABOR AUDIT FOLLOW-UP

I continue to work with the Adjutant and members of the finance committee to address past problems with how the Department handled overtime pay for staff. I have participated in Zoom and in-person meetings to come up with a plan to remedy past problems, and to avoid problems in the future. I helped the Department to retain Helena attorney, Mike Talia, to assist with legal advice. Mr. Talia is the former JAG of the Montana National Guard, and he has offered to provide the Department with legal services pro bono (for free).

#### POTENTIAL REVISIONS TO THE DEPARTMENT CONSTITUTION AND BY-LAWS

I continue work with the Constitution and Internal Affairs Committee of the DEC tasked with reviewing our Department Constitution and By-Laws to determine if revisions should be recommended to the full membership during the Spring 2025 meeting. The Committee has

delegated responsibilities for reviewing the documents to make suggestions, and we have scheduled additional meetings over the next four months. If any of our members have suggestions on potential revisions, please e-mail the Department Commander, Ken Simon, and copy me, Richard Klose, and Adjutant Duane Cunningham.

Post #73's Auxiliary had a sophomore recognized for an essay he wrote on patriotism, winning first place at District, State, and National. They were also spotlighting the two American Legion Auxiliary delegates of this past year's Girls State. 
9-1 to advance to the championship game. They lost to Eagle River Alaska 5-0 finishing as the runner-up.




#### 2024 AMERICAN LEGION WORLD SERIES TOURNAMENT

# **SCOUTS BSA**

# **Conrad Heimbigner**

I have participated in Wood Badge Staff Development starting in April 21-22, 2023, for Wood Badge Adult course 4-315-24 on August 8-11 Session 1 and September 6-8, 2024. This course ends when the participants complete 5 separate goals within the following 18 months to enhance themselves or the Unit, District, or Council of the Boy Scouts of America to provide a better program for the youth in Montana and the visiting Councils. Wood Badge Coarse 4-315-24 was conducted at the K-M Scout Ranch, 1066 K-M Rd, Hilger, MT 59451. It is a Boy Scouts of America National Program to instruct Adults how to become better leaders and lead by example through learning communication skills, the DISC Behavior Style Training, the EDGE method, the five stages of team development, the TOOLS of leadership, and many other skills in a setting as they enter the Course as an acting Cub Scout youth new to Scouting

, cross over from Cub Scouts into Scouts BSA, and earn rank to complete the "in person" training portion to return back to their homes and local units, or positions in their Districts or Council to complete five separate personal goals to complete a "Ticket" which is very similar to completing an Eagle Scout Project so each participant experiences what youth experience going through Scouting as a youth from Kindergarten through Senior in High School in a very action packed 5 day course either in a 5 day continuous coarse or a three day / two day split coarse like this one. There is benefits for having a split coarse in which the participants have to return home and keep communication with in their Patrols (groups similar to committees or Platoon – squads in the Army) throughout the break and return with a planned campout including meals and methods to prepare and cleanup after each meal for the remainder of the course as we expect youth to be able to do as they rank up through the Scouts BSA program learning all the requirements of Adult Leadership as well to be able to return back to their respective units and align them to be presenting the guidelines of National Boy Scouts of America for that age group program as a "Well Trained Leader". These five individual goals are monitored and reviewed by the Staff for the next 18 months following. If any participant does not complete their assigned individual chosen goals they do not "graduate" and receive their award of two beads on a leather cord and have to retake the course at a later date, if possible, in the future. The youth program that is similar to Wood Badge for the Adults is called "NYLT" - National Youth Leadership Training which is also conducted and presented to youth 14 to 20 years of age at K-M Scout Ranch. Any youth that completes NYLT is eligible to attend "NAYLE" - National Advanced Youth Leadership Experience at the National Campsite - Philmont Scout Ranch, 17 Deer Run Rd, Cimarron, NM 87714 or Summit Bethtel Reserve, 2550 Jack Furst Dr, Glen Jean, WV 25846 These are the premiere youth leadership camps for the youth our Scouting Programs enhance or recognize for the Eagle Scout of the Year Award winner most likely will have attended NYLT if not NAYLE on their journey to earning the Eagle Scout Rank. I have also attended the 2024 Fall Fellowship Order of the Arrow event at the K-M Scout Ranch on September 27, 28, and 29th. I communicated with various leaders at this event about the American Legion Boy Scout programs and how to promote them will attending courses on how to promote and enhance the Order of the Arrow program in the Montana Council. The Order of the Arrow is the "Honor Society of the Boys Scouts of America" that provides "cheerful service" to their communities through the Units they are members of. I am communicating with Boy Scouts of America - Montana Council Staff and Executives to promote our Scouting programs in every eligible Unit in the Montana Council to continue the work of Bill Rich and the passing of Resolution No. 21: Scouts BSA. There is not an available Council Data Base to promote the eligible youth for the Eagle Scout of the Year Award individually at each unit. We are working on a method that is a continual education of the Awards and programs that American Legion provides to every Scouting youth and Volunteer Scouter such as the American Legion Square Knot Award at each unit continuously into the future. Covid has caused disruptions in the Montana Council Scouting programs and those disruptions have been seen in the application number decreases for the American Legion Eagle Scout of the Year Award in our Department. As Units (Troops and Packs as well as Venturing Crews) regain the outdoor events and practices of pre-covid numbers, we are projected to start having increasing numbers of applications and youth eligible for our programs; however, the youth leaders who knew about our programs, that were the Patrol Leaders and Senior Patrol Leaders in the Scouts BSA program and equivalent leadership positions in the Venturing Crew program, have mostly aged out of the system to promote the American Legion Program as in the past. We as a team of leaders will be working with Unit leaders who may have also left the program

as their sons and/or daughters aged out of the Boy Scouts of America programs. The Montana Council of the Boy Scouts of America has an excellent staff and board that is dedicated to serving the Youth of Montana and the units of visiting Councils to the Montana Council Scout Camps. Hopefully the work we are doing today will show increasing numbers participating in our American Legion Programs starting in November and December as units go through the "Rechartering" Process with our American Legion Chartering Posts. #### FINANCE CHAIRMAN

### **Bill Cummins**

As the new chairman of the finance committee this has been a learning process. Since the convention in June the finance committee has met several times over Zoom and prepared a budget to be presented to the executive for their approval. On July 25th we held our first Zoom meeting where we went over the budget with the Department line by line and discussed whether to raise or lower or omit some lines in the budget.

The committee was informed at this meeting about the Department's financial situation with us having more money in our investments than is allowed by federal law. According to our auditor we should only have one and a half times our annual budget in reserve and Investments. If we continue this process the auditor felt that the IRS could come in and call for an audit and we will probably be penalized for not complying with the federal law.

We did have a deficit budget last year and a budget that will be finalized this year will probably have a deficit, but this would probably be the last year that we would have a deficit budget and that is why we have to look really hard at future fundraising and need to keep a good handle on our investments and savings. During that meeting, which was mostly educational for the finance committee, we also talked about ways to make our fundraising work better. Other than just raffles we were asked to come up with ideas on fundraising projects. It was brought to the attention of the committee that the Big K raffle is not producing the funds that it was set up to do. It's hard to understand why the post and the legion family have not been participating as much as in the past. This could be a good fundraiser if the post and the rest of the Legion family participated.

The cash calendar seems to be the best money raising endeavor as far as Raffles at this time and should be continued. The adjutant's assistant talked about the new online QuickBooks that they were converting to and that this was a work in progress. During our Zoom meeting on September 5th, a discussion was held about raising the scholarship or prize for the oratorical contest with the feeling that we could get more participation with a larger financial prize; this has been suggested by the finance committee at our June convention in 2023. A motion was made and passed to increase the prize money or cash reward to \$5,000 for first place, \$1,500 for second and \$500 for 3rd and 4th. This will have to be presented as a Resolution at the Executive Committee meeting in October. The other change that was also in the motion was to award prizes at the end of the contest instead of doing it as a scholarship and having to hold the money for up to two or three years and then the winner either forgetting about the award or feeling that there wasn't enough financial incentive to even ask for the award. It was felt it was better to award the prize at the end of the contest.

There was also a lot of discussion about the budget, and we did go over several of the line items in the budget. The committee came up with a pretty much finalized budget at that time except there were a couple unknowns in the budget since the travel had not been finalized for the upcoming June convention in 2025 because of the change in moving the convention from Calgary back to Helena, which will be a good financial savings for the Department.

A discussion was held on fundraising, and it was brought to the committee's attention that there was a possibility of partnering with Big Sky Brewery in Missoula and having them produce a beer can with one of their beers for the legion that would have a legion emblem on the can along with recognition of the Legion, Auxiliary, Sons of American Legion and Legion Riders. Duane and Lonnie, we're going to explore this possibility of partnering with the brewery where we would get a portion of proceeds of the sales of this beer. It was felt that this could be a long-term money raising endeavor for the legion; There was also talk about partnering with Willie's Distillery to produce a whiskey with a legion emblem on the bottle. A motion was made to have Duane and Lonnie pursue this to see if it would be a worthwhile project for the legion Department with The Distillery and the brewery in Missoula.

The feeling is that it is difficult at this time to continue doing raffles for the reason that most posts are also doing Raffles as money raisers for their posts and organizations within their communities are also doing raffles and that people are burned out by having to buy raffles and there are so many that they can't contribute to them all. Although we do have two Raffles going on at this time, which are a pair of cornhole boards to be raffled off at the fall executive meeting and the department was given a fishing kayak to be raffled off at next year's

convention in Helena. This is a well-equipped kayak set up for fishing not just a kayak to paddle around the lake. We also talked about having one pint beer glasses made for the legion department and selling these to Legion members or the post that have a bar connected with their post. It was also discussed to get small glasses made for drinks such as the whiskey from The Distillery.

By the end of this Zoom meeting most of the members of the committee were feeling comfortable with the budget and felt that it was a lot easier to understand the way it was presented and would be easier for the executive committee to look at and pass the budget in October. In our Zoom meeting on October 2nd, we did finalize the budget and went over some of the line items again trying to trim some money from some of the expenditures and look at fundraising. Before our meeting went to the budget and fundraising, there was a presentation by Stockman Wealth Management, who is our financial advisor, on how our investments work and how they are doing. Dave was very pleased with our investments on the portfolio that we have. It seems to be producing at a rate around 12%, which is good for the way our economy is at this time.

The budget was approved by the finance committee at this meeting, and it does show a \$33,000 deficit for this fiscal year. The operational part of the budget was approved in the June meeting so the department could go ahead and do business such as making payroll, paying bills that may come in during the early part of this year. The National Department had been very slow about distributing the money to the Departments for the memberships that they received, and our department had to withdraw \$50,000 from our investments to be able to operate until we get reimbursed by the National for our memberships that are sent in. At this time, we're starting to catch up and I was informed that we had received payments from National up to the first of September. During the meeting a motion was made and passed to go ahead and partner with Big Sky Brewing. The beer can be sold to members as well as being distributed through a beer distributor so that the posts and other establishments could have this product for sale. They are also producing a beer spicket handle for the bars so that they could have our beer on draft. This could be a good long-term financial endeavor.

There was also a motion made and passed to go ahead with the whiskey glasses and beer mugs or glasses. It was also felt that these glasses could be etched instead of having a plastic Insignia on the side. It is also the Department's concern as well as myself that the department is spending more money on travel to and from conventions and executive meetings and other programs than we are on Awards and scholarships. We are supposed to be an organization that promotes patriotism and Americanism, and this is where our priorities should lie.

#### **HIGHWAY FATALITY MARKER**

Summer only got worse; I spent June and July on the road with four more funerals along with moving my mother-in-law's property. Nonetheless, work got done by the intrepid crews that work at the various posts throughout the state.

I continue to reach out to my Posts on bi-weekly basis. This keeps them informed and me on my toes. Currently, I communicate with 59 posts. That's an improvement of 5 Posts from last year. I have zero, no, nada, contact with anyone out of District 3. They have a number of reportable fatalities that need to be addressed. I do contact other posts to attempt at

increasing awareness of the program. I need them to contact me so that we can coordinate our efforts more thoroughly. Then of eleven districts have at least one Post operational, most have multiple Posts doing the job.

It is a pleasure to report that Posts share resources when necessary. I have been able to have crosses manufactured for me and I have been able to reach out to those posts that are in need. District 7 has helped me, and I am certain that they help others with obtaining delineator posts.

I am also fortunate to receive feedback from posts with questions, suggestions, problems, etc. I feel this is important when trying to maintain a successful operation. I have tried to contact all parties that have reached out to the Adjutant's Office for help. I have had very little negative feedback when attempting to solve particular problems for people.

To the best of my knowledge, we have not placed any new media this past six months. NOTE: A new photo book, **MONTANA ROAD WRECK**, by Chris M. Forsyth, was published this year. It is a compilation of Fatality Markers throughout the state (certainly not all) with minimal commentary to accompany the photos. I urge the American Legion to purchase a copy for their records.

There is the issue of the 800-pound gorilla in the room that needs addressed. Posts are unclear as to what constitutes appropriate decorations on crosses/posts. Personally, I take anything on a marker off and leave it beside or in front of the Fatality Marker. I noticed while travelling through a couple of reservations that the FMs are so enshrined with stuff that the post is not visible. Sometimes, it is just a personal thing, like a child who perished, and the family wants to make this something other than the intended purpose. I really thing this needs to be addressed in our instructions (with approval by MDT). The wording is somewhat vague, and we need to address this.

I had 19 of 59 Posts report as of today. 19 new FMs were erected by these 19 posts. Maintenance (weeds, painting, straightening, replacements, etc.) done on hundreds of markers throughout the state.

# INSURANCE DIRECTOR

I often get asked what Legion Insurance (LIT) is or worse yet, I run into Legionnaires and Legion members who have never even heard of Legion Insurance. So, I thought it might be a good time to provide a little information on what it is, eligibility, and why its important. First off ALL Legion Family members can sign up for Legion Insurance. If you aren't incorporating LIT in your pitch as to why you should join the American Legion, the American Legion Auxiliary and the Sons of the American Legion, then you are leaving out a huge benefit.

The Legionnaire Insurance Trust (LIT) was formed in 1966 with two primary goals: to provide Legion families with low-cost insurance protection, and to provide a source of revenue to participating Legion Departments. The Trust has been so successful for over 50 years that today over 2,000,000 Legionnaires in 48 participating Departments are enrolled in this unique program. Also, in the same period of time, hundreds of millions of dollars in

claim benefits have been paid to Legionnaires and their families through the LIT; and over \$52 million in allocations have been paid to participating Legion Departments.

The first Trust insurance plan to be offered was the Hospital Income Protection plan, a program designed to pay fixed dollar amounts for periods of hospital confinement. Over the years, other insurance coverage offered included: Cancer, Accidental Death, Travel Accident, Critical Illness, Disability Income, Emergency Assistance, Long-Term Care, Medicare Supplement, Discount Cards, Dental, Whole Life, Auto, Homeowners, Identity Theft, and Home Health Care.

Since its creation, AGIA has worked closely with the Trust to develop insurance programs especially designed for Department members and their families. LIT offers a free No Cost to you Accidental Death Insurance plan. Your beneficiary will receive a check for \$5,000.00 if you suffer a fatal covered accident while you are traveling to or from or participating in any covered event conducted for Legion business, or \$1,000.00 for all other fatal covered accidents. You pay nothing for this coverage.

The American Legion endorses this coverage to stand by your family with up to \$1,000.00 cash benefits paid straight to your beneficiary, if you suffer a fatal covered accident at home, on the job, in your car, on vacation, while traveling, wherever you are. The LIT also offers Emergency Assistance Plans, a Cancer Care Insurance Plan, a Long-Term Care Plan, Health and Dental Insurance, Medicare Supplement and Medicare Advantage Plans and even Identity Theft monitoring. Pretty much a one stop insurance plan specifically designed for Legionnaires.

#### **LEGISLATIVE**

I want to begin this report by recognizing our departed good friend, Comrade Bill White. Bill and I were intricately involved in the Montana Department legislative efforts at the state level. Bill also accompanied our team during our several Congressional visits in D.C. For the past several years Bill served as your American Legion Liaison to the Governor. He was instrumental in getting our message concerning state initiatives to the Governor and assisted me throughout the many legislative sessions, getting the word out. I will miss my friend immensely and ask all of you to take a moment to reflect on his dedication to our veterans and our organization.

Your Legislative Committee has continued to represent the Department in a variety of venues since the June Convention. During that time, we have coordinated on the Veterans Long Term Care and Veteran Cemetery Study and met with the State Administration and Veterans Affairs Interim Committee (SAVA). Sadly, I was unable to attend the National American Legion Convention in New Orleans but I hear that it was a great success.

The Veterans Long Term Care and Veteran Cemetery Study is completed. The survey outreach by our and other veteran organizations assisted in gathering 3,579 surveys, of which 238 were hard copy. While that only reached about 4% of our veterans, that is a great improvement over the 2006 survey respondent numbers. Thank you to all veterans who

completed the survey and who encouraged your veteran friends to do the same. The study was released in September. The 120-page study provides valuable insight into what services our veterans will need in the coming decade. By a law originally proposed by your American Legion, this study will now be done every 10 years following the U.S. Census. I hope to get hard copies of the study for each post but that may be a stretch. More to follow.

The SAVA Interim Committee meeting in July was attended by Bill White and me. We were pleased to have 3 veterans from Lewistown attend the meeting and express their concerns about the shortage of Veteran Service Officers (VSO's) across the state. They also stated that the predator groups charging our veterans for assistance in filing VA Claims were becoming more prevalent in Montana. Their concerns were heard by the committee and questions were asked concerning the number of additional VSO's and Administrative Assistants that would be adequate to properly serve our Montana veteran population. Bill and I were asked about this, and our reply was 3 more administrative assistants and 10 more VSO's, would be a good start.

This discussion was not lost on the committee, as the September SAVA meeting included a presentation by a group called "Veterans Guardian", invited by the committee. This group is a VA Claim Consulting entity that has dozens of Veterans as their clients across our state. While this group's fee structure is not as predatory as many of the others, there is still concern that our state Veteran Affairs Division is not adequately staffed to help our veterans at no charge

rather than 'paying someone' to do what the veteran deserves to have done for them. Bill White and I were at that September SAVA meeting, and we provided input to the committee reinforcing our support of additional VSOs for the Montana Veteran's Affairs Division.

This group is proposing a legislative bill titled the "Providing Lawful Utilization of Services for Veterans Act" (PLUS Act), which would legalize in Montana these predatory groups. We will be watching closely this proposed legislation and keeping you informed.

The next thing we will keep busy with during the upcoming legislative session is the fixes we need to make to the bill we got passed last year providing for a 50% income tax exemption for veteran retirement. First, we need to clarify the eligibility (the Department of Revenue interprets the law we passed requires a retiree to be a Montana resident before they retire), next we need to get rid of the 5-year limit on the exemption, and then we need to get rid of the 10-year sunset on the law. This may take more than one session to accomplish, however it took us 8 sessions (16 years) to get this far, so be patient. Once we have those fixes done, we will then turn our efforts to getting a 100% exemption and include all military retirees regardless of Montana Wage Source Income.

Another issue we anticipate will come back in the 2025 session is the "Defend the Guard Act", which we were actively involved in defeating in the 2023 session, not once (House Bill 527), but twice (Senate Bill 560). While the title of this bill seems positive for our National Guard, it is just the opposite. The bill, if passed into law, would preclude the Governor from allowing our National Guard to deploy to federal duty if the overseas deployment may involve combat operations. This limitation will spell the end of our National Guard as we know it. The Department of Defense would move most, if not all, of our missions, troops, and equipment

to a state that is accessible for all federal deployments. We are preparing to defend against this in 2025.

One thing I will repeat in this report, and will continue to harp on in the future, is the need for more members of the Montana Department to participate in our Congressional Outreach program. It is important that all of our members subscribe to the national program called VoterVoice. You can click on the link (votervoice.net/AmericanLegion/home) and "Sign up for Alerts". While we have improved some, Montana is still near the bottom of the list of states contacting their congressional members concerning our national issues. In a recent email from the national legislative team, Montana's response to calls for congressional communications was 2.21% of our membership (membership compared to VoterVoice actions), which put us 13th worst in the nation.

Again, I ask you to become/remain engaged in the political process. This is election time! If you are registered as an absentee voter, you should have received your ballot in the mail, as they were mailed on October 11th. If haven't voted absentee yet, please get your vote in by mail or vote in person on election day, Tuesday, November 5th! And get your veteran comrades to vote as well. Take them to the polls, help them get their absentee ballot to the elections

office, and above all, do your homework and know your candidates! Then, after the election, get to know who your state legislators and U.S. Senators and Representative are and contact them early and often. Let them know your (our) needs, interests, and preferences. Talk with them about military and veteran issues and find out where they stand on those issues. Then, let your Montana Department know of the results of your engagement. Grassroots is the lifeblood of legislative efforts, both on the state and national level.

#### **MEMBERSHIP**

# **Kim Kay McCarty Martin**

On the 11th of October, at 7pm, the Membership Committee met via zoom. The following committee members were present: Department Vice-CDR Kim Kay c McCarty Martin, committee chair, Department CDR Ken Simon; South Central Zone CDR Robert Miller; Western Zone CDR Linda Cousineau; and District 11 CDR Richard Klose (on the National Committee for 21st Century Membership Strategic Plan).

The members of the committee read and discussed the draft of the American Legion of Montana Membership and Post Activities: 21st Century Strategic Plan. It is based on National's 21st Century Plan and simplified for Montana. Montana's first years' goals are in line with Nationals goals. These goals, emphasize six areas. They are as follows: 1. Be The One, 2. Training and Education, 3. Communication, 4. Post Development and Revitalization, 5. Membership Recruiting and Retention, and 6. Community Engagement. It is recommended that the draft be adopted and utilized at the 2024 Fall Conference on 25-26 October 2024. It was also recommended that the Strategic Plan be reviewed and updated every year at the Fall Conferences to keep it viable. Richard Klose informed the committee what he learned at the Membership Workshop Conference in Indianapolis in July, that National has a challenge out to Departments that if they can reach 90% retention, they can get \$2,000 (based on size of membership).

It was discussed that Department send more members to the Membership Training as there are a lot of breakout sessions to learn from. Rob Miller was able to open the Drop Box of the training material that National offered of all the sessions (Kim Kay McCarty Martin and Erin Carpenter have not been able to access the Drop Box so Rob will present it to Erin in a flash drive). The material covered can be used for post and district training which is in line with the outline of the Strategic Plan. Another training tool is YouTube, since National has videos available there for training too. It was also discussed that Department invest in a Turewell h3 projector to be used for district training.

The committee discussed ways to increase membership and get enthusiasm in the posts. Both Zone CDR's Cousineau and Miller stated what their districts were doing and what the posts were doing to increase membership. Many posts have an event scheduled in the community especially for Veterans Day and Buddy Checks are being done. It was noted that District 5 CDR Alex Vogal has momentum going with his posts by being the first District to reach 65%, and being the recipient of the Dept. Vice-CDR's challenge of Chocolate. It was also noted that a lot of districts are close behind so we want to build on that energy to continue reaching out goals and reaching 90% retention. Zone CDR Miller said a lot of members in his area didn't get first dues notices and as the second dues notices are on the way his zone should be picking up on momentum.

It was discussed that all members of the Montana American Legion take the Basic Course that is offered online. This would give new members information on what The American Legion is and

what it does for its programs. It would reiterate to members the reason they joined in the first place and invigorate them. District 11 CDR Klose said everyone should be brave enough to ask people if they are veterans. The committee agrees, we need to be vigilant and ask as a way to increase our membership when we are at our community events or even when out and about doing our daily activities. Department CDR Simon brought up that we need to also be asking if they are eligible for The American Legion Auxiliary, or Sons of The American Legion as a way to increase our membership but also make it a family affair. Dept Vice-CDR McCarty Martin advised members that women don't identify as veterans such as wearing hats or clothing identifying themselves as veterans, so don't forget to ask if they are veterans too.

Digital and social media was discussed also. With most things going digital now, we need to be utilizing this platform more. By posts having a Facebook page, we can continuously reach out more to our members and potential members. Department and some posts already have a Facebook page that they use to either post pictures of what the posts are doing or get the word out of what is going on in their communities. Department is asking for photos that can be shared on Facebook showing what posts and districts are doing in their communities. National is putting commercials on Facebook and not on TV and Department is willing to put on a 10 to 20 sec video of Why I belong from local areas.

The Digital era is not going to go away, and if we want to stay connected with younger members this is the way to do it. Instagram and Facebook are ways to communicate but like Erin Carpenter pointed out, there is also text messaging, e-mail, and phone calls. Some posts keep in contact with their members by phone calls while the Department officers use e-mailing to communicate on a regular basis.

#### NATIONAL SECURITY

# **Fred Ferrer**

**Abstract**: We have entered a period of escalating threats to the nation—both foreign and domestic. Recently, former Secretary of Defense Robert Gates (who served under Presidents Bush and Obama) stated in the <u>Washington Post</u> that "...our Army is shrinking, our Navy is decommissioning warships faster than new ones can be built, our Air Force has stagnated in size, and only a fraction of the force is available for combat on any given day." The following report will highlight the threats I see we face today. We must be particularly attuned to threats as we approach this national election and, in the months immediately afterward. Not only might our global adversaries look to take advantage of any election turmoil, but the continuing agitation of the American public by media, politicians, and the failing economy are polarizing and radicalizing factors that will push more people to the Right and Left extremes and possibly into violent actions.


#### **Nation-State Threats**

<u>Iran</u> has become the greatest threat to, not only our longtime ally Israel in the Middle East, but also as the chief antagonist in a growing conflict between Shia-connected surrogates and those of the nation's Arab Sunni allies (I,e, Saudi Arabia, the United Arab Emirates and Qatar). Recent open-source reporting is that Iran (which launched the largest ballistic attack on another nation-state (Israel) in history, is now poised to have a nuclear capability within weeks or months. On October 7<sup>th</sup>, some in the region speculated that Iran might have conducted an underground nuclear test due to recorded earthquake activity.

The <u>People's Republic of China</u> (PRC) has recently been reported to have three aircraft carriers and hundreds of naval vessels positioned in the East China Sea, threatening the Republic of China (Taiwan) and other nation states in the region. Just this Summer in the wake of a new Taiwanese President being elected, the PRC launched large-scale military drills surrounding Taiwan in what is called *punishment* for the nation's *separatist acts*.<sup>2</sup> Taking advantage of our withdraw from Afghanistan and perceptions of our weakened state, the PRC has also greatly expanded their presence in Africa, the Middle and Near East.

**Russia** is certainly a threat due to it's continuing war with the Ukraine, the continuing public threats in the possible use of nuclear weapons. Another issue is the continued drain of U.S. armament and U.S. treasure, as the current administration has poured approximately \$175 Billion into supporting their war effort. In the beginning of October, news agencies are reporting that North Korean has already sent advisors and other troops to Eastern Europe to fight alongside Russian troops in the war with the Ukraine.

Closer to the homeland, **Venezuela's** dictator Madura fraudulently remains in control after threatening and using violence in its recent national election. While the U.S. State Department says won't do anything or admit to this national leader's crimes, he is under pending indictment for illicit narcotics trafficking in the United States.

# **Terrorist and Cartel Threats**

There are now over 20 recognized terrorist organizations operating around the globe. Not only are several of these groups consolidating and training in their newly acquired safe havens within Afghanistan, but several of these groups are now being directly integrated within the Taliban government that was (until recently) receiving direct cash payments (reportedly some \$25-40 million dollars a week) from the current U.S. administration.

The Taliban government's Ministry of the Interior is being led by a known terrorist leader who has been issuing thousands of valid Afghani passports to terrorists. With legal means to travel around the world, many reported terrorists have been able to travel to Central and South America to make their way over the U.S./Mexico southern border left open by the current administration.

The porous U.S./Mexican border has been the greatest failure of national security in recent decades and has resulted in the flow of millions of unvetted foreign nationals from, not only South and Central America, but from the Middle East, Near East and Asia. In a recently revealed report by U.S. Representative Tony Gonzales in July 2024, the U.S. Immigration and Customs Enforcement had almost 700,000 non-U.S. citizens who had criminal histories on their national docket. Over 13,000 of those foreigners are convicted murderers.

While the U.S./Mexican border has received the greatest amount of attention, U.S. Customs and Border Patrol reported encountering 19,498 migrants between border posts on the northern border between October 2023 and July 2024. Most (15,000) of these were in the Swanton Sector, which runs along the Quebec's border with New York and Vermont.<sup>3</sup> In my experience while working counternarcotics at the National Security Agency and additional work in teaching intelligence tactics for northern entry points, when blocked in one area or method, these types of pathways just shift to other easier accesses.

There have been at least six foiled terrorism attacks in Canada since Hamas unleashed the massacre attack on Israel last October 7<sup>th</sup>. It is commonly known that the Trudeau administration does not fully vet foreigners it allows into Canada as well as it should. On September 4<sup>th</sup>, a Pakistani national on a Canadian student visa (Muhammad Shahzeb Khan) was arrested in Quebec. According to authorities, his intent was to travel to New York City to slaughter as many Jews as he could on the one-year anniversary of the October 7<sup>th</sup> attack.<sup>4</sup>

# **Domestic Manmade and Natural Threats**

As witnessed in the two assassination attempts on Republican Presidential candidate Donald Trump, politically motivated violence is a real concern and being increasingly noted by both political parties as problematic. I believe the threat will continue beyond the campaign and election period, but into and through an undetermined post-election and post-inauguration period. This is not dependent on who is elected as radical Left-wing or Right-wing violent extremism is a probability, regardless of who wins the national election.

As we've seen recently in the response to hurricane Hellene, the Federal Emergency Management Agency (FEMA) seems totally overwhelmed in its capabilities to adequately and quickly respond to large scale natural disasters. Had hurricane Milton been worse, I suspect we would have seen FEMA, overwhelmed as it can not properly respond to one large area natural event, no less multiple, near simultaneous large-scale disasters.

Regardless of them being illegals, migrants or undocumented, the fact of the matter is that millions of foreigners are now in the nation due to an open border and an administration that has purposefully allowed them to enter and take residence within our borders. According to NBC News, there are currently 7.5 million illegal immigrants on the U.S.

Immigration and Customs Enforcement's non-detained docket living in the nation.<sup>5</sup> Many believe that there are many more. Most of whom are draining the budgets of states and the federal government. The Federation for American Immigration Reform published that the cost of illegal immigration in 2023 was roughly \$150 billion (or about \$1,000 per each American taxpayer).<sup>6</sup>

The cost of allowing this massive influx of foreigners is just not economic. According to a letter sent after a request by U.S. Representative Tony Gonzalez and ICE testimony to Congress in September, there are currently 425,000 total convicted immigrant criminals on the non-detained docket. Over 13,000 of these not being detained are convicted of homicide. The reason given by ICE for this status is because these immigrants are "not prioritized for detention," serving jail time for some other crime, or because ICE cannot find them.

# **Illicit Narcotics**

While the election, professional sports and natural disasters capture the mainstream news headlines, the illicit narcotics problem in the United States intensifies. Fed by an open southern border, the smuggling of narcotics from the PRC and the thousands of meth labs left operating through the nation's urban and rural facades, people are dying in great numbers and the economic impact is enormous. A National Public Radio story cited federal estimates that 108,000 people died from overdoses under this administration's watch up through 2023. The most commonly reported figure for drug overdose deaths are over 300 per day. When healthcare costs, lost productivity and criminal justice costs are tallied, it has costed the nation's tax-payers \$740 billion.<sup>7</sup>

# State of the U.S. Intelligence Community (IC)

The United States not only betrayed a decades-old ally with its rushed withdraw from Afghanistan, but it abandoned almost all of its Human Intelligence (HUMINT) sources in the region. Afghanistan is now actively being used by our closest near-peer nation-state competitor—the People's Republic of China—to strengthen its hold in the region, expand their global position and mine for rare earth metals like lithium.

In abandoning Afghanistan, the U.S. gave all terrorist groups are place to consolidate, plan and train beyond its HUMINT capability and is now reliant on loosely considered allies like Pakistan, which is itself riddled with terrorist collaborators. For the first time since before 9/11, the IC is again overly dependent on HUMINT from allied intelligence and security services for Middle and Southwestern Asian area insight. An over-dependency on other technical means cannot erase the gap created with the loss of direct HUMINT sources.

The politically motivated focus of current IC leaders on Diversity, Equality and Inclusion (DEI) is resulting in a splintered workforce that sees its time and attention more drawn to required sensitivity training than expanding its expertise and mission orientation on our nation's foreign intelligence adversaries.

# **Cybersecurity Concerns**



The American public is largely uninformed about the fragility of our national critical infrastructure and systems. Be it from nefarious actors, manmade mistakes or natural disasters, an aging infrastructure combined with a continual patching of new systems on top of legacy systems are exposing vulnerabilities and weaknesses.

As noted by national IC leaders, the PRC has infiltrated and exploited innumerable gaps in both public (government) and private sector critical infrastructure across the nation. In April 2024, FBI Director Wray publicly stated,

"The fact is, the PRC's targeting of our critical infrastructure is both broad and unrelenting" that "the immense size—and expanding nature—of the CCP's hacking program isn't just aimed at stealing American intellectual property." But "It's using that mass, those numbers, to give itself the ability to physically wreak havoc on our critical infrastructure at a time of its choosing,"

With the expansion of Artificial Intelligence, hacker capabilities have become more sophisticated while government and civilian-operated systems more vulnerable.

# **Military Issues**

Our Army is shrinking, our Navy is decommissioning warships faster than new ones can be built, our Air Force has stagnated in size, and only a fraction of the force is available for combat on any given day," former Defense Secretary Robert Gates recently wrote in <a href="The Washington Post">The Washington Post</a>.

By far, the greatest issues for today's U.S. Armed Forces is two-fold—a weakness in our status as a world leader and the retention and recruitment of a robust and qualified

volunteer force. As former SECDEF Gates said in his Washington Post piece, "As secretary of defense for both Republican and Democratic presidents, I strongly supported allocating more resources for nonmilitary instruments of power — diplomacy, strategic communications, development assistance, geoeconomic tools and more. But it is a fact of life that these instruments are effective only against the backdrop of American military power so compelling that adversaries are deterred from taking up arms against us or our allies."

In regards to REAL POWER politics, the rushed abandonment of Afghanistan during this administration has badly damaged our alliances and once trusted relationships. Evilintended adversaries do not respect weakness. In fact, some would say that the perceptions of a weakened United States is a main reason why Russia insists on taking territory; terrorist groups are continuing their evil ways and two-bit dictators continue to abuse their own people. They are confident the U.S. will do nothing...or....worse, that is cannot do anything. We will continue to see more evil lurk out from the shadows as we retreat from the world stage.

# **VETERANS ECONOMICS/Homeless Veterans Coordinator**

Veteran homelessness, as well as National homelessness prevention has been getting better every year with the help of many agencies across many levels. A big push has come from the US Interagency Council on Homelessness which as just pushed through, and adopted, a program called Ending Homelessness Before It Starts: A Federal Prevention Framework. It came about as a way for communities and programs to help keep people in homes and the revolving door of homelessness to a minimum.

The VA budget for fiscal year 2025 is set at 3.2 billion and is a significant investment in ending Veteran homelessness. With that comes questions concerning where that money is allocated and how it is spent. Here are the breakdowns of six types of services according VA.gov

Permanent housing supportive services that provide Veterans with access to affordable housing and intensive case management to help them remain stably housed

Prevention services to keep Veterans from becoming homeless in the first place

Transitional housing that provides Veterans with temporary, safe places to stay during their search for permanent housing

Treatment, such as health care, mental care, and residential rehabilitative care

Employment and job training to help Veterans obtain meaningful employment

Administrative costs to support our work and fund research

The budget broken down by percentage is, Direct services staff and operational costs for local patient care 61%, grants and contracts for direct services 34%, miscellaneous 4%, and National administrative and operating costs for local patient care 1%

For fiscal year 2024 the Montana VA made significant strides. The Montana VA's goal was to help 230 Veterans, and they ended up housing 249. This was with the help of numerous communities and housing authority partners. This falls right in line with the National VA, which had a goal of placing 41,000 Veterans and ended placing 43,116 Veterans in housing, with a retention rate of 96.3% among Veterans. There is still a long road ahead but is being taken head on.

#### VA HOSPITAL VOLUNTEER REPRESENTATIVES

The Montana American Legion Voluntary Services Committee has been actively supporting veterans across the state by organizing volunteer efforts in VA Hospitals and Community-Based Outpatient Clinics (CBOCs). Volunteers dedicate their time and skills to assist veterans with various needs, enhancing their well-being and providing much-needed support to healthcare staff.

Volunteers play a vital role in these healthcare facilities by escorting patients, delivering personal items, assisting with recreational activities, and providing companionship to veterans during their stays. The American Legion's efforts are closely aligned with the mission of the VA to honor America's veterans by providing exceptional healthcare that improves their health and overall quality of life. Montana's volunteers have consistently demonstrated commitment, serving veterans and ensuring that they receive the best possible care.

However, the Montana Department is currently seeking a new chairman for the American Legion Voluntary Services Committee. This role involves coordinating volunteer efforts, recruiting new volunteers, and acting as a liaison between the American Legion, VA facilities, and other organizations. The position is essential in ensuring that volunteer services continue to grow and meet the evolving needs of veterans throughout the state.
