CUNNINGHAM SELECTED INCOMING DEPARTMENT ADJUTANT

As indicated in the accompanying report of the Department Adjutant Ad Hoc Selection Committee, Duane Cunningham, a US Navy Persian Gulf veteran has been selected to become the next Department Adjutant starting April 1, 2021.

Duane Cunningham was born in Waterloo, Iowa July 10, 1966. Raised by an amazing single mom and farming grandparents; Duane graduated from Oelwein High School in 1984 in Oelwein, Iowa. He joined the United States Navy through the delayed entry program the beginning of his senior year of high school and upon graduation, headed to Great Lakes NTC for bootcamp.

Having somehow survived bootcamp, he was assigned as a A-6 Intruder plane captain aboard the

USS Midway (CV-41), homeported in Yokosuka, Japan. A change in rating to the Personnelman field, brought change of station orders to the World's Finest Battleship, the USS New Jersey (BB-62); where if given a choice, he would have spent the rest of his Naval career. Enjoying career stops up and down the west coast culminating in a deployment to Combined Joint Task Force Horn of Africa, Djibouti in support of Operation Enduring Freedom. Duane retired from the United States Navy in 2007 after a successful 23-year career.

Upon retirement, Duane took a job with the Montana Department of Health and Human Services as a Field

Inspector for the Weatherization and LIEAP Programs. After six years at the State; he returned to what he truly enjoyed; assisting Veterans; landing a job as the My HealtheVet Coordinator for VA Montana where he continues to assist Veterans with healthcare and VA benefits.

Duane is a five-year member of The American Legion with Lewis & Clark Post 2 in Helena. He has held the following Post positions; 2nd Vice Commander; 1st Vice Commander, Trustee and Post Adjutant. He has held numerous committee positions at the Post level. Duane is also a member of the Sons of The American Legion Squadron #2; and the La Société des Quarante Hommes et Huit Chevaux (The Society of Forty and Eight); Voiture 718.

Duane is very active in his community; he is a member of the Helena Football Official Association; the Helena Basketball Officials Association and a former Frontier Conference football official. He has also officiated high school lacrosse the last few years.

Duane has three beautiful daughters; and five grand-children living in Helena and Missoula; as well as Santa Rosa, California. They continue to bring joy to his life, along with his three dachshunds that maintain and run the household.


VICE COMMANDER SHARBONO

There is valid concern that the applicant cannot at present give the Legion full time as he is a VA employee. However, his work is related to Legion activities and he has extensive Legion experience. It is the unanimous opinion of the committee that the applicant can make it work when supported by a dedicated, capable clerk.

The applicant is Legionnaire Duane Cunningham a retired Navy Chief Petty Officer residing in Helena Mt.

The committee consisted of the following legionnaires:

The selection committee recommended the acceptance of Comrade Duane Cunningham's application pending resolution of several issues. These have been resolved since the interview meeting described above. Issues were as follows:

There were concerns about possible conflicts of interest between his present employer (VA) duties as Department Adjutant. This issue has been favorably resolved.

Apparently, there is a requirement for a formal contract between the Department Adjutant and the Department. This is being arranged by the Department JAG and is no longer an issue.

The committee kept in close contact with the Finance Committee. There is agreement on this

Therefore, it is believed that this committee has carried out its mission. The committee recommends that Comrade Duane Cunningham be installed as the replacement Department Adjutant upon the retirement of Comrade Gary White.

The Story of The Four Chaplains

With many thanks to the Chapel of the Four Chaplains for the following historical narrative.

It was known as Torpedo Junction, the U-Boat-infested icy waters of the North Atlantic during World War II. On February 3, 1943, the USAT DORCHESTER, an old coastal steamer quickly pressed into military service, was slowly making her way with other ships through those waters bound for Greenland.

Most of the men were seasick, and green with nausea. Because they were in submarine waters, the captain directed the men to keep outer gear and life jackets on at all times. Due to the extreme heat below decks, that order was ignored by many.

Moving among the troops were four Army Chaplains: George Fox (Methodist), Alexander Goode (Jewish), Clark Poling (Dutch Reformed), and John Washington (Roman Catholic). The Chaplains spoke with and listened to the men – soothing apprehensions, offering encouragement, or sharing a joke. By their concern, their cameraderie with the men – and one another - and by their very presence, they brought comfort.

An enemy submarine stalking the ship undetected fired a torpedo toward the ship's aging flank. The missile exploded in the boiler room, destroying the electric supply and releasing suffocating clouds of steam and ammonia gas. Many on board died instantly; some were trapped below deck. Others, jolted from their bunks, groped and stumbled their way to the decks of the stricken vessel. Taking on water rapidly, the ship began listing to starboard.

Because security reasons prevented the use of distress flares, escort vessels still close enough to assist, pushed on

into the darkness completely unaware the DORCHESTER was sinking.

Overcrowded lifeboats capsized; rafts drifted away before anyone could reach them. Men clung to the rails, frozen with fear, unable to let go and plunge into the icy, dark, churning water far below.

The Four Chaplains calmed frightened men, got them spare life jackets, and urged them over the side. The supply of extra jackets ran out with men still waiting. Having decided to remain with the sinking ship, the Four Chaplains either gave to or forced upon frightened servicemen their own life jackets. Much too quickly, no more lifeboats could be launched and many men were left aboard, yet there was more for the Chaplains to do.

When last seen, they were standing together on the deck leading the men in prayer. With arms linked in friendship and heads bowed, they sank beneath the waves. Two of those chaplains were Protestant, one was a Catholic, and one

Monsignor John McNamara, former Chief of Chaplains of the U.S. Navy, said at a Four Chaplains Award Service, "No casting director in Hollywood could have selected a better cast of characters than these four to portray the basic unity of the American people."

The self-sacrifice of the Four Chaplains was a heroic act. It was not the only heroic act aboard the DORCHESTER that night; however, it was the identity of these four young men, representing three great faiths of the American people that magnifies the symbolism of their sacrifice.

It is our charge to see that this brief, but significant, portion of American history is not lost, and that the lessons of cooperation and selfless service are proclaimed.



The M21-1 Adjudication Procedures Manual is an internal manual used to convey guidance for the policies, procedures, and regulations for the Veterans Benefits Administration (VBA) and its staff who develop, process, and adjudicate US Veteran's Disability Benefits Claims, Non-Service Connected Pension Claims, Death Pension Claims (Widow's Pension), and Dependency Indemnity Compensation (DIC) Claims.

Like the VBA staff, accredited Veteran Service Officers (VSOs) follow the same guidance for the policies, procedures, and regulations of the M21-1 to ensure claims submitted to the VA meet the requirements outlined in the procedural manual. This helps prevent unsubstantiated and frivolous claims from being submitted or appealed.

Throughout the year I will discuss different topics from the M21-1. My hope is to help individuals develop a basic understanding of the nature of claims. I will discuss topics like what is the representative organization form, what does an Intent to File do, what information is required to submit a fully developed

claim, what does the standard process mean, what are the different types of claims, what evidence is needed for a claim, what is a nexus letter and where can I get one, will I need a disability benefits questionnaire, where do I attend a compensation and pension examination, what is a proposal to reduce, what are routine future examinations, what does recoupment of payments mean, what do I do if I incur a debt, how do precedent setting cases help me, and many more.

My aim is to prepare you for when you sit down with your VSO, that you will have some understanding of the expectations of the VA regarding your claim, and what it will take to file it.

Pleases remember your local VSO has received extensive training to assist you with the claims process from start to finish. Please contact a VSO at the location nearest you for an appointment.

VA Received First Shipment of Moderna Vaccine

[12/24/20] The Fort Harrison VA Medical Center received its first shipment of the Moderna vaccine just before Christmas. The MTVAHCS began distributing the Moderna vaccine then.

"Montana VA Health Care System is excited to have our first shipment of Moderna COVID-19 vaccines for our health care personnel and our Miles City community living center residents and staff," said Executive Director, Dr. Judy Hayman. "For over nine months, our healthcare teams and Veterans have adapted time and time again to meet every new challenge during the pandemic. That said, we must remain vigilant—the pandemic is not over. Starting today though, we are going to celebrate that the arrival of the vaccines marks the next phase towards ending the pandemic. As our vaccine supplies increase, our ultimate goal is to offer COVID-19 vaccination to all Veterans and employees who want to be vaccinated."

Fort Harrison VA Medical Center is one of 113 VA Medical Centers across the country to receive the first limited supply of the Moderna COVID-19 vaccine. Sites were identified based on need for the vaccine according to CDC's 1A prioritization and capacity to store the vaccine at -20°C.

The Moderna COVID-19 vaccine was 94 percent effective in clinical trials in preventing COVID-19 disease. The vaccine is administered in two doses, 28 days apart. The side effects appear similar to those of other vaccines and are short-lived.

Thirty-seven medical centers began offering the Pfizer-BioNTech COVID-19 vaccine to health care personnel and Veterans Dec. 14. Fifteen additional VA facilities will receive an allocation of Pfizer-BioNTech COVID-19 vaccine the week of December 21.

Even after receiving COVID-19 vaccination, employees and Veterans should continue wearing face coverings, practicing physical distancing, and washing hands often.

As vaccines become available for more groups of Veterans, MTVAHCS care teams will reach out to eligible Veterans to schedule vaccinations. There is no need to preregister or come to a facility to sign up. Veterans can get up-to-date information on VA's VA COVID-19 vaccine webpage, which launched on December 11, 2020, and sign up to receive regular updates on the vaccine on the VA's Stay Informed page.

MTVAHCS's overall trust scores—which derive from Veteran rankings of their health care experiences—are at a historic high. MTVAHCS provides healthcare to Veterans across Montana through a series of community-based clinics, the Miles City Community Living Center (Montana VA's only nursing home), an acute care medical center, a nationally acclaimed sleep center, and robust telehealth services.

The MTVAHCS serves over 47,000 enrolled Veterans across Montana—an area roughly 147,000 square miles in size. Veterans are cared for by a staff of 1,400 at 17 sites of care across the state. One third of Montana VA employees are Veterans.

ADJUTANT continued from pg. 2 provided. When we as individuals do not participate in self-governance or the activities of our organization, we create and environment for less scrupulous individuals to take advantage of.

Involvement or participation does not necessarily mean rolling up your sleeves and getting your hands dirty. Sometimes simply being present to bear witness is all that is needed. It allows those who are actively involved to know that what we are doing is important and they are being observed. Members need to attend Post meetings whenever possible. Posts need to provide their new members with a proper orientation to The American Legion by holding official Post initiation programs at least annually. Posts need to ensure that their Post is represented at each District meeting and have authorized delegates attend the Department Convention. Districts need to find a way to ensure that their District Officers, especially their Vice Commanders, attend Department Executive Committee (DEC) meetings to back up their District Commanders. All members need to know that they are encouraged to attend DEC meetings whenever possible to observe and learn.

The lack of personal participation in the programs of The American Legion, allows far too many

members to lose sight of the goals and principals of this great organization. The forget that they are part of a much larger ideal when they

become embroiled in petty bickering and boorish behavior of "leechanaires" interested in their own self-satisfaction. Legionnaires know that when all generations of veterans work together towards a common goal, we are an awesome sight to behold.

Most Post and some District election of officers for the coming year have now been completed or soon will be. For well-organized Posts and Districts who follow the prescribed rituals in the Manual of Ceremonies the transition of officers is a relatively smooth process. For the most part, the new officers are familiar with the duties and responsibilities of the various offices they are now assuming. They have observed others who held their offices previously and know where to seek advice from. On the other hand, if your Post resembles a third world country with dictatorships, chaos, rebellion, apathy and constant turmoil, the transition probably is not going to be smooth.

A large percentage of our new officers will find themselves somewhere between those two types of Posts.

You can quite often identify them by the "deer in the headlights" look on their faces. Not sure where to turn but knowing they need to go one way or another. If you have found yourself in this position or if you haven't been elected to an office but would like to become familiar with the rituals and protocols of The American Legion but do not know where to begin; I offer this advice from personal experience: Locate a copy of the Officer's Guide & Manual of Ceremonies that you can use. Each Post receives a current copy with their Post membership supplies each year. Your Post Adjutant or Commander should be able to assist you in securing a copy. Or, if you have the ability, go to National's website www.legion.org where you will find it listed on one of the menus. As there are normally few changes made to the manual each year, an older copy will still provide you with pertinent information.

Another document that every officer and member should be aware of is the Post Constitution and By-Laws. This will provide guidance for the proper administration of your Post.

As you peruse these documents you will become aware of the potential and possibilities of a well-organized Post of The American Legion. By adopting the prescribed rituals, your Post can instill the pride of membership and sense of belonging to a wartime veterans' organization that encompasses all generations of veterans, working together "To consecrate and sanctify our comradeship by our devotion to mutual helpfulness."

As a close to this final article, I wish to again "Thank You" for the opportunity to serve you and our great organization for the past 19 years. I leave you with two thoughts, the first for our current and future leadership – remember the seven "Ps" - Proper Prior Planning Prevents Piss Poor Performance; and finally, I ask that all of you remain constantly vigilant in adhering to the Constitution and By-Laws, whether they be Post, District, Department or National.



EMERGENCY NEC MEETING

On November 17, 2020, The American Legion National Executive Committee was called to order by National Commander Oxford for the purpose of reviewing a resolution, Resolution #1, #48 IndyCar Team Sponsorship. It passed with only two no votes. The American Legion has the opportunity to leverage the highly visible IndyCar marketing platform through a sponsorship initiative with Chip Ganassi Racing and Jimmie Johnson. This sponsorship platform has the dynamic ability to impact all facets of the TAL organization both from a public awareness perspective and the ability to drive incremental revenue; new members; and new donors. It also serves as an extremely efficient media buy when compared to what it would cost to generate the type of exposure and brand relevance the sponsorship will deliver.

Chip Ganassi Racing (CGR) has been a fixture in the auto racing industry for over 30 years and is considered one of the most successful as well as innovative owners in all of motorsports. Currently, Ganassi Racing and his teams include multiple entries in the NASCAR Cup Series and three (3) cars in the NTT IndyCar Series. In 2021 and 2022, the CGR will add seven-time NASCAR Champion Jimmie Johnson to its impressive roster in the NTT IndyCar Series.

Jimmie Johnson, who retired from NASCAR this year, leaves behind a legacy that includes a recordtying seven Cup titles and 83 victories in NASCAR's premier series, tied with Cale Yarborough for sixth on the all-time list. 





Medallion

A family member of an eligible service member may apply for the honor and remember medallion by submitting Honor and Remember Medallion Application providing the supporting documentation. An eligible service member is a member of the United States armed forces who: was killed in action or classified by the United States as missing in action on or after September 8, 1939, was serving on federal military active duty orders, and was a legal resident of Montana at the time.




Per state of Montana statutes, the first Honor and Remember Medallion issued to a deceased service-member's authorized family member is at no cost, subsequent issuing of the Medallion will entail a \$20 fee. The fee covers the cost of the Medallion, its presentation box, inscription, and shipping and handling. In addition, it allows the Honor and Remember program to be financially self-sustaining in





How do I communicate with my Legislators?

Military/Veteran Organizations, below is a great 'how to' communicate with your legislators and committees. Kudos and thanks to Mr. Bob Walker, Chairman of the Montana Trails Coalition.

Recently several have requested information about working with our Legislature. Following, please find information about the primary processes put as simply as possible! The common web location for Legislature activities is <u>leg.mt.gov</u>.

To track a bill, click on Bill Search in top left corner of the webpage. Enter the type of bill (SB, HB,HJ, SJ,HR,SR) and enter the bill number. You can also find bills by clicking on Subject, Legislator, or Primary Sponsor. If you wish to track specific bills during the session, near the bottom click on Establish a Preference Account that will allow you to list bills you wish to track and receive emails announcing status of those bills.

The public is allowed to attend hearings at the capitol, but because of social distancing, you may only be allowed in the room when it is your time to testify and may not be able to stay in the room. It is recommended that you wear a mask or face covering in the Capitol Building and in hearing rooms.

You can watch or listen to committee hearings. All committee meetings will have a video-stream link and an audio-stream link so you can observe a committee meeting live or watch the archive of the hearing.

There are a few methods of providing input to legislators and providing testimony to committees.

The most efficient way of contacting members of a committee is to go on the Montana State Legislature webpage, scroll down in the middle column and click on "Send a message to a legislator/committee," enter your personal information, name the bill and committee, and type away!

Due to the CORONA virus, some may wish to testify remotely. Go to the Legislature web page, in the middle column click on request to Testify Remotely, select bill for which you wish to testify, select committee, provide your personal information to identify who you are, and upload your documents and if you wish to testify via ZOOM click yes. This must be completed by Noon the day before the hearing. Written comments you provide will be distributed to committee members.

This should be an "interesting session" so please pay attention to Legislature activities, those bills that affect your interests, and take part. This is your state Legislature, and their actions will affect us all and our way of life. Let's be certain the results are positive!

If you do not have access to a computer or do not use a computer, you may give input through the Legislative Hotline at 444-4800. This is a very easy way to communicate with your State Senators and Representatives.

Starting a veteran-owned **business**

Working for the military does many things to a person—it fosters resilience, persistence in the face of constant challenges, a mind-set geared towards flexible problem-solving, and an aptitude to adapt to virtually any situation and manage to come out on top.

The only downside to all of this? When a service member gets out, they're often so skilled and ambitious that they never want to work for another person again!

This isn't really a downside, if the Veteran is able to find a way to channel all of those skills into their own business. And that's exactly what many Vets do after they separate. Armed with an entrepreneurial spirit and a solid business plan, the only thing lacking is usually seed money. That's why we thought we'd share a few tips on where to get funding for your Veteran-Owned Small Business (VOSB)!

SMALL BUSINESS ADMINISTRATION

The Small Business Administration should be one of your first stops when researching financing options. Similar to how a VA Home Loan works, the SBA itself isn't lending you the money, they just make it easier to obtain. From \$500 to \$5.5 million, SBA guarantees a percentage of a commercial loan (typically 50% - 85%), with the caveat that the funds be used for set business purposes, naturally. This guarantee reduces risk to the lender, who might otherwise be either unwilling to offer the loan or they'd offer much higher rates.

Whether shopping for fixed assets (buildings, furnishings, equipment) or working capital, the SBA can help Vetrepreneurs find the funding they need. The process takes time, and in some cases, collateral. But lenders love the protection that the SBA provides, and some lenders will even match whatever amount the SBA is willing to

guarantee. Their Lender Match tool can connect you to lending partners.

Apart from loans, SBA is also a resource for securing grants. Many are related to helping organizations which are, in turn, helping VOSBs. So if your business is going to be helping other Vets, you may want to investigate further!

SBA OFFICE OF VETERANS BUSINESS **DEVELOPMENT**

Specific to Veterans, SBA has an entire department dedicated strictly to you—the aptlytitled Office of Veterans Business Development (OVBD). OVBD exists to facilitate a gamut of Veteran-centered programs which offer aid to all Vets, transitioning service members, and dependents and survivors, too.

One of the first perks Veterans can benefit from is the Veterans Entrepreneurship Act of 2015. This Act offers "fee relief" by waiving costly upfront loan guaranty fees on Express Loans. The policy seems to come up for annual renewal, so keep an eye out to ensure it's in effect for the fiscal year you're interested in.

OVBD also features a wide variety of entrepreneurship training, including tailored curriculums for unique business situations, and also classes (both in-person and online) covering business ownership basics. They explain other SBA resources in greater detail, to ensure Vets can maximize their benefits. These programs may not directly impact your funding, but can help you understand how to get it while strengthening your overall knowledge of the business world.

One interesting program is their Boots to Busi-

ness, which SBA provides directly at various bases during local Transition Assistance Programs. For those who didn't get to attend such a class or who want to learn more, there's a "Reboot" version which goes into greater depth and is open to all Veterans (not just those recently transitioned out).

VETERAN AFFAIRS

The VA's Veteran Entrepreneur Portal (VEP) is a fast way to find financing for your VOSB. The site is linked to the SBA's, but this user-friendly portal helps with navigation. A few of the options on the home page include:

- Start a Business
- Access Financing
- **Grow Your Business**
- Resources for Veterans
- How to do Business with Federal Agencies
- **Corporate Connections**
- Franchising Opportunities

Aside from SBA links, the site offers exclusive information on doing business with the VA itself. The VA is a major national client with a range of contracting and procurement needs for hospitals, regional offices, data centers and cemeteries. So depending on what type of business you're planning to start up, this could be a potential customer to look into.

Also check out their Office of Small & Disadvantaged Business Utilization page. Their 9th Annual National Veterans Small Business Engagement gathering is taking place in Nashville, Tennessee, on December 10th and 11th, 2019. It's advertised as one of the "largest businessnetworking events for Veteran-Owned Small Business suppliers and firms."

So, from myself to the rest of the veterans out there, I commend and thank you for all that you have done and sacrificed for our country.


Try to remember the good times and make peace with the bad times.

RESOLUTION NO. FC20-03 SUBJECT: Trade names and Insurance SUBMITTED BY: Finance Committee

WHEREAS, The American Legion's charter is codified in 36 USC 21701 et seq and under this statutory code The American Legion may: (a) establish and maintain offices to conduct tis activities, (b) sue and be sued, (c) establish state, territorial and post organizations, and (d) have exclusive right to use, manufacture and control the adopted organization emblems, and

WHEREAS, The American Legion, its state, territorial and post organizations have the exclusive to use the name "The American Legion" or "American Legion" (collectively "Trademarks"); and

WHEREAS, The names, emblems trademarks and copyrights of The American Legion compromise The American Legion's intellectual property (collectively "Tradenames"); and

WHEREAS, The American Legion's Tradenames consist of assets requiring legal and financial protection through insurance coverage; and

WHEREAS, It is recommended that The American Legion's state, territorial and post organizations have their own protective insurance coverage, now, therefore, be it

RESOLVED, By The American Legion Department of Montana in executive session at the Fall Conference assembled October 23-25, 2020 in Helena, Montana That because The American Legion owns, controls protects and defends The American Legion Trade Names, this resolution is necessary to dictate protective standards over the Tradenames; and, be it further

RESOLVED, That The American Legion of Montana, via insurance policies, has so protected itself, and the tradenames of The American Legion from liability and strongly urges all districts and posts to do the same; and, be it further

RESOLVED, That the need to protect The American Legion's Tradenames from liability it will be required forthwith that when that when any American Legion department-chartered intermediate body, post or organization use The American Legion Name or Tradenames and an insurance policy is obtained, the group utilizing this insurance policy shall specify in the insurance policy The American Legion and The American Legion of Montana harmless and named as an additional insured on any, and all, insurance policies; and, be it finally

RESOLVED, That The American Legion's National Adjutant and The American Legion of Montana's Department Adjutant, or their designee, has complete authority to independently investigate, confirm and/or report that any, and all, insurance policy(ies) purchased by an American Legion Department, intermediate department-chartered body, Post or organization shall specify that The American Legion and/or The American Legion of Montana is held harmless and named as an insured on any, and all, insurance policies.

Date: 2 November 2020

Issue: How Departments and Posts comply with Resolution 35, Fall 2020

The American Legion National Organization ("The American Legion") is the owner, protector and the organization that may grant the use of the names, emblems, trademarks and copyrights ("Tradenames") of The American Legion. As owner and protector of the Tradenames, The American Legion utilizes a number of different protective insurance coverages. As owner, protector and grantor of the Tradenames, The American Legion, like all owners of trademarks or copyrights, is allowed to place restrictions upon the use of its Tradenames, including similar insurance requirements, reviewing Tradename usage prior to use, etc.

Resolution No. 35 (passed at the 2020 Fall Meetings of The American Legion National Executive Committee) places restrictions on the use of the Tradenames -namely that, if any organization would like to use the Tradenames of The American Legion and the Tradename-using organization has a situation whereby there is a need for liability insurance protection, then the Tradename-using organization will specify that The American Legion (and, if needed, the respective Department of The American Legion) is held harmless and named as an additional insured on any and all insurance liability policies.

In other words, any organization using the Tradenames of The American Legion, and needing liability insurance coverage, is required to specify that The American Legion (and, if needed, the respective Department of The American Legion) is held harmless and named as an additional insured on any and all insurance liability policies. This Tradename protection is a standard business practice and not viewed as a control of the insurance-purchasing organization.

This requirement brings up two areas for clarification: (1) what is liability insurance? and (2) what is an additional insured?

First, liability insurance is an insurance product that provides an insured party with protection against claims resulting from injuries and damage to other people or property. Liability insurance policies protect both the insured and third parties who may be injured as a result of the policyholder's unintentional negligence and therefore the liability insurance covers legal costs and payouts for which an insured party is responsible, if the insured party is found legally liable. Liability insurance policies pay these damaged parties and not the policyholders.

The different types of liability insurance include directors and officers insurance (D&O); commercial liability; general liability insurance; dram shop liability; special events insurance; employment practices liability (EPL); and criminal acts insurance.

Second, an "additional insured" is a type of insurance status associated with liability insurance policies that provides coverage to another group that is not initially named in the liability policy. With an additional insured endorsement, the additional insured is then protected under the named insurer's liability policy.

Therefore, the Tradename-using group may obtain this additional insured endorsement coverage for The American Legion, and the respective Department of The American Legion as needed, by simply calling their insurance agent and requesting the addition of The American Legion, and the respective Department of The American Legion as needed, to their liability insurance coverage(s) as an additional insured endorsement. The majority of insurance agencies do not charge for this endorsement; therefore, if presented with an additional charge one should inquire why such additional fee.

Enforcement of this Tradename business requirement is also covered in Resolution No. 35. The American Legion's national adjutant, or designee, has been given authority to independently investigate, confirm and determine that organizations using the Tradenames are also naming The American Legion, and respected Department of The American Legion as needed, as additional insured on their respective liability insurance policies. Once a national adjutant's designee is determined and authorized, this designee's information will be made public.

Ninety-Nine Years Ago...Our legacy is challenged again: The Chet Shore-Governor Nutter Room in the MT Historical Society & Montana Heritage Center

The enabling act by which Montana was created provided that certain income from lands given to the state by the U.S. government should be used for erecting public buildings at the State Capital. This income went into the Capital Building Land Grant Fund. It was from this fund that greater part of the principle and interest for a new building was paid.

The first legislative act approving the erection of a Pioneer building was in 1923. It was hoped that persons would voluntarily donate money to erect the building; however, this hope failed to materialize. The act finally passed by the Montana Legislative Assembly was the one that really set into motion the program for the erection of the building.

Many veterans' and pioneers' groups worked towards the promulgation of such a building, among whom were Miss Mary Evans of Anaconda, President of the Montana Pioneers in 1941; Lester H. Loble of Helena, President of the Sons and Daughters of Montana Pioneers; H.R. Hampton of Lewistown, Chairman for the Veterans Memorial Commission; and W.G. Ferguson of Helena, secretary of the Commission. Mr. Hampton was the chairman for the Spanish-American War Veterans. Robert J. Merrill represented the Veterans of Foreign Wars, and John J. Byrne, the Disabled American Veterans. W. G. Ferguson, The American Legion of Montana; and J. Ward Crosby was the fifth member of the Commission.

The chief problem was how to build, and where to get the funds for Pioneer building. It was finally decided to earmark certain funds in the Capital Building Land Grant Fund for the building. However, none of this money could be used for any other purpose except building. After several meetings among the interested groups, the Montana Pioneers, Sons and Daughters of Montana Pioneers, and the various veterans' groups decided to combine forces and erect a building to be known as the Montana Veterans and Pioneers Building. Into the building was to go not only the monies earmarked from the Capital building Land Grant Building fund, but also the amount the veterans had on deposit in the State Treasury from the boxing tax, the latter to be used for items which could not be purchased from the Land Grant Fund. To decide whether these funds could be co-mingled, a test case was taken to the Montana Supreme court. The decision the high Courts that the funds could be co-mingled was a major contribution towards achievement of desired objective.

To most effectively present the building problem, Pioneers, accompanied by Veterans, went from desk to desk in the Legislature in 1941 and finally House Bill 112 was drafted and ultimately passed into law by the Legislative Assembly. This enacted law combined the activities of the above-mentioned groups for a building to be known as "Montana Veterans and Pioneers Building." The Act also provided for bonds to be issued in the amounts of \$250,000, and that there be available for the payment of bonds all money in the Veterans Memorial funds from the proceeds of boxing and sparring matches, and the remainder of the money for the prepayment of the principal of the bonds of the Capital Building Landing grant Funds. The validity of this legislation was determined because of the same test case in which the Supreme Court rendered a decision approving co-mingling of funds.

As provided for in the Act, plans were immediately made to issue bonds in the sum of \$250,000. However, when World War II began it was decided it be temporarily stopped. Building costs began to increase and efforts were subsequently made to also increase the amount of the proposed bond issues. Finally, in 1945, the Legislature passed and act increasing the amount earmarked for the Building from \$250,000 to \$400,000.

In 1946, the Sons and Daughters of Montana Pioneers acquired as tax sale deed on 63 lots immediately east of the Capital Building. The deeds were gratuitously to State of Montana by this group as their contribution towards the erection of the new building and pro-

The architect approved by the Board of Examiners in 1948, and likewise by the Veterans and Pioneers was A.V. McIver of Great Falls, Montana.

vision of a site.

Governor John K. Bonner, in his message to the 31st Legislative Assembly, in 1949, endorsed the Montana Veterans and Pioneers Building, and recommended that there be set aside for the building and that an additional \$350,000, bringing the total to \$750,000. This message was adopted.

Competitive bids were called upon by the Board of Examiners, and the contract for the erection of the Building was awarded to the Carson Construction Company, in 1950.

The building was normally dedicated on August 21, 1951. Members of Helena Veterans' organizations paraded the colors to the speakers stand to open the ceremonies and municipal band played the National Anthem. Lester H. Loble, principal speaker, called the building the dream of a quarter century come true. In his dedication address, Governor John W. Bonner cited the Veterans and Pioneer Building as symbolic of Montana's appreciation and great pride in its Pioneers and Veterans. Other speakers, too, had nothing but the highest praise for those who worked with unswerving zeal towards the attainment of such an expedient objective; and cited the building as a shrine

to preserve the record of the sacrifices and courage of our pioneers and defenders of freedom.

There are four floors in the Veterans and Pioneers Memorial Building. The ground floor consisted of the Museum workshops, collections storage and archives. The main floor is the formal museum, the Charles M. Russell Room, and art gallery and offices, the Library and Stack area are on the second floor; and the top floor was originally given over to veterans' offices, meeting rooms and a trophy hall. The first three rooms are occupied by the Montana Historical Society.

Chapter 22-3-301 of Montana Code Annotated identifies a Veterans and Pioneers Memorial Building be in Helena, Montana. Title 22-Chapter 3-Paragraph 302 indicates the use of the Building stated, "the veteran and pioneers memorial building shall constitute a perpetual memorial to the war veterans and pioneers of Montana and the said building shall be devoted to the use of the united Spanish Veterans of Montana, the Veterans of Foreign Wars, the American Legion of Montana, the Disabled American Veterans of Montana, the World War I veterans of Montana, the Montana Historical Society, the Society of Montana Pioneers, and the Sons and Daughters of Montana Pioneers and for the housing of books, records, documents and other property of such veterans organizations [Noted the World War I veterans transferred their area to the World War II veterans and subsequently this area is transferred to the Post World War II generation]; and there shall be provided in such building appropriate office quarters for the State headquarters and officer and employees of the such veterans and organizations and for the librarian and other employees of the MHS.

How to Submit Articles & Photos? Deadline: APR. 1, 2021

(always include Post & City in Email Subject Line)

<u>Text</u> – No formatting such as, multiple space and multiple tabs to line up text

- Set one tab (publisher will format to line up paragraphs and columns) PLEASE do not use multiple spaces as All formatting has to be removed before placing into paper. Modern formatting is single-space between sentences (after the period)
- Provide Post City as well as Post/Unit number
- Post, Unit & Department are capitalized
- It is better if articles/stories are written in third person unless you're talking about quotes from actual people, of course. There really should never be any "we did this" or "I/we think that" written in the body of a good news story – imagine someone else is telling your story at all times, as though the journalist is telling the reader about someone or something else.
- Acronyms. Always keep new members informed and familiar with programs. For example: Veterans Affairs Voluntary Service (VAVS). The first time an acronym is used in an article use full title followed with acronym in parenthesis, then following first use, the acronym.
- Please keep articles to approximately 600 words per article.
- If you are using information in your article from another source be sure to use quotation marks and give credit to the author and/or publication you are taking the information from otherwise this is plagiarizing which has serious legal repercussions
- DO NOT submit articles in PDF format.
- If you want credit for an article or photo (s), please make sure you let us know... \textit{who submitted.} Photos – send as e-mail attachments – PLEASE!!
- JPG format, as an attachment
- Default setting on a digital camera is usually set very high. Set to 1200 x 1725 pixels which is ideal for printing 4x6 with desired output resolution of 300 dpi.
- Cell phone photos are many times too poor quality so take your time taking the photo
 - If the photo is blurry, too far away, tops of heads cut off, shows just the backs of heads we cannot make it look better for you. Send photos in medium resolution.
- Captions should be noted in the e-mail:

Photo# caption which includes Post/ Unit #, Name, City along with the names of those in

- the photo and what Post/Unit they are members of. Don't spend time setting up photos and captions in a Word document - PLEASE
- Each time a photo is copied/pasted to edit it loses integrity. Send as an e-mail attachment.
- Do Not embed (insert) photos in an e-mail (use attach)

See above (if embedded in the body of an e-mail the photo has to be copied/pasted into Word, then copied/pasted into photo editor). Send as an e-mail <u>attachment</u>.

News articles

Sending a <u>hyperlink</u> to an article via e-mail is best (rather than hard-copy to scan) Helps ensure article can be found (sometimes older articles are archived and cannot be found) and also to give proper credit to the author and newspaper to avoid plagiarizing. **Corrections** to previously-sent articles

Send an e-mail with the corrections only

Most times the article has already been formatted and grammar-edited, and inserting the correction saves a lot of time in redoing. Edit and spellcheck your work before you send it the first time.

On January 12, 2021, L&C 4-H Shooting Sports held an introduction to Air Rifle class for all first-year shooters enrolled in the 4-H Air Rifle Project. In February these first-year participants will get an opportunity to practice their new skills along with more experienced shooters during Tuesday / Thursday shooting practice sessions.

Due to current Covid restrictions, shooting sessions must be limited to groups of only 25 during each practice. Additionally, new shooters must be age 9 or older as of October 1, 2020. To sign up for air pistol youth must have been in air rifle for one year. To sign up for small bore, youth must be 12 years old and been in air rifle for at least one year and have approval of the Air Rifle Superintendent. To shoot small bore pistol, youth must have been in air rifle and air pistol. This

means two years of air rifle and air pistol, as well as approval of the Superintendent.

The American Legion Support for the Lewis & Clark 4-H Shooting Sports program typically includes providing all coordination and funding needed to run the American
