National Commander brings 'Buddy Check' Message to Montana

In a scene that resembled an old western, American Legion National Commander Bill Oxford was surrounded by horseback-riding American Legion Family members as he was led into the historic ranching town of Geraldine, Mont., March 21.

While it's not uncommon for American Legion Riders to escort the national commander, the riders of the Geraldine Painter Brothers Post 102 Mounted Color Guard prefer organic horsepower over Harleys. "I have had a lot of escorts on my travels but this was unique," Oxford told Legionnaires attending the Department of Montana Three Rivers District 8 meeting. "Being led by horseback is an experience unique to Montana. Every post that I visit in The American Legion has its special characteristics. But they all care about serving veterans and their communities."

The message that Oxford delivered in Geraldine was the same as what he said a day earlier to District 9 in Roy, Mont. "We have to get a handle on

Harlowton High School Senior Wins The Montana American Legion Oratorical Contest

HELENA, MT-MARCH 9, 2021: The National American Legion High School Oratorical Competition sponsored by The American Legion of Montana and its 120 Posts located throughout the State concluded in Helena on Saturday March 6. Margaret Martin of Two Dot who attends Harlowton High School prevailed over five other contestants.

Martin won the local competition

sponsored by Harlowton Post 15 and then went on to take the District contest also in Harlowton a week later for the chance to compete in the state finals. Eva Bruce of Kalispell took second place followed by Angelica Sutton of Wolf Point for third followed by Ella Henslee of Big Sky in fourth.

The American Legion established the annual oratorical contest in 1939 as part of its multi-faceted Americanism Program. The focus of the competition has always been the United States Constitution.

The subject of the prepared oration portion of the contest must be about some phase of The Constitution of the United States, emphasizing the duties and obligations of a citizen to the United States government. The prepared oration must be an original effort of each contestant and should be 8-10minutes in length.

The Montana state winners 1st through 4th places is eligible for monetary scholarships from The American Legion of Montana. Also, as part of The American Legion program fee waiver scholarships are available from the various units of the Montana University system as well as Carroll College. Information on these scholarships is available from high school guidance counselors or the American Legion.

In addition, Martin will receive an additional \$5,000 from The American Legion National Headquarters to be applied to the college of her choice.

The American Legion State Oratorical Chairman is Jeff Holmes, Harlowton, Montana

veterans' suicide," Oxford said. "We need to continue Buddy Checks to help veterans cope with the isolation caused by the pandemic and issues that are related to their military service. The suicide rate is much lower for veterans who get in the VA system and receive help. We need to do everything we can to encourage vulnerable veterans to get the help that they need."

In a news interview broadcast by local affiliates in markets throughout state, Oxford reiterated the need for veterans to seek help in a state where one in five suicides are committed

"When we think about veterans, we're a stubborn group (with an) unwillingness to reach out and ask for help. We just want every veteran to know, hey, we're still here, we want to help, we can help but you got to let us."

The national commander's visit marked the end of an era for longtime Department of Montana Adjutant Gary White, who will be retiring after 19 years on April 1. White, a retired Army commander sergeant major, intentionally sought to include smaller communities as part of Oxford's itinerary.

> "Roy has a population of less than 100, yet Post 96 has 26 members. Think about that!" White said. "The post is led by young veterans and they have achieved 113 percent of their goal. Geraldine has a population of less than 200, and its post has 108 members as of today. There are a lot of

For those of you who choose to support The American Legion through your payment of dues, I want to thank you and to encourage you to contact your nearest Post, attend a monthly membership meeting, and dip your toes in the water; the reward you receive from the experience will far outweigh the time spent doing it.

The month of March brought a visit to Montana from the National Commander James W. (Bill) Oxford. The Commander got the royal treatment from Posts 96 in Roy and Post 102 in Geraldine, small town Montana hospitality and some amazing

The Commander discussed his priorities regarding the importance of membership, and what being a member of The American Legion really means. The retention of our members and using tools such as buddy checks, to show genuine concern and friendship, not a call seeking dues. He discussed why the Consolidated Post Reports (CPR) are such an important tool that can be used at the highest levels of Congress to show exactly the impact The American Legion has within the community and in developing the next generation of leaders. Montana's American Legion family stepped up and provided a great experience for the National Commander. Bravo Zulu!

From time to time, I will use my chunk of space to provide any information I pick up from the Montana VA and I bring you good news; all Veterans, their spouses and/or caregivers are now eligible for a Covid-19 vaccination through the VHA.

Who is eligible to receive a COVID-19 vaccine at a MTVAHCS vaccine clinic?

If you are a Veteran, you are eligible to receive a vaccine through MTVAHCS, even if you are not enrolled with VHA healthcare. On March 23, 2021, President Biden signed into law, H.R. 1276 (also known as the SAVE LIVES Act). The law expands VA's legal authority to provide COVID-19 vaccines to Veterans, regardless of their VA health care enrollment status, as well as Veteran spouses, and caregivers. For COVID-19 vaccine eligibility, we define a caregiver as a family member or friend who provides care to a Veteran.

FAQs Q: I am a Veteran. How can I confirm I am eligible to receive a vaccine through MTVAHCS?

A: Veterans, regardless of discharge type, are eligible to receive their vaccine through the MTVAHCS. The only verification needed is the either a NGB Form 22 or their last DD214/215. Veterans, their spouses, or Veteran caregivers can schedule a vaccination at any of the upcoming Montana VA COVID-19 vaccination clinics.

Q: What COVID-19 vaccine will I receive?

A: The Montana VA is currently receiving allotments of the two-dose Moderna vaccine and the single-dose Janssen vaccine. You will receive one of these vaccines based on your vaccination site allotment. If you receive the Moderna vaccine, you will be scheduled for your second dose approximately four weeks after.

Q: Is there a number I can call to find out about upcoming clinics?

A: Please call 877-468-8387 (select Option 2, and then Option 2 again).



The training conference will begin promptly Saturday, June 26th at 1 pm at the Delta Red Lion Hotel in Helena and last until 4 pm. You do not have to register for Department Convention to attend this informative and spirituallyinclusive training opportunity.

You are not required to be currently appointed or ordained as a chaplain to attend; however, you must register by May 31st so there will be enough materials and seating for everyone.

Due to Lewis and Clark County Health Department COVID planning requirements, NO registrations can be accepted after June 5th. We will also be unable to accommodate walk-ins unless you take someone's place if they cannot attend.

The Department of Veterans Affairs (VA) policy is that all claimants (veterans, spouses, children, parents) have the right to representation before the department in claims affecting the payment of benefits of relief. This is often referred to as the "Power of Attorney."

VA Form 21-22 – Appointment of Veterans Service Organization as Claimant's Representative, is completed by your local Veterans Service Officer who is accredited by a State Organization like the Montana Veterans Affairs Division or a national organization like The American Legion, to serve as the representative for the claimant (veteran, spouse, child, parent) in the VA Benefits Claims Process. The term "Power of Attorney" means the VSO

Service Officer Kate Hahn is granted VA representation for the claimant. It means your VSO is trained and accredited, and has completed legal formalities authorizing them to perform functions on the claimant's behalf in business before the VA. This "POA" does not grant a VSO any functions outside the scope of the VA. This "POA" is valid until revoked. Once revoked, your (former) VSO cannot access your VA claims files and will not be able to assist you with future claims, unless you file a follow-up VA Form 21-22.

Once POA is granted your VSO can access your claims file. The VSO can see your disability rating, what conditions you are service connected for, what you receive in disability or non-service connected pension compensation, your medical records, previous claims you have submitted, the evidence submitted to support those claims, dependents, military service, etc.

The POA authorizes your VSO to change your address, phone number, email address, but it does not authorize a VSO to change your direct deposit. The POA may be revoked by filing a new VA Form 21-22 with another agency. The POA expires after 5 years but may need updating after 2 years.

For more information about the VA Form 21-22, please contact your local VSO. They have received extensive training to assist you with the claims process from start to finish. Please contact a VSO at the location nearest you for an appointment.

Schedulers will be available Monday through Friday from 8 a.m. to 4 p.m.

Walk-in appointments are available on a first come, first served basis however, MTVAHCS strongly encourages all partici-



pants to schedule an appointment to ensure eligibility and vaccine availability. Walk-ins who are not already enrolled with the Montana VA are asked to please, bring a copy of their DD 214 or DD 215 for enrollment.

Copayment Debt: Refunds, Forgiveness:

The American Recovery Plan also waives copayments through September 2021.

VA copayments for medical care will be waived, refunded, or forgiven under the American Recovery Plan. If you're a Veteran who receives care through VA, here's what this means for you:

- If you received a statement with copayment charges from April 6, 2020, or later, we'll remove these charges. You won't need to pay them.
- If you already paid any co-pay charges from April 6, 2020, or later, we'll send you a refund.
- If you have unpaid co-pay charges from before April 6, 2020, you don't have to make payments until September 30, 2021. We won't add fees or interest or take other collection action on these charges during this time. But you can still make payments if you'd like. Find out how to pay your VA co-pay bill.

You currently do not need to do anything to get a refund. We ask for your patience as we work to adjust statements and send refunds.

Co-pay charges will be waived.

The American Recovery Plan also waived VA copayments for all medical care received between April 6, 2020, and September 30, 2021, and all prescription medications ordered between April 6, 2020, and September 30, 2021. Again, if you made a payment; you will automatically be reimbursed.

BENEFICIARY TRAVEL

-New Online Portal to Submit Travel Claims

Beginning in May 2021, Veterans, caregivers, and beneficiaries who are eligible for reimbursement of mileage and other travel expenses to and from approved health care appointments can now enter claims in the new Beneficiary Travel Self-Service System (BTSSS). BTSSS simplifies the current claim submission process for beneficiaries and ensures timely processing and payment of travel reimbursements.

- Submit claims online 24/7, 365 days a year
- Track the status of submitted claims
- Reduce processing time for submitted claims
- Use self-help tools to make claim submissions fast and easy
- Visit AccessVA, select submit a travel claim, and logon using a DS Log on account.

Veteran Portal Instructions for Veterans Questions & Answers

Who is eligible for Beneficiary Travel Reimbursement?

Veterans and caregivers may be eligible for travel pay. A list of eligibility requirements can be found on the VA Travel Pay Reimbursement webpage.

How do I submit a travel reimbursement claim?

VA is phasing in a new web-based portal to submit and process beneficiary travel claims beginning July 2020 and continuing through November 2020. The new portal, the Beneficiary Travel Self-Service System (BTSSS), is VA's preferred method to receive travel reimbursement claims. Once implemented, BTSSS will phase out claims submitted through the facility kiosks. However, in-person claims, and hard-copy submissions will still be available. BTSSS is available through the AccessVA website.

Are there advantages to using the Beneficiary **Travel Self-Service System?**

The BTSSS automates the claims process to ensure timely processing and payment of travel reimbursement claims. With BTSSS, turnaround time to evaluate and settle a claim is less than 5 days. BTSSS allows Veterans and caregivers to submit claims 24/7, 365 days a year from a computer or mobile device. It also allows users to electronically track the status of a claim request.

Can I get help to file my first claim?

There are several sources of help for filing a claim. BTSSS was built with several self-help tools to guide users through the process of logging on and submitting/tracking claims. Additionally, a user's guide for BTSSS is available on the VA Travel Pay Reimbursement webpage. Lastly, Veterans who do not have access to a computer can get help from a travel clerk at the facility.

How do I access BTSSS?

BTSSS is available through the AccessVA webpage. To submit a claim, Visit AccessVA, select submit a travel claim, and logon using a DS Log on Level 2 account. A DS Logon is an ID issued by DoD that will allows Veterans and caregivers to access many VA and DoD sites with one user username and password. Need a DS Log on?

Need Help?

There are several sources of help to file a claim. Eligible Veterans and caregivers may get help from a travel clerk at the facility or refer to the BTSSS user's guide at https://www.va.gov/health-care/ get-reimbursed-for-travel-pay.

Montana Commander Jeff Nelson. "When I pass one of those markers, I'll look again in my rearview mirror and maybe pay more attention to the speedometer. Not every fatality has a marker, since some accidents cause multiple deaths."

Baseball is another program in which Montana's young people rely heavily on The American Legion. Due to long and harsh winters, high schools do not offer opportunities for students to play America's national pastime. Though the playing seasons are shorter than what can be found in many southern departments, Montana conducts a robust American Legion Baseball program, which includes eight Canadian-based teams. American Legion Baseball is viewed as "the only game in town," according to the department.

Additionally, the department hopes to instill patriotism among young people by encouraging the legislature to pass a bill which would require the presence of an American flag in every Montana

"It's important for young people to see that flag and remember the sacrifices that have been made on their behalf," White said. "Americanism is one of the pillars of The American Legion, so this is an issue that we think is very important."

The Montana American Legion is also trying to convince lawmakers to exempt military pensions from state income tax. "We are one of the few states that still taxes military retirement," White explained. "We believe that exempting these pensions would create a major incentive for veterans to move to Montana. It would send a message that Montana is veteran-friendly and still increase revenue for the state in other areas."

While Oxford's travel tempo has not reached its pre-pandemic level, the Montana tour came on the heels of department visits to Iowa, Nebraska and Virginia. "Every department that I visit has shown great hospitality," Oxford said. "We are not done with coronavirus yet, and I encourage all Legionnaires to get the vaccines, practice social distancing when they can and be safe. Even while doing all of these things, American Legion Family members still find ways to serve their communities and strengthen America."

Helena veteran who trained Army sled dogs receives congressional record commendation

David Armstrong sat through a small ceremony Tuesday [March 16, 2021], in which he was presented with a congressional record commendation, when he gave a reaction that those who know him said was typical.

"It's awfully pige but I don't

"It's awfully nice, but I don't think it's necessary," the 100-yearold Armstrong said while sitting in a wheelchair in a nice lawn adjoining his home adjacent to the Archie Bray Foundation. "Anybody could do it."

It's probably where he and the handful of people at the ceremony would disagree.

Armstrong [member of Lewis & Clark Post 2, Helena, MT is the last known survivor of Camp Rimini, where sled and pack dogs were trained during World War II. He was honored by Sen. Steve Daines, R-Mont., who read a tribute to him into the congressional record honoring his military service and for reaching the 100-year milestone.

Daines called Armstrong during the ceremony to thank him.

"I wish I could be there to shake your hand personally," he said.

In the Dec. 19 tribute, Daines called Armstrong "a distinguished World War II veteran who played a pivotal role in the U.S. Army's plan to liberate Norway from Nazi occupation; as well as number search and rescue missions across northern Europe."

Armstrong came to Helena in early 1943 to begin training sled and pack dogs at Camp Rimini, one of two sites that produced dogs for the Army's K-9 Corps during WWII. Armstrong was stationed in Newfoundland, where he and his dogs aided in recovering downed personnel and sensitive equipment from aircraft wreckage sites in Greenland and Baffin Island.

Daines noted that after the war, Armstrong and his wife, Alice, returned to Montana and started the annual "Race to the Sky," which preserves the legacy of the soldiers and dogs who served at Camp Rimini. The race is described as one of the most challenging and beautiful sled dog races in the world. The event was initially called Montana's Governor's Cup Sled Dog Race in 1986, and the first 500-mile race was in February of that year. Race to the Sky has been an Iditarod qualifier. According to the race's website, there is now a 300-mile distance race, the 100-mile junior continuous race and the 100-mile adult continuous race.

Daines mentioned that Armstrong also preserved the legacy with his 2008 memoir "Camp Rimini and Beyond."

"On behalf of a grateful nation, I want to thank Dave for his service to our state and to our country," Daines said.

Denny Lenoir, director of veteran and military affairs for Daines, presented Armstrong with the congressional record tribute and a "Challenge Coin," which the senator gives to Montanans to honor them for special achievements. One side of the coin has Daines' name with the Capitol building in the background and the other side has the seal of the U.S. Senate.

Friend Ken Rosenbaum called the honor "tremendous" and said he worked with Armstrong on the Race to the Sky.

"I've seen him stand on the sled," he said.

Armstrong's son, Mark, spoke on behalf of the family, saying they were "grateful" for the honor and praised his father.

"He was one of the best dads I could have ever asked for," he said. "What he did after the war was pretty amazing."

"He's had a very interesting and rewarding life," Mark Armstrong said.

The Josephine and Yellowstone National Cemetery

Bold and majestic western history surrounds Yellowstone National Cemetery, Laurel, Montana. The Lewis and Clark Expedition, intrepid westward pioneers, and brave warriors Native and soldier, all passed near the present cemetery. The scenic Yellowstone River, longest free-flowing river in America and the Missouri River's major tributary, flows south of the cemetery.

In the mid-to-late nineteenth century smaller shallow-draft paddle wheel river boats navigated the fast-flowing upper Missouri and Yellowstone Rivers. These unadorned rugged work horses with resolute boat captains carried cargo, animals, supplies, and soldiers. At about 180 feet long and thirty feet wide, two sister ships, the Far West and

the Josephine, rendered valued service and remain honored in history. The Far West carried wounded soldiers from the Battle of the Little Bighorn ("Custer's Last Stand") in June 1876. The Josephine forced many rapids, and holds the record of its day for the farthest upriver run on the Yellowstone River: tying up near present Billings, Montana, in June 1875.1

In 2008 visionary citizens and veterans created Yellowstone County Veterans Cemetery: forerunner of present Yellowstone National Cemetery. Plans included a small warming hut having public toilets using green technology with vent stacks, and a separate built-in meeting room. When workers finished the hut, a retired military veteran serving on the cemetery committee smiled and said, "It looks like the Josephine The moniker stuck. The small building, now partly used as the cemetery caretaker's office, continues valued service. To this day locals honor the building at Yellowstone National Cemetery by fondly yet reverently calling it the "Josephine."

Public health mandates in response to the oronavirus included stay-at-home orders and business closures. Those mandates financially impacted American Legion Posts nationwide as member and community outreach efforts were limited, resulting in a loss of revenue.

To provide some relief during these challenging times, financial grants are now available for eligible American Legion Posts.

Resolution No. 36, Mission Blue Post Assistance Program, will provide \$1,000 grants to Posts that are in good standing with their respective department. These funds must be used exclusively to pay current or past due rent, mortgage, utilities, and insurance.

The American Legion National Executive Committee approved Resolution No. 36 Oct. 14, 2020 during its annual Fall Meetings. Funds for the approved grants will be provided through The American Legion National Emergency Fund (NEF).

Eligibility for a Mission Blue Post Assistance Program grant requires Posts to have:

1. A Consolidated Post Report on file.

- 2. Filed an IRS 990 within the prescribed due
- as prescribed by the department. 4. Actively participated in one or more Amer-

3. Filed all other required forms and reports


- ican Legion programs in the last 18 months.
- 5. A financial need.
- 6. A certificate of insurance naming The American Legion doing business as American Legion National Headquarters as an additional insured.
- 7. Documentation indicating that the Post is properly incorporated.

The Mission Blue Post Assistance Program grant application is available online. Search for Mission Blue Post Assistance

Program.

American Legion Posts applying for a grant will be required to first submit the completed application to Department for approval before it can be sent to National Headquarters. This application procedure is the same as the NEF.

American Legion Posts have until Dec. 31, 2021, to apply for a Mission Blue Post Assistance Program grant.



Corvallis American Legion Post 91 hosts Reconnect ski event at Lost Trail

Corvallis American Legion Post 91 held their Reconnect for activeduty troops as a ski trip to Lost Trail Powder Mountain, Feb 18-20.

They brought soldiers and their spouses to an allexpense-paid vacation to see Montana and enjoy refreshing time off. Troops from the U.S. Air Force Special Tactics [2021]. Squadron, Army

Rangers, Army Special Operations Aviation and 7th Infantry division from Joint Base Lewis McChord, Washington took part, and one came from Okinawa, Japan.

They toured businesses, had five-star lodging, enjoyed breakfast at Camp Sula, rentals, ski lessons and skiing at Lost Trail and nightly dinners.

Retired military and organizer Chris Kurinec said local sponsorship made it possible.

"Lost Trail is doing us a huge favor by freeing up instructors and equipment so that some of these folks who have never been to Montana and never skied are given that opportunity," he said. "We've got American Legion members skiing with them, as part of the reconnect where the guys who have already gotten out or retired are seeing the younger guys that are taking their place in the unit."

"It's so guys like me who retired a decade ago can see the guys following in our footsteps and making bigger strides in their military careers," Kurinec said. "Hopefully, we've left it better than we got it and they're taking it that much further. It is interesting for guys that have been out 20-30 years to see the folks who are deploying to Afghanistan or Syria or wherever else they have to deploy and hear their stories."

Michael Willeby is serving in Okinawa, Japan, where his job is "an 88 Mike."

"Basically, I'm a driver," Willeby said. "We set the teams up and push them out for deployments. We get them to all the crazy places that they go and ensure they are in accordance with government rules."

Willeby said he enjoyed connecting with the retired military.

"They have been extremely accommodating," he said. "I came with every possible problem and they were so easy going. I've never had anyone jump through so many hoops to ensure I could get here."

"I could live here," he said. "I could leave the beach; I've had my fun with it. It is so hot and humid. I love Montana. I've always wanted to be here, it is amazing. I've never been in a state that reminds me of Japan where you can just leave your skis that are obviously expensive, and no one will touch them. It's really community-like. I've had a blast."

Air Force Staff Sergeant parachute rigger Tim Doyle was born and raised in Springfield, Massachusetts, and is serving in Washington at Ft. Lewis.

This was his first time skiing and he enjoyed it.

"I've played hockey most of my life and the movement kind of came natural," Doyle said. "The first day I was falling more than I would have liked but the second and third day I only fell a couple of times. Now I have the hang of it and have been hitting some of the more advanced slopes."

"Someone is taking the time to show their appreciation and I like how these guys are putting it together," Doyle said. "I've met all the veterans. I previously worked with John [Nolan], he was at one of our jump courses. This is a really great program that a lot more people should experience."

Mario Elias and his wife came from Ft. Lewis, Washington, where he serves as a 19-Delta Calvary Scout.

"It's the easy way of saying we paint the picture of the battlefield for our commander, and he sends it up higher," Elias said. "We're pretty much the first eyes on everything."

He and his wife are from Oregon but neither had skied before this trip and enjoyed the lessons and runs. "The experience has been amazing from the people we flew here with to the people who are providing the trip for us," Elias said. "It has been awe-some to meet our older brothers in arms, the service members who have been in longer than I have been alive."

Cole (last name withheld), a mortar man in the Army at Ft. Lewis, is originally from Illinois.

He said snow was something that he sledded on two to three weeks each year growing up. He enjoyed the Reconnect.

"It's a great location, we got to see a lot of wildlife including bighorn sheep, elk and mule deer," he said. "The retired military are super friendly; they help us out with the skiing. We've been having good conversations."

Cody (last name withheld) serves as an infantryman in the Army in Ft. Lewis but grew up in Oklahoma. He hadn't had much experience with snow until he moved to Washington where he did some snowboarding. His favorite sport is skydiving.

"These guys are awesome," he said. "They came before us and have a lot of knowledge and experience. It's nice to hear stories. Every night we have supper with them and have a free-for-all telling stories."

He was one of the few single men who came to the Reconnect.

"At first it was for married couples, then for single E6's and below," he said. "I'm the only single squad leader so they sent me. I am snowboarding by myself this trip, it's great."

Montanans John Nolan and Vern Cortes are two of the retired military (from Army special operations) invested in the Reconnect program.

Cortes said the four days was wonderful camaraderie with guys he could relate to.

"I've got 16 combat deployments, five years overseas fighting," he said. "When you come back you're just getting ready to go back again, you don't have time to relax. To bring those guys away from the machine that just demands constantly and let them take the wheels off and have a good time is me giving back to my community."

"The only way to do 16 deployments is taking care of the soldier and his family and there is a lot of outlets for married guys like wife retreats," Nolan said. "My wife and I have been married 26 years and probably been together for 12 years. Some of these guys said this is the first vacation they've ever had. They are living like rock stars which is what we want."

Nolan said the Reconnect has been beneficial to him also.

"It is therapy for me," he said. "You're in the service, then you're out of the service and no longer part of the team. That meat grinder is still going and it's like watching the train leave in the distance. But this way I get back with the Joes and share some stories. It's great to teach them to ski and give them confidence in something new."

Reconnect happens nationwide but this "Is a very aggressive American Legion," Nolan said. "For some American Legions, it is just meeting in a bar on Wednesday night. For us, it's Reconnects, scholarship opportunities and career day experiences for high school students. We're showing them options that are out there."

Kurinec thanked Lost Trail, Bitterroot River Inn, Big Sky Brewing, Camp Sula, Quality Used Cars, Joint Special Operations Fund, Corvallis American Legion Post 91, and anonymous donors.

"We're trying to run three [Reconnects] a year, skiing, fishing, and hiking just providing that resource to the command where they can send their troops to get some good rest and relaxation in Montana," Kurinec said.

There's a new Secretary in town

On Tuesday [April 6, 2021], selected Laurel veterans including Former State Commander of The American Legion (and Laurel City Counselor) Richard Klose and historian Ed Saunders were invited, along with Bill Kennedy, who heads Friends of Yellowstone National Cemetery, to meet with the recently confirmed Secretary of Veterans Affairs Denis McDonough and U.S. Senator Jon Tester.

The group met at Yellowstone National Cemetery just north of Laurel as part of Secretary McDonough's visit to Montana. He's traveling with Sen. Tester to various veterans' service sites to gain a better understanding of the needs of Montana veterans, but especially veterans living in rural areas. Senator Tester is the Chair of the Committee on Veterans Affairs.

Previously, a long-time aide and Chief of Staff to former President Barack Obama, Secretary McDonough helped the Obama "administration's work on behalf of military families and veterans and earned the trust of President Biden as a first-class manager with the knowledge and vision to deliver results," according to an official announcement on his February confirmation. As a member of the National Security Council, McDonough visited troops regularly in Iraq and Afghanistan.

Although not a veteran himself, the Secretary will guide the nation's second largest federal agency through the transition. While some groups have decried the choice of McDonough because they had hoped the job would go to a woman or a post 911 vet, he has been welcomed by many, including VoteVets.

"What the VA needs, more than anything, is an experienced manager with a deep depth of knowledge about how the agency works, how it interacts with other agencies, and how to quickly build the agency back even better," said Will Fischer, with VoteVets, in a statement.

On Monday, the Secretary and Senator met with veterans at MSU Billings for a town-hall style meeting. They will repeat that at several other Montana locations this week.

FEMA to Help Pay Funeral Costs for COVID-19-related Deaths

In early April, FEMA will begin providing financial assistance for funeral expenses incurred after Jan. 20, 2020 for deaths related to coronavirus (COVID-19) to help ease some of the financial stress and burden caused by the pandemic. The policy was finalized today, and FEMA is now moving rapidly to implement this funeral assistance program nationwide.

To be eligible for COVID-19 funeral assistance, the policy states:

- The applicant must be a U.S. citizen, non-citizen national, or qualified alien who incurred funeral expenses after Jan. 20, 2020 for a death attributed to COVID-19.
- If multiple individuals contributed toward funeral expenses, they should apply under a single application as applicant and co-applicant. FEMA will also consider documentation from other individuals not listed as the applicant and co-applicant who may have incurred funeral expenses as part of the registration for the deceased individual.
- An applicant may apply for multiple deceased individuals.
- The COVID-19-related death must have occurred in the United States, including the U.S. territories and the District of Columbia.
- This assistance is limited to a maximum financial amount of \$9,000 per funeral and a maximum of \$35,500 per application.
- Funeral assistance is intended to assist with expenses for funeral services and interment or cremation.

In the coming weeks, a dedicated 800 number will be established to help individuals who apply. In the meantime, potential applicants are encouraged to start gathering the following documentation:



- An official death certificate that attributes the death to COVID-19 and shows that the death occurred in the U.S. The death certificate must indicate the death "may have been caused by" or "was likely the result of" COVID-19 or COVID-19 like symptoms. Similar phrases that indicate a high likelihood of COVID-19 are considered sufficient attribution.
- Funeral expense documents (receipts, funeral home contract, etc.) that include the applicant's name, the deceased individual's name, the amount of funeral expenses, and the dates the funeral expenses were incurred.
- Proof of funds received from other sources specifically for use toward funeral costs. Funeral assistance may not duplicate benefits received from burial or funeral insurance, financial assistance received from voluntary agencies, federal/ state/local/tribal/territorial government programs or agencies, or other sources.

Helena observance honors Vietnam veterans who were not welcomed home from war

A "Welcome Home Vietnam Veterans Day" ceremony was held Monday at The American Legion Post No. 2 in Helena.

The 10th anniversary of the Welcome Home Vietnam Veterans Day ceremony took place Monday in Helena, although a cold March morning wind forced the cancellation of the planned walk.

The event was highlighted by the drumming of the Native American Magpie Singers, and keynote speaker Vietnam combat veteran John Quintrell of Helena.

The ceremony, which was moved from Kindrick Legion Field to the American Legion (Lewis & Clark) Post No. 2 due to the weather, kicked off with the music of the Magpie Singers.

"This was originally a funeral song," explained drummer/singer Cary Youpee, who was born and raised on the Fort Peck Indian Reservation, "but it became an honor song in the 1970s for the Vietnam War."

Next, Charmaine Lindgren of the Oro Fino Daughters of the American Revolution sang the National Anthem, followed by opening prayers by

Chaplain Chaya Semple and then Magpie member Daniel Pocha.

"This prayer was written by Francis Whitebird, and was offered at the dedication of the Vietnam War Memorial," Pocha said.

Master of Ceremonies, Vietnam veteran Col. Ray Read, noted that the U.S. Senate passed a congressional measure in 2011 recognizing March 29 as Welcome Home Vietnam Veterans Day nationally. The 2011 Montana Legislature established the holiday in the state with the passage of House Bill 255.

After the reading of Gov. Greg Gianforte's proclamation marking the holiday and the introduction of several guests – including Brig.

Gen. James Wilkins – it was keynote speaker John Quintrell's turn.

Staff Sgt. Quintrell served with Company C of the Second Platoon, Second Battalion, 27th Regiment of the Army's 25th Infantry Division – known as the Wolfhounds – in the Republic of Vietnam in 1968-69.

Forty-nine members of Quintrell's outfit were killed in action, with 70% earning the Purple Heart.

"But when I came back, I was not welcomed home," related Quintrell. He described having vegetables and verbal taunts thrown at him at the Great Falls airport, and then a long-respected father of a friend told him that he "should be ashamed for killing women and babies."

"I made a promise that I would never tell anyone that I was Vietnam vet, which I kept for 34 years," he said.

In 2003, he started searching for the guys he served with. The next year his Vietnam platoon members held their first reunion. He later began speaking publicly about his war experiences, after meeting former combat nurse Diane Carlson Evans of Helena,

founder of the Vietnam Women's Memorial.

"We found out that Diane and I got into Vietnam at the same time, although we didn't know each other back then," Quintrell said. "She influenced me to start speaking about the war. And I just want to say thanks to all the war-time nurses and medical services, a lot of us might not be here now if it weren't for them."

Quintrell has now organized eight Wolfhound reunions – the last consisted of 104 veterans – and has authored a book about his service, "My 365 Days."

His talk also included the plight of tens of thousands of veterans who are experiencing homelessness or died by suicide, and he challenged those in attendance to "reach out to a Vietnam veteran today, let them know they're not forgotten," and urge them to seek the benefits they deserve.


"And to this day, I would still take a stand to defend this country and our freedom," he concluded.

After Chaplain Semple's closing benediction, the Magpie Singers played a moving rendition of the song "Soldier Boy."

"Thirty-six thousand Montanans served during the Vietnam era, and we believe at least 5% (about 1,800) of those were Native American Indians," Pocha said.



John A. Brieden III of Brenham, Texas, was elected National Commander of the 2.8-million-member American Legion on August 28, 2003, in St. Louis, Mo, during the 85th National Convention of the nation's largest veterans organization.



Brieden is a United States Army veteran where he served as an Infantry Officer from 1972 – 1977. During his time in the Army, he attended Ranger School, Airborne School, Jungle Warfare School, and Arctic Warfare School. He was selected to serve in the 1st Battalion, 75th Infantry when the U.S. Army was first going back to the concept of Ranger Battalions.

He joined The American legion in 1979 and for 25 years he has served in key leadership positions at the post, district, department (state) and national level. Among his national level appointments are; Chairman of the National legislative Commission; Chairman of the National Economic Commission; Chairman of the National Foreign Relations Commission and Chairman of the National Americanism Council.

After leaving the Army, Brieden went into the insurance business where he earned the professional designation Life Underwriter Training Council Fellow. He was named the Central Texas Association of Insurance and Financial Advisors Man of the Year in 1993.

Commander Brieden has served as a member of Congressman Kevin Brady's Military Academy Selection Committee: was appointed by the Texas Governor in 1998 to the Texas Veterans Commission and served a term as Secretary of that Commission in 2000 and 2001.

Married to the former Terry Weaver Dial, the Brieden's have four children and five grandchildren.





In May 2017, American Legion Post 46 in Boulder obtained approval to restore an amusement park train that was in operation at the state owned/operated Boulder River School and Hospital from 1961 to the early 1980s. The train was part of a recreation program



instituted by Dr. Arthur Westwell, school superintendent. The train is a replica of the 1864 steam engine that transported President Lincoln to Gettysburg and was designed/built by local craftsmen who worked at the school Maintenance Shop. It operated on a half-mile track and pulled two passenger cars. In the 1980s, after the recreation program was halted, the train was obtained by the local community from the State of Montana. After 30 years in storage, Post 46 members undertook a community service project to become caretakers of the train and restore it. The restoration focused on converting the train from operating on a rail system to roadways and for resuming passenger rides. Restoration has included painting, repair of the 1940s Jeep Willys engine, installation of steering utilizing an Oliver tractor single pendant front wheel with steering box, wiring, casting front wheels to maintain the original overall shape, and installation of rear road wheels. A small trailer that replicates a coal tender was built to enable an additional passenger during events. Future restoration will include a passenger car that will seat eight people. Once restoration is complete, the intent is for the Post 46 to operate the train at events throughout the county. The necessary funding for the restoration has come from generous donations and grants from local businesses, charities, and individual donors.
